## **LEGISLATIVE BILL 298**

Approved by the Governor June 1, 2023

Introduced by Linehan, 39; DeBoer, 10; Conrad, 46.

A BILL FOR AN ACT relating to education; to amend section 79-101, Revised Statutes Cumulative Supplement, 2022; to require each school district to collect and provide information regarding learning disabilities and the school board of each school district to adopt a written dress code and grooming policy as prescribed; to require the State Department of Education to provide a report and to develop a model dress code and grooming policy for schools as prescribed; to adopt the Interstate Teacher Mobility Compact; to provide a duty for the State Board of Education; to define and redefine terms; to harmonize provisions; and to repeal the original section. Be it enacted by the people of the State of Nebraska,

- Section 1. (1) On or before July 1 of each year, each school district shall provide to the State Department of Education, on forms prescribed by the department, information relating to dyslexia. Such information shall include, but not be limited to, the number of students in each public school in such <u>district:</u>
- (a) Tested for a specific learning disability in the area of reading, including tests that identify characteristics of dyslexia and the results of
- (b) Identified as having a reading issue, including dyslexia, pursuant to assessment administered under the Nebraska Reading Improvement Act; and
- (c) Identified as described in subdivision (b) of this subsection that have shown growth on the measure used to identify the reading issue.
- (2) The State Department of Education shall annually compile information received pursuant to subsection (1) of this section and provide a report on such information electronically to the Legislature on or before September 1 of each year.
- (3) The State Board of Education may adopt and promulgate rules and regulations to carry out this section.
- Sec. 2. (1) On or before July 1, 2025, the school board of each school district shall adopt a written dress code and grooming policy to be implemented at the start of the 2025-26 school year that is consistent with the model policy developed by the State Department of Education in accordance with section 3 of this act and may include any other procedures and provisions the school board deems appropriate.
- (2) Enforcement of violations of the written dress code and grooming <u>policy shall:</u>
- (a) Be treated as minor on the continuum of school rule violations and shall not constitute student conduct subject to long-term suspension, expulsion, or mandatory reassignment as provided in section 79-267;
- (b) Not require the student to miss substantial classroom
- instruction time, or school activities; and
  (c) Not, under any circumstance, allow an administrator, teacher, member of the staff, or contractor to permanently or temporarily alter or cut a student's hair.
- (3) No student shall be disproportionately affected by a dress code or grooming policy enforcement because of the student's gender, race, color, religion, disability, or national origin.
  - Sec. 3. (1) For purposes of this section:
- (a) Department means the State Department of Education;
  (b) National origin includes characteristics associated with actual perceived place of birth, ancestry, or ethnicity including, but not limited to, skin color, natural and protective hairstyles, headdress, tribal regalia, and <u>attire;</u>
- Natural and protective hairstyles include, but are not limited to, braids, locks, twists, tight coils or curls, cornrows, bantu knots, afros, weaves, wigs, or head wraps;
- (d) Race includes characteristics associated with actual or perceived race, ancestry, or ethnicity including, but not limited to, skin color, natural and protective hairstyles, tribal regalia, and attire;
- (e) Religious attire and characteristics associated with religion includes, but is not limited to, natural and protective hairstyles, tribal burkas, hijabs, head wraps, or other headdress, adornments, <u>regalia,</u> clothing garments used to express or observe one's religious beliefs; and (f) Tribal regalia includes natural and protective hairstyles
- traditional garments, jewelry, or other adornments or similar objects of cultural significance worn by members of an indigenous tribe of the United States or another country. Tribal regalia does not include any dangerous weapon or, expect in compliance with an appropriate federal permit, any object that is otherwise prohibited by federal law.
  (2) On or before December 1,
- (2) On or before December 1, 2024, the department shall develop and distribute a model dress code and grooming policy for schools that facilitates

and encourages an inclusive and positive learning environment while complying with any applicable health or safety law, rule, regulation, ordinance, resolution. Such model policy shall not:

- (a) Target, disproportionately impact, discriminate, or be applied in a discriminatory manner against any students on the basis of race, religion, sex,
- disability, or national origin;
  (b) Prohibit a student from wearing attire, including religious attire, and protective hairstyles, adornments or other characteristics natural associated with race, national origin, or religion; or
  - (c) Require a student's hair be permanently or temporarily altered.
- (3) Such model policy shall include a statement that specifies that enforcement of a violation of such policy shall be done in a manner that is consistent with a school's overall discipline plan and in a consistent manner.
- (4) The department may develop as part of the dress code and grooming policy a health and safety standard that allows for the regulation of characteristics associated with race, national origin, or religion in the dress code and grooming policy under certain circumstances. Such standard shall:
- (a) Demonstrate that without the implementation of such standard, it reasonably certain that the health and safety of the student another individual will be impaired;
   (b) Require adoption of the standard for nondiscriminatory reasons;
- (c) Require that the standard be applied equally;
  (d) Require that the school engage in a good faith effort to reasonably accommodate the student and notify the student's parent or guardian, in a language that such parent or guardian understands, of such an attempt to accommodate the student's appearance or any attire, tribal regalia, hairstyles, adornment, or other characteristic associated with race, national origin, or <u>religion;</u>
- (e) Provide a process to obtain consent from a student's parent or guardian prior to altering a student's appearance or removing or altering a student's attire, tribal regalia, hairstyle, adornment, or other characteristic
- associated with race, national origin, or religion; and

  (f) Provide a process to ensure records are kept on each effort to reasonably accommodate a student's appearance, attire, hairstyle, adornment, or other characteristics associated with race, national origin, or religion occurring at school, on school grounds, or at a school-sponsored event and ensure that such records allow for analysis of related data and delineate:
- (i) The reason for such student's referral relating to the dress code and grooming policy; and
  - (ii) Federally identified demographic characteristics of such student.

Sec. 4. INTERSTATE TEACHER MOBILITY COMPACT

ARTICLE I- PURPOSE

The purpose of this Compact is to facilitate the mobility of Teachers across the Member States, with the goal of supporting Teachers through a new pathway to licensure. Through this Compact, the Member States seek to establish a collective regulatory framework that expedites and enhances the ability of

Teachers to move across State lines.

This Compact is intended to achieve the following objectives and should be interpreted accordingly. The Member States hereby ratify the same intentions by subscribing hereto.

- A. Create a streamlined pathway to licensure mobility for Teachers;
  B. Support the relocation of Eligible Military Spouses;
- Facilitate and enhance the exchange of licensure, investigative,
- disciplinary information between the Member States;

  D. Enhance the power of State and district level education officials to hire qualified, competent Teachers by removing barriers to the employment of out-of-state Teachers;
- E. Support the retention of Teachers in the profession by removing barriers to relicensure in a new State; and
- the regulation of the teaching <u>F. Maintain State sovereignty in</u> profession.

- ARTICLE II- DEFINITIONS
  As used in this Compact, and except as otherwise provided, the following <u>definitions</u> shall govern the terms herein:
- A. "Active Military Member" means any person with full-time duty status in the uniformed service of the United States, including members of the National Guard and Reserve.
- B. "Adverse Action" means any limitation or restriction imposed by a State's Licensing Authority, such as revocation, suspension, reprimand, probation, or limitation on the licensee's ability to work as a Teacher.
- C. "Bylaws" means those bylaws established by the Commission.

  D. "Career and Technical Education License" means a current, valid authorization issued by a Member State's Licensing Authority allowing an individual to serve as a Teacher in P-12 public educational settings in a specific career and technical education area.
- specific career and technical education area.

  E. "Charter Member States" means a Member State that has enacted legislation to adopt this Compact where such legislation predates the initial meeting of the Commission after the effective date of the Compact.

  F. "Commission" means the interstate administrative body which
- membership consists of delegates of all States that have enacted this Compact, and which is known as the Interstate Teacher Mobility Compact Commission.

  G. "Commissioner" means the delegate of a Member State.

  - "Eligible License" means <u>license</u> to engage in the teaching a

profession which requires at least a bachelor's degree and the completion of a

- <u>state approved program for Teacher licensure.</u>

  <u>I. "Eligible Military Spouse" means the spouse of any individual</u> full-time duty status in the active uniformed service of the United States, including members of the National Guard and Reserve on active duty, moving as a result of a military mission or military career progression requirements or on their terminal move as a result of separation or retirement (to include
- surviving spouses of deceased military members).

  J. "Executive Committee" means a group of Commissioners elected or appointed to act on behalf of, and within the powers granted to them by, the
- Commission as provided for herein.

  K. "Licensing Authority" means an official, agency, board, or other entity of a State that is responsible for the licensing and regulation of Teachers authorized to teach in P-12 public educational settings.
- L. "Member State" means any State that has adopted including all agencies and officials of such a State.
- M. "Receiving State" means any State where a Teacher has applied for <u>licensure under this Compact.</u>
- N. "Rule" means any regulation promulgated by the Commission under this Compact, which shall have the force of law in each Member State.
- "State" means a state, territory, or possession of the United States and the District of Columbia.
- "State Practice Laws" means a Member State's laws, rules, regulations that govern the teaching profession, define the scope of such
- profession, and create the methods and grounds for imposing discipline.
  Q. "State Specific Requirements" means a requirement for licensure covered in coursework or examination that includes content of unique interest to the State.
- R. "Teacher" means an individual who currently holds an authorization from a Member State that forms the basis for employment in the P-12 public schools of the State to provide instruction in a specific subject area, grade level, or student population.
  S. "Unencumbered License"
- S. "Unencumbered License" means a current, valid authorization issued by Member State's Licensing Authority allowing an individual to serve as a Teacher in P-12 public educational settings. An Unencumbered License is not a restricted, probationary, provisional, substitute, or temporary credential.

  ARTICLE III- LICENSURE UNDER THE COMPACT

- A. Licensure under this Compact pertains only to the initial grant of a <u>license</u> by the <u>Receiving State</u>. <u>Nothing herein applies to any subsequent or ongoing compliance requirements that a Receiving State might require for the complex control of the contr</u>
- Each Member State shall, in accordance with the Commission, define, compile, and update as necessary, a list of Eligible Licenses and Career and Technical Education Licenses that the Member State is willing to consider for equivalency under this Compact and provide the list to the Commission. The list shall include those licenses that a Receiving State is willing to grant to Teachers from other Member States, pending a determination of equivalency by the Receiving State's Licensing Authority.
- C. Upon the receipt of an application for licensure by a Teacher holding an Unencumbered Eligible License, the Receiving State shall determine which of the Receiving State's Eligible Licenses the Teacher is qualified to hold and shall grant such a license or licenses to the applicant. Such a determination shall be made in the sole discretion of the Receiving State's Licensing <u>Authority and may include a determination that the applicant is not eligible</u> for any of the Receiving State's Eligible Licenses. For all Teachers who hold an Unencumbered License, the Receiving State shall grant one or more Unencumbered License(s) that, in the Receiving State's sole discretion, are equivalent to the license(s) held by the Teacher in any other Member State.
- D. For Active Military Members and Eligible Military Spouses who hold <u>license that is not Unencumbered, the Receiving State shall grant an equivalent</u> license or licenses that, in the Receiving State's sole discretion, is equivalent to the license or licenses held by the Teacher in any other Member
- State, except where the Receiving State does not have an equivalent license.

  E. For a Teacher holding an Unencumbered Career and Technical Education License, the Receiving State shall grant an Unencumbered License equivalent to the Career and Technical Education License held by the applying Teacher and issued by another Member State, as determined by the Receiving State in its sole discretion, except where a Career and Technical Education Teacher does not hold a bachelor's degree and the Receiving State requires a bachelor's degree for licenses to teach Career and Technical Education. A Receiving State may require Career and Technical Education Teachers to meet State industry recognized requirements, if required by law in the Receiving State.

  ARTICLE IV- LICENSURE NOT UNDER THE COMPACT

- A. Except as provided in Article III above, nothing in this Compact shall be construed to limit or inhibit the power of a Member State to regulate licensure or endorsements overseen by the Member State's Licensing Authority.
- B. When a Teacher is required to renew a license received pursuant to this Compact, the State granting such a license may require the Teacher to complete State Specific Requirements as a condition of licensure renewal or advancement in that State.
- C. For the purposes of determining compensation, a Receiving State may require additional information from Teachers receiving a license under the provisions of this Compact.

Nothing in this Compact shall be construed to limit the power Member State to control and maintain ownership of its information pertaining to Teachers, or limit the application of a Member State's laws or regulations governing the ownership, use, or dissemination of information pertaining to Teachers.

- E. Nothing in this Compact shall be construed to invalidate or alter any existing agreement or other cooperative arrangement which a Member State may already be a party to, or limit the ability of a Member State to participate in
- any future agreement or other cooperative arrangement to:

  1. Award teaching licenses or other benefits based on addiprofessional credentials, including, but not limited to, National <u>Certification;</u>
- 2. Participate in the exchange of names of Teachers whose licenses have been subject to an Adverse Action by a Member State; or
- 3. Participate in any agreement or cooperative arrangement with a non-M<u>ember State.</u>

ARTICLE V- TEACHER QUALIFICATIONS AND REQUIREMENTS FOR LICENSURE UNDER THE

- A. Except as provided for Active Military Members or Eligible Military Spouses in Article III.D above, a Teacher may only be eligible to receive a <u>license under this Compact where that Teacher holds an Unencumbered License in</u> a Member State.
- B. A Teacher eligible to receive a license under this Compact shall, unless otherwise provided for herein:
- 1. Upon their application to receive a license under this Compact, undergo criminal background check in the Receiving State in accordance with the laws and regulations of the Receiving State; and
- 2. Provide the Receiving State with information in addition to the information required for licensure for the purposes of determining compensation, <u>if applicable.</u>

ARTICLE VI- DISCIPLINE / ADVERSE ACTIONS

- A. Nothing in this Compact shall be deemed or construed to limit the authority of a Member State to investigate or impose disciplinary measures on Teachers according to the State Practice Laws thereof.
- B. Member States shall be authorized to receive, and shall provide, files information regarding the investigation and discipline, if any, of Teachers other Member States upon request. Any Member State receiving such information or files shall protect and maintain the security and confidentiality thereof, in at least the same manner that it maintains its own investigatory or disciplinary files and information. Prior to disclosing any disciplinary or investigatory information received from another Member State, the disclosing state shall communicate its intention and purpose for such disclosure to the Member State which originally provided that information.

ARTICLE VII-ESTABLISHMENT OF THE INTERSTATE TEACHER MOBILITY COMPACT <u>COMMISSION</u>

- A. The interstate compact Member States hereby create and establish a public agency known as the Interstate Teacher Mobility Compact <u>Commission:</u>
- 1. The Commission is a joint interstate governmental agency comprised of
- States that have enacted the Interstate Teacher Mobility Compact.

  2. Nothing in this interstate compact shall be construed to be a waiver of sovereign immunity.
  - B. Membership, Voting, and Meetings
- Each Member State shall have and be limited to one (1) delegate to the Commission, who shall be given the title of Commissioner.

  2. The Commissioner shall be the primary administrative officer of the
- <u>State Licensing Authority or their designee.</u>
- 3. Any Commissioner may be removed or suspended from office as provided by law of the state from which the Commissioner is appointed.

  4. The Member State shall fill any vacancy occurring in the Commission
- within ninety (90) days.
- 5. Each Commissioner shall be entitled to one (1) vote about the promulgation of Rules and creation of Bylaws and shall otherwise have an opportunity to participate in the business and affairs of the Commission. A Commissioner shall vote in person or by such other means as provided in the Bylaws. The Bylaws may provide for Commissioners' participation in meetings by telephone or other means of communication.
- 6. The Commission shall meet at least once during each calendar year.

  Additional meetings shall be held as set forth in the Bylaws.

  7. The Commission shall establish by Rule a term of office for
- Commissioners.
  - C. The Commission shall have the following powers and duties:
  - 1. Establish a Code of Ethics for the Commission.
  - Establish the fiscal year of the Commission.
  - 3. Establish Bylaws for the Commission.
- 4. Maintain its financial records in accordance with the Bylaws of the Commission.
- <u>5. Meet</u> and take such actions as are consistent with the provisions of <u>interstate compact, the Bylaws, and Rules of the Commission.</u>
- 6. Promulgate uniform Rules to implement and administer this interstate compact. The Rules shall have the force and effect of law and shall be binding in all Member States. In the event the Commission exercises its Rulemaking authority in a manner that is beyond the scope of the purposes of the compact,

or the powers granted hereunder, then such an action by the Commission shall be invalid and have no force and effect of law.

- Bring and prosecute legal proceedings or actions in the name of Commission, provided that the standing of any Member State Licensing Authority to sue or be sued under applicable law shall not be affected.
  - 8. Purchase and maintain insurance and bonds.
- 9. Borrow, accept, or contract for services of personnel, including, but not limited to, employees of a Member State, or an associated non-governmental organization that is open to membership by all states.

  10. Hire employees, elect, or appoint officers, fix compensation, define duties, grant such individuals appropriate outbasits to accompany the compensation.
- duties, grant such individuals appropriate authority to carry out the purposes of the compact, and establish the Commission's personnel policies and programs relating to conflicts of interest, qualifications of personnel, <u>related personnel matters.</u>
- accept appropriate gifts or donations 11. Lease, purchase, otherwise own, hold, improve, or use, any property, real, personal or mixed, provided that at all times the Commission shall avoid any appearance of impropriety.
- 12. Sell, convey, mortgage, pledge, lease, exchange, abandon, or otherwise <u>dispose of any property real, personal, or mixed.</u>
  - 13. Establish a budget and make expenditures.
- 14. Borrow money.

  15. Appoint committees, including standing committees composed of members such other interested persons as may be designated in this interstate compact, Rules, or Bylaws.
- 16. Provide and receive information from, and cooperate enforcement agencies.
  - <u>17. Establish and elect an Executive Committee.</u>
- 18. Establish and develop a charter for an Executive Information Governance Committee to advise on facilitating exchange of information, use of information, data privacy, and technical support needs, and provide reports as <u>an Executive Information</u>
- 19. Perform such other functions as may be necessary or appropriate to achieve the purposes of this interstate compact consistent with the State <u>regulation of Teacher licensure.</u>
- 20. Determine whether a State's adopted language is materially different from the model compact language such that the State would not qualify for participation in the Compact.
- D. The Executive Committee of the Interstate Teacher Mobility Compact Commission
- 1. The Executive Committee shall have the power to act on behalf of the Commission according to the terms of this interstate compact.
  - 2. The Executive Committee shall be composed of eight voting members:
- a. The Commission chair, vice chair, and treasurer; andb. Five members who are elected by the Commission from the current membership:
- i. Four voting members representing geographic regions in accordance with Commission Rules; and
  - ii. One at large voting member in accordance with Commission Rules.
- The Commission may add or remove members of the Executive Committee as provided in Commission Rules.
- 4. The Executive Committee shall meet at least once annually.

  5. The Executive Committee shall have the following duties responsibilities:
- a. Recommend to the entire Commission changes to the Rules or Bylaws, changes to the compact legislation, fees paid by interstate compact Member States such as annual dues, and any compact fee charged by the Member States on behalf of the Commission.
- <u>b. Ensure Commission</u> administration services are appropriately provided, contractual or otherwise.
  - c. Prepare and recommend the budget.
  - d. Maintain financial records on behalf of the Commission.
- of Member States and provide <u>Monitor</u> compliance reports to Commission.
  - f. Perform other duties as provided in Rules or Bylaws.
  - 6. Meetings of the Commission
- a. All meetings shall be open to the public, and public notice of meetings shall be given in accordance with Commission Bylaws.
- b. The Commission or the Executive Committee or other committees of the Commission may convene in a closed, non-public meeting if the Commission or Executive Committee or other committees of the Commission must discuss:
- Non-compliance of a Member State with its obligations <u>compact.</u>
- <u>ii.</u> The employment, compensation, discipline, or other matters, practices procedures related to specific employees or other matters related to the Commission's internal personnel practices and procedures.
  - iii. Current, threatened, or reasonably anticipated litigation.
- iv. Negotiation of contracts for the purchase, lease, or sale of goods, <u>services, or real estate.</u>
- v. Accusing any person of a crime or formally censuring any person.
  vi. Disclosure of trade secrets or commercial or financial information that is privileged or confidential.
  - vii. Disclosure of information of a personal nature where disclosure would

constitute a clearly unwarranted invasion of personal privacy.

<u>viii. Disclosure of investigative records compiled for law enforcement purposes.</u>

- ix. Disclosure of information related to any investigative reports prepared by or on behalf of or for use of the Commission or other committee charged with responsibility of investigation or determination of compliance issues pursuant to the compact.
- x. Matters specifically exempted from disclosure by federal or Member State statute.
  - xi. Others matters as set forth by Commission Bylaws and Rules.
- c. If a meeting, or portion of a meeting, is closed pursuant to this provision, the Commission's legal counsel or designee shall certify that the meeting may be closed and shall reference each relevant exempting provision.
- d. The Commission shall keep minutes of Commission meetings and shall provide a full and accurate summary of actions taken, and the reasons therefore, including a description of the views expressed. All documents considered in connection with an action shall be identified in such minutes. All minutes and documents of a closed meeting shall remain under seal, subject to release by a majority vote of the Commission or order of a court of competent jurisdiction.
  - 7. Financing of the Commission
- a. The Commission shall pay, or provide for the payment of, the reasonable expenses of its establishment, organization, and ongoing activities.
- b. The Commission may accept all appropriate donations and grants of money, equipment, supplies, materials, and services, and receive, utilize, and dispose of the same, provided that at all times the Commission shall avoid any appearance of impropriety or conflict of interest.
- c. The Commission may levy on and collect an annual assessment from each Member State or impose fees on other parties to cover the cost of the operations and activities of the Commission, in accordance with the Commission Rules.
- d. The Commission shall not incur obligations of any kind prior to securing the funds adequate to meet the same; nor shall the Commission pledge the credit of any of the Member States, except by and with the authority of the Member State.
- e. The Commission shall keep accurate accounts of all receipts and disbursements. The receipts and disbursements of the Commission shall be subject to accounting procedures established under Commission Bylaws. All receipts and disbursements of funds of the Commission shall be reviewed annually in accordance with Commission Bylaws, and a report of the review shall be included in and become part of the annual report of the Commission.
  - 8. Qualified Immunity, Defense, and Indemnification
- a. The members, officers, executive director, employees, and representatives of the Commission shall be immune from suit and liability, either personally or in their official capacity, for any claim for damage to or loss of property or personal injury or other civil liability caused by or arising out of any actual or alleged act, error, or omission that occurred, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing in this paragraph shall be construed to protect any such person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful or wanton misconduct of that person.
- b. The Commission shall defend any member, officer, executive director, employee, or representative of the Commission in any civil action seeking to impose liability arising out of any actual or alleged act, error, or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining his or her own counsel; and provided further, that the actual or alleged act, error, or omission did not result from that person's intentional or willful or wanton misconduct.
- result from that person's intentional or willful or wanton misconduct.

  c. The Commission shall indemnify and hold harmless any member, officer, executive director, employee, or representative of the Commission for the amount of any settlement or judgment obtained against that person arising out of any actual or alleged act, error, or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that such person had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities, provided that the actual or alleged act, error, or omission did not result from the intentional or willful or wanton misconduct of that person.

## ARTICLE VIII- RULEMAKING

- A. The Commission shall exercise its Rulemaking powers pursuant to the criteria set forth in this interstate compact and the Rules adopted thereunder. Rules and amendments shall become binding as of the date specified in each Rule or amendment.
- B. The Commission shall promulgate reasonable Rules to achieve the intent and purpose of this interstate compact. In the event the Commission exercises its Rulemaking authority in a manner that is beyond purpose and intent of this interstate compact, or the powers granted hereunder, then such an action by the Commission shall be invalid and have no force and effect of law in the Member States.

C. If a majority of the legislatures of the Member States rejects a Rule, by enactment of a statute or resolution in the same manner used to adopt the compact within four (4) years of the date of adoption of the Rule, then such Rule shall have no further force and effect in any Member State.

- D. Rules or amendments to the Rules shall be adopted or <u>ratified at a</u> regular or special meeting of the Commission in accordance with Commission Rules and Bylaws.
- E. Upon determination that an emergency exists, the Commission may consider and adopt an emergency Rule with forty-eight (48) hours' notice, with opportunity to comment, provided that the usual Rulemaking procedures shall be retroactively applied to the Rule as soon as reasonably possible, in no event later than ninety (90) days after the effective date of the Rule. For the purposes of this provision, an emergency Rule is one that must be adopted immediately in order to:
  1. Meet an imminent threat to public health, safety, or welfare;

  - 2. Prevent a loss of Commission or Member State funds;
- 3. Meet a deadline for the promulgation of an administrative Rule that is established by federal law or Rule; or

4. Protect public health and safety.
ARTICLE IX- FACILITATING INFORMATION EXCHANGE

- A. The Commission shall provide for facilitating the exchange information to administer and implement the provisions of this compact accordance with the Rules of the Commission, consistent with generally accepted data protection principles.
- B. Nothing in this compact shall be deemed or construed to alter, limit, inhibit the power of a Member State to control and maintain ownership of its <u>licensee information or alter, limit, or inhibit the laws or regulations governing licensee information in the Member State.</u>

ARTICLE X- OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT

<u>A. Oversight</u>

- The executive and judicial branches of State government in each Member State shall enforce this Compact and take all actions necessary and appropriate to effectuate the Compact's purposes and intent. The provisions of this Compact shall have standing as statutory law.
- 2. Venue is proper and judicial proceedings by or against the Commission shall be brought solely and exclusively in a court of competent jurisdiction where the principal office of the Commission is located. The Commission may waive venue and jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution proceedings. Nothing herein shall affect or limit the selection or propriety of venue in any action against a licensee for professional malpractice, misconduct, or any such similar matter.
- 3. All courts and all administrative agencies shall take judicial notice of the Compact, the Rules of the Commission, and any information provided to a Member State pursuant thereto in any judicial or quasi-judicial proceeding in a Member State pertaining to the subject matter of this Compact, or which may affect the powers, responsibilities, or actions of the Commission.
- The Commission shall be entitled to receive service of process proceeding regarding the enforcement or interpretation of the Compact and shall have standing to intervene in such a proceeding for all purposes. Failure to provide the Commission service of process shall render a judgment or order void as to the Commission, this Compact, or promulgated Rules.
  - B. Default, Technical Assistance, and Termination
- 1. If the Commission determines that a Member State has defaulted in the performance of its obligations or responsibilities under this Compact or the
- promulgated Rules, the Commission shall:

  a. Provide written notice to the defaulting State and other Member States of the nature of the default, the proposed means of curing the default, or any other action to be taken by the Commission; and
  b. Provide remedial training and specific technical assistance regarding
- the default.
- C. If a State in default fails to cure the default, the defaulting State be terminated from the Compact upon an affirmative vote of a majority of Commissioners of the Member States, and all rights, privileges, benefits conferred on that State by this Compact may be terminated on the effective date of termination. A cure of the default does not relieve the offending State of obligations or liabilities incurred during the period of <u>default.</u>
- D. Termination of membership in the Compact shall be imposed only after other means of securing compliance have been exhausted. Notice of intent to suspend or terminate shall be given by the Commission to the governor, majority and minority leaders of the defaulting State's legislature, the State
  Licensing Authority, and each of the Member States.

  E. A State that has been terminated is responsible for all assessments,

  while attempts and dishibition incurred through the effective data of
- and liabilities incurred through the effective date of including obligations that extend beyond the effective date of <u>obligations,</u> <u>termination,</u>
- F. The Commission shall not bear any costs related to a State that is found to be in default or that has been terminated from the Compact, unless agreed upon in writing between the Commission and the defaulting State.
- G. The defaulting State may appeal the action of the Commission by petitioning the United States District Court for the District of Columbia or the federal district where the Commission has its principal offices. The prevailing party shall be awarded all costs of such litigation, including

reasonable attorney's fees.

H. Dispute Resolution

- 1. Upon request by a Member State, the Commission shall attempt to resolve disputes related to the Compact that arise among Member States and between <u>Member and non-Member States.</u>
- 2. The Commission shall promulgate a Rule providing for both binding and non-binding alternative dispute resolution for disputes as appropriate.
  - <u>I. Enforcement</u>
- The Commission, in the reasonable exercise of its discretion, shall
- enforce the provisions and Rules of this Compact.

  2. By majority vote, the Commission may initiate legal action in the United States District Court for the District of Columbia or the federal <u>district</u> where the Commission has its principal offices against a Member State in default to enforce compliance with the provisions of the Compact and its promulgated Rules and Bylaws. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, prevailing party shall be awarded all costs of such litigation, including reasonable attorney's fees. The remedies herein shall not be the exclusive remedies of the Commission. The Commission may pursue any other remedies available under federal or State law.

- ARTICLE XI- EFFECTUATION, WITHDRAWAL, AND AMENDMENT

  A. The Compact shall come into effect on the date on which the Compact statute is enacted into law in the tenth Member State.
- 1. On or after the effective date of the Compact, the Commission shall convene and review the enactment of each of the Charter Member States to determine if the statute enacted by each such Charter Member State is materially different from the model Compact statute.
- 2. A Charter Member State whose enactment is found to be materially different from the model Compact statute shall be entitled to the default process set forth in Article X.
- 3. Member States enacting the Compact subsequent to the Charter States shall be subject to the process set forth in Article VII.C.20 to determine if their enactments are materially different from the model Compact statute and whether they qualify for participation in the Compact.
- B. If any Member State is later found to be in default, or is terminated or withdraws from the Compact, the Commission shall remain in existence and the Compact shall remain in effect even if the number of Member States should be <u>less than ten.</u>
- C. Any State that joins the Compact after the Commission's initial adoption of the Rules and Bylaws shall be subject to the Rules and Bylaws as they exist on the date on which the Compact becomes law in that State. Any Rule that has been previously adopted by the Commission shall have the full force and effect of law on the day the Compact becomes law in that State, as the Rules and Bylaws may be amended as provided in this Compact.

  D. Any Member State may withdraw from this Compact by enacting a statute
- repealing the same.
- 1. A Member State's withdrawal shall not take effect until six (6) months after enactment of the repealing statute.
- 2. Withdrawal shall not affect the continuing requirement of the withdrawing State's Licensing Authority to comply with the investigative and Adverse Action reporting requirements of this act prior to the effective date <u>of withdrawal.</u>
- E. This Compact may be amended by the Member States. No amendment to this Compact shall become effective and binding upon any Member State until it is enacted into the laws of all Member States.

  ARTICLE XII- CONSTRUCTION AND SEVERABILITY

This Compact shall be liberally construed to effectuate the purposes thereof. The provisions of this Compact shall be severable and if any phrase, clause, sentence, or provision of this Compact is declared to be contrary to the constitution of any Member State or a State seeking membership in the compact, or of the United States or the applicability thereof to any other government, agency, person, or circumstance is held invalid, the validity of the remainder of this Compact and the applicability thereof to any government, agency, person, or circumstance shall not be affected thereby. If this Compact shall be held contrary to the constitution of any Member State, the Compact shall remain in full force and effect as to the remaining Member States and in full force and effect as to the Member State affected as to all severable

ARTICLE XIII- CONSISTENT EFFECT AND CONFLICT WITH OTHER STATE LAWS

- A. Nothing herein shall prevent or inhibit the enforcement of any other law of a Member State that is not inconsistent with the Compact.
- B. Any laws, statutes, regulations, or other legal requirements in a Member State in conflict with the Compact are superseded to the extent of the conflict.
- C. All permissible agreements between the Commission and the Member States
- are binding in accordance with their terms.

  Sec. 5. Section 79-101, Revised Statutes Cumulative Supplement, 2022, is amended to read:

- 79-101 For purposes of Chapter 79:
  (1) School district means the territory under the jurisdiction of a single school board authorized by Chapter 79;
  (2) School means a school under the jurisdiction of a school board
- authorized by Chapter 79;

- (3) Legal voter means a registered voter as defined in section 32-115 who is domiciled in a precinct or ward in which he or she is registered to vote and which precinct or ward lies in whole or in part within the boundaries of a school district for which the registered voter chooses to exercise his or her right to vote at a school district election;
- (4) Prekindergarten programs means all early childhood programs provided for children who have not reached the age of five by the date provided in section 79-214 for kindergarten entrance;
  (5) Elementary grades means grades kindergarten through eight, inclusive;
- (6) High school grades means all grades above the eighth grade;
  (7) School year means (a) for elementary grades other than kindergarten, the time equivalent to at least one thousand thirty-two instructional hours and (b) for high school grades, the time equivalent to at least one thousand eighty instructional hours;
- (8) Instructional hour means a period of time, at least sixty minutes, which is actually used for the instruction of students;
- (9) Teacher means any certified employee who is regularly employed for the instruction of pupils in the public schools;
- (10) Administrator means any certified employee such as superintendent, assistant superintendent, principal, assistant principal, school nurse, or other supervisory or administrative personnel who do not have as a primary duty
- the instruction of pupils in the public schools;

  (11) School board means the governing body of any school district. Board of education has the same meaning as school board;
- (12) Teach means and includes, but is not limited to, the following responsibilities: (a) The organization and management of the classroom or the physical area in which the learning experiences of pupils take place; (b) the assessment and diagnosis of the individual educational needs of the pupils; (c) the planning, selecting, organizing, prescribing, and directing of the learning experiences of pupils; (d) the planning of teaching strategies and the selection of available materials and equipment to be used; and (e) the evaluation and reporting of student progress;
  - (13) Permanent school fund means the fund described in section 79-1035.01; (14) Temporary school fund means the fund described in section 79-1035.02;
- (15) School lands means the lands described in section 79-1035.03. Educational lands has the same meaning as school lands;
- (16) Community eligibility provision means the alternative to household applications for free and reduced-price meals in high-poverty schools enacted in section 104(a) of the federal Healthy, Hunger-Free Kids Act of 2010, section 11(a)(1) of the Richard B. Russell National School Lunch Act, 42 U.S.C. 1759a(a)(1), as such act and section existed on January 1, 2015, and administered by the United States Department of Agriculture; and
- (17)(a) (17) Certificate, certificated, or certified, when referring to an individual holding a certificate to teach, administer, or provide special services, also includes an individual who holds a permit issued by the Commissioner of Education pursuant to sections 79-806 to 79-815.
- (b) Certificate, certificated, or certified, when referring to an individual holding a certificate to teach, also includes an individual who is granted a certificate in accordance with the Interstate Teacher Mobility Compact and section 6 of this act.
- The State Board of Education may adopt and promulgate rules and regulations to define school day and other appropriate units of the school calendar.
- Sec. 6. The State Board of Education shall adopt and promulgate rules and regulations to provide for certification of teachers pursuant to the Interstate <u>Teacher Mobility Compact.</u>
- Sec. 7. Original section 79-101, Revised Statutes Cumulative Supplement, 2022, is repealed.
