## LEGISLATIVE BILL 43

Approved by the Governor April 17, 1986

Introduced by Warner, 25

AN ACT relating to constitutional officers; to amend sections 84-201.01 and 84-721, Reissue Revised Statutes of Nebraska, 1943, and sections 24-201.01 and 75-104, Revised Statutes Supplement, 1984; to change the salaries of constitutional officers as prescribed; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 24-201.01, Revised Statutes Supplement, 1984, be amended to read as follows:

24-201.01. On January 8, 1981, the salary of the Chief Justice and Judges of the Supreme Court shall be forty-eight thousand three hundred fourteen dollars and eighty cents. As soon as the same may be legally paid under the Constitution of Nebraska, the salary shall be increased to an amount equal to five per cent over the base salary. For the purposes of this section, base salary shall mean the amount derived by increasing forty-eight thousand three hundred fourteen dollars and eighty cents by five per cent. On January 5, 1984, the salary shall be increased by five per cent of the salary received immediately prior to such date. On January 3, 1985, the salary shall be increased by five per cent of the salary received immediately prior to such date. January 1, 1986, the salary shall be increased by five per cent of the salary received immediately prior to such date. The Governor shall receive an annual salary of forty thousand dellars. The Chief Justice and the Judges of the Supreme Court shall hold no other public office of profit or trust during their terms of office nor accept any public appointment or employment under the authority of the government of the United States for for their services. which they receive compensation shall be payable in equal monthly Such salaries installments.

Sec. 2. The Governor shall receive an annual salary of forty thousand dollars. Commencing January 8, 1987, the salary of the Governor shall be fifty-eight thousand dollars. Such salary shall be payable in equal monthly installments.

Sec. 3. That section 75-104, Revised Statutes Supplement, 1984, be amended to read as follows:

75-104. As soon after July 1, 1985, as the same may be payable under the Constitution of Nebraska, each of the commissioners shall receive an annual salary of twenty-seven thousand dollars, payable in the same manner that the salaries of other state officers are Commencing January 8, 1987, the salary of each commissioner shall be thirty-five thousand dollars. In addition thereto, the commissioners, secretary, clerks, and other employees of the commission shall be entitled receive from the state their actual necessary traveling expenses, which shall include the cost of transportation while traveling on the business of the commission, to be paid in the same manner as other claims against the state. In computing the cost of transportation for commissioners, secretary, clerks, and other employees, no mileage or other traveling expense shall be claimed or allowed unless the provisions of sections 84-306 to 84-306.05 are strictly complied with. Sec. 4. That section 84-201.01, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

84-201.01. Until the first Thursday after the first Tuesday in January 1979; there shall be paid as salary to the Attorney General; the sum of thirty-two thousand five hundred dollars. Commencing the first Tuesday after the first Tuesday in January 1979, there shall be paid as salary to the Attorney General; the sum of thirty-nine thousand five hundred dollars. The salary of the Attorney General shall be payable in equal monthly installments. Commencing January 8, 1987, the salary of the Attorney General shall be fifty-seven thousand five hundred dollars.

Sec. 5. That section 84-721, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

84-721. Until the first Thursday after the first Tuesday in January 1979, there shall be paid as salaries to certain constitutional officers, as follows: Secretary of State, the sum of twenty-five thousand dollars per annum; Auditor of Public Accounts, the sum of twenty-five thousand dollars per annum; State Treasurer, the sum of twenty-five thousand dollars per annum; and the Licutenant Governor, the sum of twenty-five thousand dollars per annum; and the Licutenant Governor, the sum of twenty-five thousand dollars per annum; From and after Commencing the first Thursday after the first Tuesday in January 1979, there shall be paid as salaries to certain constitutional officers, as follows: Secretary of

State, the sum of thirty-two thousand dollars per annum; Auditor of Public Accounts, the sum of thirty-two thousand dollars per annum; State Treasurer, the sum of thirty-two thousand dollars per annum; and the Lieutenant Governor, the sum of thirty-two thousand dollars per annum. Beginning January 8, 1987, there shall be paid as salaries to certain constitutional officers as follows: Secretary of State, the sum of forty thousand dollars per annum: Auditor of Public Accounts, the sum of thirty-five thousand dollars per annum; State Treasurer, the sum of thirty-five thousand dollars per annum; and the Lieutenant Governor, the sum of forty thousand dollars per annum. Such salaries shall be payable in equal monthly installments.

Sec. 6. That original sections 84-201.01 and 84-721, Reissue Revised Statutes of Nebraska, 1943, and sections 24-201.01 and 75-104, Revised Statutes

Supplement, 1984, are repealed.
