LEGISLATIVE BILL 812

Approved by the Governor February 3, 1988
Introduced by Labedz, 5, Chairperson, Executive Board

AN ACT relating to public meetings; to amend sections 2-3219, 79-439, and 79-1003.01, Reissue Revised Statutes of Nebraska, 1943; to change references to sections that were repealed in 1975; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 2-3219, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

2-3219. (1) The board shall hold regularly scheduled monthly meetings at which meetings the board shall take such action and make such determinations as are required by sections 2-1502 to 2-1504, 2-1507, 2-3201 to 2-3259, 31-101.01, 31-301.01, 31-401.01, 46-613.01, 46-614.01, and 46-1001.01. After the first Thursday after the first Tuesday in January 1975, a Δ majority of the voting members of the board shall constitute a quorum, and the concurrence of a majority of a quorum shall be sufficient to take action and make determinations. Within ninety days of the creation of any natural resources district, the board thereof shall, by appropriate rules and regulations, designate the regular time and place such meetings are to be held. At the first meeting of each year, the board shall review its program for the preceding year and outline its plans for the following year. At the first regularly scheduled meeting after the completion of the yearly audit required by section 2-3223, it shall present a report of the financial condition of the district and open discussion relevant to the same. Notice shall given of all board meetings pursuant to section 84-1402 84-1411.

(2) The boards of directors of the natural resources districts within each river basin shall meet jointly at least twice a year at such times and places as may be mutually agreed upon for the purpose of receiving and coordinating their efforts for the maximum benefit of the basin.

Sec. 2. That section 79-439, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

79-439. In all meetings of any school board, or board of education, a majority of the members shall constitute a quorum for the transaction of business. Regular meetings shall be held on or before the third Monday of every month. All meetings of the board shall be subject to the previsions of sections 84-1401 to 84-1405 sections 84-1408 to 84-1414. Special meetings may be called by the president or any two members, but all members shall have notice of the time and place of meeting. Sections 7 PROVIDED, the previsions of sections 79-439 to 79-444 shall not apply to Class V school districts.

Sec. 3. That section 79-1003.01, Reissue Revised Statutes of Nebraska, 1943, be amended to read

as follows:

79-1003.01. The regular meetings of the board of education shall be held on the first and third Monday of each month. Special 7 but special meetings may be held as circumstances may demand 7 at the call of the president of the board or on petition of a majority of the members thereof. All meetings of the board shall be subject to the previsions of sections 84-1408 to 84-1414.

Sec. 4. That original sections 2-3219, 79-439, and 79-1003.01, Reissue Revised Statutes of

Nebraska, 1943, are repealed.
