1 A BILL FOR AN ACT relating to appropriations; to amend Laws 2023, LB227A,  
2 section 1; Laws 2023, LB814, sections 80 and 304; and sections 66  
3 and 111, Legislative Bill 1412, One Hundred Eighth Legislature,  
4 Second Session, 2024; to transfer funds, appropriate funds, and  
5 change appropriations to aid in carrying out the provisions of  
6 Legislative Bill 1355, One Hundred Eighth Legislature, Second  
7 Session, 2024; to harmonize provisions; to provide an operative  
8 date; to repeal the original sections; and to declare an emergency.  
9 Be it enacted by the people of the State of Nebraska,

1           Section 1. The State Treasurer shall transfer \$9,000,000 from the  
2 Nebraska Opioid Recovery Trust Fund to the Opioid Treatment  
3 Infrastructure Cash Fund on or after July 1, 2024, but before July 15,  
4 2024.

5           Sec. 2. There is hereby appropriated (1) \$-0- from the Opioid  
6 Treatment Infrastructure Cash Fund for FY2023-24 and (2) \$159,649 from  
7 the Opioid Treatment Infrastructure Cash Fund for FY2024-25 to the  
8 Department of Health and Human Services, for Program 33, to aid in  
9 carrying out the provisions of Legislative Bill 1355, One Hundred Eighth  
10 Legislature, Second Session, 2024.

11           Total expenditures for permanent and temporary salaries and per  
12 diems from funds appropriated in this section shall not exceed \$-0- for  
13 FY2023-24 or \$118,258 for FY2024-25.

14           Sec. 3. There is hereby appropriated (1) \$-0- from the General Fund  
15 for FY2023-24 and (2) \$250,000 from the General Fund for FY2024-25 to the  
16 Board of Regents of the University of Nebraska, for Program 781, to aid  
17 in carrying out the provisions of Legislative Bill 1355, One Hundred  
18 Eighth Legislature, Second Session, 2024.

19           There is included in the appropriation to this program for FY2023-24  
20 \$-0- General Funds for research at the University of Nebraska Medical  
21 Center, which shall only be used for research on opioid misuse prevention  
22 research, opioid addiction research, or population, clinical,  
23 translational, and basic science research proposals to decrease the  
24 harmful impact of the opioid epidemic on Nebraska. There is included in  
25 the appropriation to this program for FY2024-25 \$250,000 General Funds  
26 for research at the University of Nebraska Medical Center, which shall  
27 only be used for research on opioid misuse prevention research, opioid  
28 addiction research, or population, clinical, translational, and basic  
29 science research proposals to decrease the harmful impact of the opioid  
30 epidemic on Nebraska.

31           No expenditures for permanent and temporary salaries and per diems

1 for state employees shall be made from funds appropriated in this  
2 section.

31 It is the intent of the Legislature that any provider rate increases

1 appropriated in FY2021-22 and FY2022-23 continue in the appropriation to  
2 this program and that any provider rate increases appropriated in  
3 FY2023-24 and FY2024-25 are in addition to such increases.

4 It is the intent of the Legislature that any appropriation to the  
5 department for behavioral health aid and designated as funding to be  
6 allocated to a behavioral health region shall be utilized to provide  
7 activities pursuant to the approved annual budget of the behavioral  
8 health region or additional activities identified through need  
9 demonstrated by the region throughout the year.

10 Whenever circumstances occur during the budget year that impact the  
11 initial projected behavioral health region budget, the Behavioral Health  
12 Regional Governing Board may request a reassignment of funds to  
13 accommodate emerging needs identified by the behavioral health region to  
14 maximize the ability of the region to implement new behavioral health  
15 services and supports or expand capacity in existing services. The  
16 Division of Behavioral Health shall approve all such requests which  
17 comply with all state and federal requirements. The Division of  
18 Behavioral Health shall approve or deny such requests in writing within  
19 thirty days.
