- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 196, One Hundred
- 3 Eighth Legislature, Second Session, 2024; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$2,770,810 from the
2 General Fund, \$62,809 from the Nebraska State Patrol Cash Fund, and
3 \$81,097 from federal funds for FY2024-25 and (2) \$2,770,810 from the
4 General Fund, \$62,809 from the Nebraska State Patrol Cash Fund, and
5 \$142,720 from federal funds for FY2025-26 to the Nebraska State Patrol,
6 for Program 100, to aid in carrying out the provisions of Legislative
7 Bill 196, One Hundred Eighth Legislature, Second Session, 2024.

8 No expenditures for permanent and temporary salaries and per diems
9 for state employees shall be made from funds appropriated in this
10 section.

11 Sec. 2. There is hereby appropriated (1) \$608,970 from the Carrier
12 Enforcement Cash Fund and \$36,369 from federal funds for FY2024-25 and
13 (2) \$608,970 from the Carrier Enforcement Cash Fund and \$36,369 from
14 federal funds for FY2025-26 to the Nebraska State Patrol, for Program
15 205, to aid in carrying out the provisions of Legislative Bill 196, One
16 Hundred Eighth Legislature, Second Session, 2024.

17 No expenditures for permanent and temporary salaries and per diems
18 for state employees shall be made from funds appropriated in this
19 section.

20 Sec. 3. There is hereby appropriated (1) \$11,427 from the Capitol
21 Security Revolving Fund for FY2024-25 and (2) \$11,427 from the Capitol
22 Security Revolving Fund for FY2025-26 to the Nebraska State Patrol, for
23 Program 630, to aid in carrying out the provisions of Legislative Bill
24 196, One Hundred Eighth Legislature, Second Session, 2024.

25 No expenditures for permanent and temporary salaries and per diems
26 for state employees shall be made from funds appropriated in this
27 section.

28 Sec. 4. There is hereby appropriated (1) \$31,335 from the Workers'
29 Compensation Claims Revolving Fund for FY2024-25 and (2) \$31,761 from the
30 Workers' Compensation Claims Revolving Fund for FY2025-26 to the
31 Department of Administrative Services, for Program 535, to aid in

1 carrying out the provisions of Legislative Bill 196, One Hundred Eighth
2 Legislature, Second Session, 2024.

3 Total expenditures for permanent and temporary salaries and per
4 diems from funds appropriated in this section shall not exceed \$14,940
5 for FY2024-25 or \$15,687 for FY2025-26.

6 Sec. 5. There is hereby appropriated (1) \$15,433 from the State
7 Insurance Fund for FY2024-25 and (2) \$15,643 from the State Insurance
8 Fund for FY2025-26 to the Department of Administrative Services, for
9 Program 535, to aid in carrying out the provisions of Legislative Bill
10 196, One Hundred Eighth Legislature, Second Session, 2024.

11 Total expenditures for permanent and temporary salaries and per
12 diems from funds appropriated in this section shall not exceed \$7,358 for
13 FY2024-25 or \$7,726 for FY2025-26.

14 Sec. 6. There is hereby appropriated (1) \$20,000 from the State
15 Patrol Retirement Act Expense Fund for FY2024-25 and (2) \$-0- from the
16 State Patrol Retirement Act Expense Fund for FY2025-26 to the Public
17 Employees Retirement Board, for Program 41, to aid in carrying out the
18 provisions of Legislative Bill 196, One Hundred Eighth Legislature,
19 Second Session, 2024.

20 No expenditures for permanent and temporary salaries and per diems
21 for state employees shall be made from funds appropriated in this
22 section.

23 Sec. 7. Since an emergency exists, this act takes effect when
24 passed and approved according to law.
