1 A BILL FOR AN ACT relating to appropriations; to amend Laws 2023, LB50A,  
2 section 5; Laws 2023, LB814, section 67; and section 111,  
3 Legislative Bill 1412, One Hundred Eighth Legislature, Second  
4 Session, 2024; to appropriate funds and reduce appropriations to aid  
5 in carrying out the provisions of Legislative Bill 631, One Hundred  
6 Eighth Legislature, Second Session, 2024; to harmonize provisions;  
7 and to repeal the original sections.  
8 Be it enacted by the people of the State of Nebraska,

1           Section 1. There is hereby appropriated (1) \$-0- from the General  
2 Fund for FY2023-24 and (2) \$376,819 from the General Fund for FY2024-25  
3 to the Supreme Court, for Program 67, to aid in carrying out the  
4 provisions of Legislative Bill 631, One Hundred Eighth Legislature,  
5 Second Session, 2024.

6           Total expenditures for permanent and temporary salaries and per  
7 diems from funds appropriated in this section shall not exceed \$-0- for  
8 FY2023-24 or \$181,280 for FY2024-25.

9           Sec. 2. There is hereby appropriated (1) \$-0- from the General Fund  
10 for FY2023-24 and (2) \$150,000 from the General Fund for FY2024-25 to the  
11 State Fire Marshal, for Program 193, to aid in carrying out the  
12 provisions of Legislative Bill 631, One Hundred Eighth Legislature,  
13 Second Session, 2024.

14           Total expenditures for permanent and temporary salaries and per  
15 diems from funds appropriated in this section shall not exceed \$-0- for  
16 FY2023-24 or \$51,875 for FY2024-25.

17           Sec. 3. There is hereby appropriated (1) \$-0- from the General Fund  
18 and \$-0- from the Parole Program Cash Fund for FY2023-24 and (2)  
19 \$10,111,051 from the General Fund and \$455,873 from the Parole Program  
20 Cash Fund for FY2024-25 to the Department of Correctional Services, for  
21 Program 200, to aid in carrying out the provisions of Legislative Bill  
22 631, One Hundred Eighth Legislature, Second Session, 2024.
