INTRODUCTION

Nebraska has more than 200 statutorily created boards, commissions, and other similar entities (boards). Among the many tasks assigned to them, boards provide oversight of governmental programs, regulate licensed professionals, carry out studies, oversee implementation of new programs, advocate for certain constituencies, and advise state agencies.

In 1997, the Executive Board of the Legislative Council requested that the Legislative Research Office compile and annually update a list of statutorily created boards. This publication contains that list.²

THE LEGISLATURE'S ROLE IN BOARDS AND COMMISSIONS

The Legislature plays a pivotal role in the establishment, administration, and operation of the state's boards and commissions.

First, as evidenced by the more than 200 statutorily created boards, the Legislature creates boards via passage of legislation. In addition to creating boards, the legislation establishes membership and prescribes powers and duties.

Second, members of the Legislature are often required to confirm specific board members appointed by the Governor. Forty-six boards have members who must be confirmed by a majority vote of the Legislature. The boards are identified in Appendix D, Table 5.

Finally, legislators serve as ex officio board members and appoint members or provide nominees for appointment by the Governor. Information about those boards can be found in Appendix A, Tables 1 and 2.

BOARDS CREATED IN THE NEBRASKA CONSTITUTION

Twelve boards are created in the Nebraska Constitution. They are the: Coordinating Commission for Postsecondary Education, State Board of Education, Board of Educational Lands and Funds, Commission of Industrial Relations, judicial nominating commissions, Commission on Judicial Qualifications, Board of Pardons, Board of Parole, Public Service Commission, Board of Trustees of the Nebraska State Colleges, Tax Equalization and Review Commission, and University of Nebraska Board of Regents.

BOARDS AS AGENCIES OF STATE GOVERNMENT

Of the 222 statutorily created boards documented in this report, 51 are state agencies.

² The list does not include: (1) boards created by executive order, by agency rule or regulation, or pursuant to federal mandates, unless enacted via state statutes; (2) governing commissions or councils created pursuant to interstate compacts; or (3) boards created via state statutes that serve local government (e.g., local school boards or boards of directors of natural resources districts).

What makes a board a state agency?

The *Nebraska Blue Book* defines state agencies as entities which have their own staffs, are not affiliated with another agency or entity, and appear as distinct items within the state budget. The most recent board/agency—the Nebraska Tourism Commission—was created in 2012 with the passage of LB 1053. (Previously, the commission had been a division within the Department of Economic Development.)

Nebraska state agencies are categorized as "code agencies" or "noncode agencies"; however, neither phrase is statutorily defined, making categorizing agencies more of an art than a science.³

Generally, a "code agency" is an agency whose executive director or chief official is appointed by the Governor. The appointee serves at the pleasure of and answers directly to the Governor. On the other hand, a "noncode agency" is an agency whose executive director or chief official is appointed by the governing agency board (whose members are usually gubernatorial appointees themselves).

Of the 51 agency boards, five are under the direct control of the Governor and are considered code agencies, and the remaining 46 are considered noncode agencies. Appendix B, Table 3 lists these boards and includes additional information about them.

OTHER STATUTORILY CREATED BOARDS

Many of the remaining state boards are created or housed within other state agencies. The health profession licensing boards within the Department of Health and Human Services are examples.

However, a significant number of boards defy categorization; they are not full-fledged state agencies nor are they completely under the control of another state agency. The *Nebraska Blue Book* classifies these boards as "other state governmental bodies" and describes them as follows: "[M]iscellaneous boards, commissions, committees, councils, authorities and quasi-governmental bodies and bodies with members from more than one branch of state government. None of these entities are full-fledged state agencies, but they have a degree of independence that keeps them from being classified within any department or agency."⁴ Among this diverse group of boards are the Environmental Trust Board, the Nebraska Investment Finance Authority, and the State Anatomical Board.

All of these boards are listed within the master list of Nebraska Boards and Commissions found in Appendix D, Table 5.

³ The terms "code" and "noncode" harken back to 1919, when the Legislature adopted the Civil Administrative Code. Essentially, the 1919 legislation reorganized the executive branch of state government. The legislation abolished over 20 boards, commissions, and other departmental subdivisions and replaced them with six departments, each headed by a gubernatorial appointee. Those agencies and subsequent, similarly structured agencies came to be called "code agencies." Because sources disagree on how boards are classified and consistent statutory guidance is lacking, this report uses the Governor's Office classification of code and noncode agency boards, as generally reflected in the *Nebraska Blue Book*.

2013-2014 LEGISLATION IMPACTING BOARDS AND COMMISSIONS

The 103rd Legislature created 12 new boards and eliminated 8 boards.

New Boards Enacted in 2013

Nebraska Commission on Problem Gambling (LB 6). The commission oversees the state's Gamblers Assistance Program (program), which uses revenue from the state lottery to provide services for problem gamblers. Its duties include developing guidelines and standards for the program and directing the distribution and disbursement of money in the Compulsive Gamblers Assistance Fund. Additionally, the commission appoints a director who is responsible for hiring staff and the program's day-to-day operation. The commission replaces the advisory State Committee on Problem Gambling. For administrative purposes, the commission is housed within the Department of Revenue, Charitable Gaming Division.

The Governor appoints and the Legislature confirms the members, who must have no monetary interest in program contracts nor be employees of the Department of Revenue. The nine-member commission includes: (1) one person with medical care or mental health expertise; (2) one person with expertise in banking and finance; (3) one person with legal expertise; (4) one person with expertise in the field of education; (5) two consumers of problem gambling services; (6) one person with data analysis expertise; and (7) two Nebraska residents who represent the public at large. Members serve three-year terms.

Young Adult Voluntary Services and Support Advisory Committee (LB 216). The committee makes recommendations to the Department of Health and Human Services and the Nebraska Children's Commission regarding implementing and operating the extended services program for former state wards who have aged out of the state's foster care system. Youth who enter into the voluntary program can receive services, such as Medicaid, housing, and education assistance, up to age 21. Extending the program to older youth allows the state to garner additional federal revenue for the services.

The Children's Commission appoints committee members. Members include: (1) representatives from all three branches of government; (2) no less than three young adults currently or previously in foster care; (3) one or more representatives from a child welfare advocacy organization; (4) one or more representatives from a child welfare service agency; and (5) one or more representatives from an agency providing independent living services. Appointees serve for two years.

In 2014, via LB 853, the Legislature changed the name of this advisory committee to the **Young Adult Bridge to Independence Advisory Committee**, reflecting changes made to the overall program to aid foster children aging out of the system. The advisory committee's membership and role remain the same.

Nebraska Exchange Stakeholder Commission (LB 384). The commission has several duties pertaining to Nebraska's health insurance exchange, operated as part of the federal

health care reform law. The commission must (1) work with state and federal agencies and policymakers to make recommendations for implementing and operating the exchange; (2) create technical and advisory groups, as needed, to discuss issues related to the exchange and make recommendations to the commission, state or federal agencies, and the Legislature; (3) assist the exchange in meeting the federally mandated stakeholder consultation requirement; (4) identify problems encountered as the exchange is implemented and make recommendations to solve them; and (5) provide annual reports regarding the exchange to the Governor and the Legislature. For administrative and budgetary purposes, the commission is housed within the Department of Insurance.

The commission has 11 members, nine of whom are appointed by the Governor and confirmed by the Legislature. The appointees include (1) four members to represent the interests of consumers who will access health insurance in the exchange, one of whom must represent rural consumers; (2) one member to represent the interests of small businesses qualified to purchase health insurance in the exchange; (3) two members to represent the interests of health care providers in Nebraska; (4) one member to represent the interests of health insurance carriers eligible to offer health plans in the exchange; and (5) one member to represent the interests of health insurance agents. The other two nonvoting, ex officio members of the commission are the Director of Insurance or his or her designee and the director of the Division of Medicaid and Long-Term Care of the Department of Health and Human Services or his or her designee. Members serve four-year terms.

Water Funding Task Force (LB 517). The task force was charged with studying the state's water resources and developing a plan to sustainably manage those resources, including identifying a way to pay for water projects. The task force, which terminated on December 31, 2013, presented its findings in a report to the Legislature in December 2013.

The members of the task force included the members of the Nebraska Natural Resources Commission, the Director of Natural Resources or his or her designee, the chairperson of the Legislature's Natural Resources Committee or his or her designee, and five other members of the Legislature appointed by the Executive Board of the Legislative Council. Those members served as ex officio, nonvoting members. The Governor also appointed an additional 11 voting members to represent diverse geographic regions of the state. The gubernatorial appointees included one member from each of the following categories: (1) public power; (2) public power and irrigation districts; (3) irrigation districts; (4) a metropolitan utilities district; (5) municipalities; (6) agriculture; (7) wildlife conservation; (8) livestock producers; (9) agribusiness; (10) manufacturing; and (11) outdoor recreation users.

In response to the task force's findings, the Legislature enacted Laws 2014, LB 1098, which gave new duties to the Natural Resources Commission. For more information on this bill, see page 10.

New Boards Enacted in 2014

Health Care Data Base Advisory Committee (LB 76.) The advisory committee, created pursuant to the Health Care Transparency Act, makes recommendations regarding the creation and implementation of the Nebraska Health Care Data Base. The data base has

three intended purposes: (1) provide objective analysis of health care costs and quality, (2) promote transparency for health care consumers, and (3) facilitate the reporting of health care and health quality data. The Director of Insurance appoints the advisory committee members.

Members of the advisory committee include: (1) a member of academia with experience in health care data and cost efficiency research; (2) at least one hospital representative; (3) at least one physician; (4) at least one other health care provider; (5) a small-business employer who purchases group health insurance for employees; (6) a large-business employer who purchases health insurance for employees; (6) at least one experienced health care consumer advocate, knowledgeable about health insurance issues; (7) at least one insurance representative; (8) a representative of organizations that facilitate health information exchange; and (9) at least one member of a local public health department.

Additionally, the Director of Insurance and the directors of the Division of Medicaid and Long-Term Care and the Division of Public Health or their designees serve as ex officio members of the advisory committee.

The Director of Insurance is to report the recommendations made by the advisory committee to the Governor and the Legislature by December 15, 2014.

Priority School Intervention Team (LB 438). Under LB 438, public schools with the lowest performance levels, as measured by such standards as test scores and graduation rates, are to be designated "priority schools" by the State Board of Education. For each school designated a priority school, the Commissioner of Education appoints an intervention team of up to five people to work with the school administration and staff to develop a progress plan. To be appointed to an intervention team, individuals must have the education and experience to carry out the team's responsibilities. Team members receive pay and expenses for their service on an intervention team.

Council on Student Attendance (LB 464). The council replaces the Truancy Intervention Task Force, established in 2010 to redress student absenteeism, which is viewed as a corollary to juvenile delinquency. Council members include the probation administrator, the Commissioner of Education, and the chief executive officer of the Department of Health and Human Services or their designees and seven members appointed by the State Board of Education. The appointed members include: (1) a school board member; (2) two unrelated parents with children attending school; (3) a school district superintendent or his or her designee; (4) a student; (5) a community or advocacy organization representative; and (6) a county attorney

Members appointed by the State Board of Education serve staggered three-year terms and receive expense reimbursement but no additional compensation.

Duties assigned to the council include studying whether school district policies and practices for addressing absenteeism are effective, reviewing the written attendance policies all school districts must have, and making recommendations for improvement when needed.

The council must issue a report on its activities to the Legislature by October 1 of each year.

Aging Nebraskans Task Force (LB 690). The task force is charged with developing and facilitating implementation of a statewide strategic plan to address the needs of the state's aging population and providing a forum for stakeholders to collaborate on long-term care programs. All three branches of state government are represented on the task force's executive committee, but only legislative members can vote. The legislative members are the chairperson of the Health and Human Services Committee; a member each from the Appropriations Committee, the Health and Human Services Committee, and the Planning Committee; and an at-large member, all appointed by the Executive Board of the Legislative Council. Rounding out the task force's executive committee are the chief executive officer of the Department of Health and Human Services and the Chief Justice of the Nebraska Supreme Court.

An additional four members are appointed by the executive committee through an application and selection process. These members represent stakeholders in the long-term care system and can include a representative of the Division of Medicaid and Long-Term Care Advisory Committee on Aging, representatives of health care providers, elder law attorneys, representatives of the long-term care ombudsman program, health care economists, geriatric specialists, family caregivers of seniors in at-home care, providers of services to the elderly, seniors currently or previously in institutional care, and advocacy organizations for the aged.

The task force must report its recommendations to the Legislature by December 15, 2014. The task force terminates on June 30, 2016.

Nebraska Sesquicentennial Commission (LB 744). The commission is tasked with planning for the official observance of the 150th anniversary of Nebraska statehood in 2017.

The commission consists of 17 members, appointed by the Governor, from all regions of the state, representing all major interests, and a diverse array of industries. No more than eight members can be affiliated with the same political party. For administrative and budgetary purposes, the commission is housed within the Nebraska State Historical Society. Members are reimbursed for their expenses. The commission can employ personnel, contract for services, and receive and expend gifts, grants, donations, and legislative appropriations to carry out its functions.

The commission terminates on June 30, 2018.

Review, Evaluate, and Decide Team (LB 853). The team consists of internal staff within the Department of Health and Human Services knowledgeable about the structured review process in child abuse and neglect investigations. The team must consist of no fewer than two supervisors or administrators and two staff members. County attorneys, child advocacy center representatives, and law enforcement agency personnel can attend team reviews by request.

The team's job is to evaluate reports of child abuse and neglect that come to the department and decide whether each report should be handled by a traditional response involving the initiation of a criminal investigation or whether the department should undertake an alternative response. An alternative response is not investigated as a

criminal matter, does not result in a finding of child abuse or neglect, nor are families in such cases entered into the central registry of child protection cases maintained by the department. Instead, families in alternative-response cases receive appropriate and supportive services.

Nebraska Justice Reinvestment Working Group (LB 907). The working group is composed of members from all three branches of state government appointed for the purpose of assisting the Council of State Governments as it examines Nebraska's criminal justice system. The goals of the examination are to reduce correctional spending, prison overcrowding, and recidivism and to increase public safety.

The working group includes four members selected by the Governor, four members selected by the Speaker of the Legislature, four members selected by the Chief Justice of the Nebraska Supreme Court, and four representatives of local governments selected jointly by the Governor, Speaker, and Chief Justice, who also serve as co-chairpersons of the working group.

The working group dissolves upon delivery of a report containing the group's recommendations. The report is due by September 1, 2015.

Advisory Council on Public Guardianship (LB 920). The advisory council assists the state's new Public Guardian. The Office of Public Guardian is intended to provide Nebraskans unable to manage their own affairs an official state entity to contact for help.

The State Court Administrator appoints advisory council members from a variety of disciplines who are knowledgeable in guardianship and conservatorship matters. Members must represent the geographical and cultural diversity of the state and reflect gender fairness. Specifically, the council must consist of (1) a representative of the Nebraska County Court Judges Association; (2) licensed practicing attorneys; (3) social workers; (4) mental health professionals; (5) professionals with expertise in the aging population; (6) developmental disability professionals; and (7) other interested groups or individuals. Initial appointments are for staggered terms of one, two, or three years, but all subsequent appointees serve three years.

The advisory council must meet at least four times per year and upon the call of the chairperson. Members are reimbursed for expenses.

Eliminated Boards, 2013-2014

The Legislature eliminated eight boards during the 2013-2014 biennium.

Neb. Rev. Stat secs. 50-1301 to 50-1304, directs the Government, Military and Veterans Affairs Committee to review and evaluate the state's boards to determine whether the boards should be continued, terminated, or modified. The review and evaluation resulted in the introduction and passage of Laws 2013, LB 78, which eliminated six boards. Additionally, one other board was eliminated in 2013 and one board was eliminated in 2014.

The following boards were eliminated in 2013.

Livestock Auction Market Board (LB 78)

Economic Development Commission (LB 78)

The following board was eliminated in 2014.

Truancy Intervention Task Force (LB 464)

Existing Boards, 2013-2014

This report does not track every change made to existing boards. However, the following significant changes are briefly noted.

2013 Legislation Affecting Existing Boards

Nebraska Educational Finance Authority (LB 170). LB 170 changes the name of the authority to the **Nebraska Educational, Health, and Social Services Finance Authority**. This change reflects the authority's new duties under the expanded scope of the also newly renamed Nebraska Educational, Health, and Social Services Finance Authority Act. Previously, the authority existed to facilitate bond financing for private higher education institutions in the state. The bill expands the authority's duties to include private health care and social services institutions.

Coordinating Commission for Postsecondary Education and the Nebraska Community College Student Performance and Occupational Grant Committee (LB 211). Changes made pursuant to LB 211 affect both the coordinating commission and the grant committee. Notably, LB 211 clarifies that the coordinating commission is responsible for the statewide coordination of Nebraska's six community college areas and that statewide coordination of community college areas is not the province of any board or association representing all community colleges. The bill also provides that the Nebraska Community College Student Performance and Occupational Education Grant Fund is under the direction of the grant committee but is to be administered by the coordinating commission.

State Child Death Review Team (LB 269 and LB 361). LB 269 adds the Inspector General

of Nebraska Child Welfare as a core member of the State Child Death Review Team.

LB 361 changes the name of the team, increases its membership, and gives it new duties pertaining to maternal deaths. The team is renamed the *State Child and Maternal Death Review Team* and the membership is increased to between no fewer than 12 and no more than 15 members. (Previously, the membership was between 8 and 12 members.) Additionally, the bill places the team under the general administration of the Department of Health and Human Services and directs the department to hire or contract with a team coordinator to provide administrative support to the team.

Riparian Vegetation Management Task Force (LB 477). LB 477 changes the sunset date for the task force from June 30, 2013 to June 30, 2015 and extends the final report due from the task force to that date.

Foster Care Reimbursement Rate Committee and the Nebraska Children's Commission (LB 530). Laws 2012, LB 820 created the Foster Care Reimbursement Rate Committee to develop a statewide, standard reimbursement rate structure for children in foster care and a statewide level-of-care assessment to use in determining placement needs and the appropriate reimbursement rate. The committee finished its work in December 2012 with the delivery of its final report.

Laws 2013, LB 530 implements the committee's findings, re-enacts the committee, and charges it with continuing duties pertaining to foster care reimbursement rates, the standardized level-of-care assessment, and adoption assistance payments.

The committee consists of no fewer than nine members and includes voting and nonvoting members. The voting members include: (1) representatives from child welfare agencies that contract directly with foster parents, representing each of the five service areas; (2) a representative from an advocacy organization which deals with child welfare-related legal and policy issues; (3) a representative from an advocacy organization with the sole focus of issues impacting children; (4) a representative from a foster and adoptive parent association; (5) a representative from a lead agency; (6) a representative from a child advocacy organization that supports young adults who were in foster care as children; (7) a foster parent who contracts directly with the Department of Health and Human Services (DHHS); and (8) a foster parent who contracts with a child welfare agency. Voting members are appointed by the children's commission and serve for four years.

The nonvoting, ex officio members include the chief executive officer of DHHS or his or her designee and representatives of the designated service areas from the DHHS Division of Children and Family Services, including an employee with a thorough understanding of the foster care payment system and at least one employee with a thorough understanding of the N-FOCUS electronic data collection system.

Finally, LB 530 extends the termination date for the children's commission to June 30, 2016.

Climate Assessment Response Committee (LB 583). LB 583 gives additional duties to the committee pertaining to climate change. Specifically, the committee must prepare a report on cyclical climate change in Nebraska, assessing such factors as historical climate

variability and change; climate projections; and possible impacts to key sectors such as agriculture, water, wildlife, ecosystems, forests, and outdoor recreation. The final report, due December 1, 2014, must include a summary of findings and recommendations for future action to address climate change.

2014 Legislation Affecting Existing Boards

Board of Cosmetology, Electrology, Esthetics, Nail Technology, and Body Art (LB 132). LB 132 adds an owner of a tanning salon to the board's membership.

Young Adult Voluntary Services Advisory Committee (LB 853). LB 853 changes the advisory committee's name to the Young Adult Bridge to Independence Advisory Committee.

Legal Education for Public Service Loan Repayment Board (LB 907). LB 907 renames the board the **Legal Education for Public Service and Rural Practice Loan Repayment Assistance Board.**

Commensurate with its name change, the board is given duties pertaining to encouraging attorneys to practice in rural areas. Additionally, LB 907 requires one board member to be a law student who intends to work for a tax-exempt charitable organization primarily doing public legal services, one board member to be a law student who is from or intends to practice in a state-designated legal profession shortage area, and one member to be a Nebraska State Bar Association member who practices in a designated legal profession shortage area.

Board of Educational Lands and Funds (LB 967). LB 967 authorizes a \$50 per diem for the board, reinstating and increasing the \$40 per diem the board had received until a budget-cutting measure in 2011 eliminated it.

Nebraska Natural Resources Commission (LB 1098). The work of the Water Funding Task Force (page 4) resulted in several recommendations for managing the state's water resources. Among these recommendations are restructuring the Natural Resources Commission to oversee administration of water projects that receive funding via the newly created Water Sustainability Fund.

LB 1098 adds 11 members to the 16-member commission. The new members, along with three existing members, are appointed by the Governor and confirmed by the Legislature. (The other 13 members are selected by the natural resources districts they represent).

The gubernatorially appointed members must represent the following categories: agribusiness interests; agricultural interests; ground water irrigators; irrigation districts; manufacturing interests; metropolitan utilities districts; municipal users of water from a city of the primary class; municipal users of water from a city of the first or second class or a village; outdoor recreation users; public power districts; public power and irrigation

districts; range livestock owners; surface water irrigators; and wildlife conservation interests.



A "Y" in this column indicates that a provision authorizing expenses exists in the statute creating the board or commission; an "N" indicates the enacting statute makes no mention of allowing expenses. However, Neb. Rev. Stat. sec. 81-1178 provides that "Any member of any state commission, council, committee, or board which has been created by statute shall be entitled to be reimbursed for expenses in the same manner as provided in sections 81-1174 to 81-1177 for state employees whether or not specific reference is made to such sections."

- Unless otherwise noted, per diems listed are the maximum allowable in statute for that particular board. Since some statutes indicate that the permissible per diem is "at least" or "up to", the actual per diem paid to a given board member could be less than that listed. As per Neb. Rev. Stat. sec. 71-112, the professional boards in the various health-related fields receive expenses as well as a per diem not to exceed \$30. Additionally, the per diem and expenses cannot be greater than "is received in fees from the applicants taking the examination in any particular profession." Each individual board sets its own per diem within those parameters. Additionally, these boards may set per diems and pay the expenses up to this rate for any subcommittees they create.
- iii Compensation for the Task Force for Building Renewal members is "established by the Governor on a per diem basis...."
- Paid only when traveling for business of the CHIP board, at the rate set by the pool administrator.
- LB 1161 states, "Each member of the board shall receive as compensation the same per diem and travel expenses as other state employees for each day actually spent in traveling to and from and while attending sessions of the board and its committees or authorized meetings of the National Association of State Boards of Geology, or their subdivisions or committees, and all necessary expenses incident to the performance of his or her duties under the Geologists Regulation Act as provided in sections 81-1174 to 81-1177."
- The Commission on Housing and Homelessness was formed by Executive Order 98-4 and combines two statutorily created advisory committees previously listed as the Housing Advisory Committee to the Affordable Housing Trust Fund and the Nebraska Affordable Housing Committee, both under the authority of the Department of Economic Development.
- In 2002, the former Advisory Committee on Families with Special Needs Housing became the Commission on Housing and Homelessness Continuum of Care Committee, which serves as the advisory committee to the Nebraska Homeless Assistance Program. Its parent agency is the Department of Health and Human Services.
- "The board, when appointed and convened, shall continue in existence only until it has resolved a dispute referred to it pursuant [to statute]." Neb. Rev. Stat. sec. 46-719(1a).
- There are actually 33 commissions of nine members each representing the various judicial districts and courts within the state.
- The Legislature confirms the three gubernatorial appointees to the 16-member commission.
- The three lay members of the board are the only members to receive a per diem, which is set at the same rate as that paid to the members of the State Highway Commission.

- All members of the Real Estate Commission receive a per diem except the chairman, who is an ex officio member and the Nebraska Secretary of State.
- Four of the 11 members are appointed by the Governor and confirmed by the Legislature.
- Committee members who are not employed by Nebraska medical schools receive a stipend per meeting. The amount is determined by the Division of Public Health of the Department of Health and Human Services based on standard consultation fees.
