A BILL

1 FOR AN ACT relating to all-terrain vehicles; to amend section
2 60-6,356, Reissue Revised Statutes of Nebraska; to change
3 provisions relating to the operation of all-terrain
4 vehicles as prescribed; and to repeal the original
5 section.

6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-6,356, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 60-6,356 (1) ~~Except as provided in subsections (2)~~
4 ~~through (5) of this section,~~ an An all-terrain vehicle shall
5 not be operated on any highway of this state. The controlled-access
6 highway with more than two marked traffic lanes, and the crossing
7 of any controlled-access highway with more than two marked traffic
8 lanes shall not be permitted. Subsections (2), (3), and (5)
9 through (8) of this section authorize and apply to operation
10 of an all-terrain vehicle only on a highway other than a
11 controlled-access highway with more than two marked traffic lanes.

12 ~~(2) The crossing of a highway shall be permitted only if:~~

13 ~~(a) The crossing is made at an angle of approximately~~
14 ~~ninety degrees to the direction of the highway and at a place where~~
15 ~~no obstruction prevents a quick and safe crossing;~~

16 ~~(b) The vehicle is brought to a complete stop before~~
17 ~~crossing the shoulder or roadway of the highway;~~

18 ~~(c) The operator yields the right-of-way to all oncoming~~
19 ~~traffic that constitutes an immediate potential hazard;~~

20 ~~(d) In crossing a divided highway, the crossing is made~~
21 ~~only at an intersection of such highway with another highway; and~~

22 ~~(e) Both the headlight and taillight of the vehicle are~~
23 ~~on when the crossing is made.~~

24 (2) An all-terrain vehicle may be operated in accordance
25 with the operating requirements of subsection (3) of this section:

1 (a) Outside the corporate limits of a city, village,
2 or unincorporated village if incidental to the vehicle's use for
3 agricultural purposes;

4 (b) Within the corporate limits of a city or village
5 if authorized by the city or village by ordinance adopted in
6 accordance with this section; or

7 (c) Within an unincorporated village if authorized by the
8 county board of the county in which the unincorporated village is
9 located by resolution in accordance with this section.

10 (3) An all-terrain vehicle may be operated ~~on a highway~~
11 as authorized in subsection (2) of this section when such operation
12 occurs only between the hours of sunrise and sunset, ~~and such~~
13 ~~operation is incidental to the vehicle's use for agricultural~~
14 ~~purposes.~~ Any person operating an all-terrain vehicle ~~on a highway~~
15 as authorized in subsection (2) of this section shall have a
16 valid Class O operator's license or a farm permit as provided in
17 section 60-4,126, shall have liability insurance coverage for the
18 all-terrain vehicle while operating the all-terrain vehicle on a
19 highway, and shall not operate such vehicle at a speed in excess
20 of thirty miles per hour. The person operating the all-terrain
21 vehicle shall provide proof of such insurance coverage to any peace
22 officer requesting such proof within five days of such a request.
23 ~~When operated on a highway,~~ operating an all-terrain vehicle as
24 authorized in subsection (2) of this section, the headlight and
25 taillight of the vehicle shall be on and the vehicle shall be

1 equipped with a bicycle safety flag which extends not less than
2 five feet above ground attached to the rear of such vehicle. The
3 bicycle safety flag shall be triangular in shape with an area of
4 not less than thirty square inches and shall be day-glow in color.

5 (4) All-terrain vehicles may be operated without
6 complying with subsection (3) of this section on highways in
7 parades which have been authorized by the State of Nebraska or
8 any department, board, commission, or political subdivision of the
9 state.

10 (5) Subject to subsection (1) of this section, the
11 crossing of a highway shall be permitted by an all-terrain vehicle
12 without complying with subsection (3) of this section only if:

13 (a) The crossing is made at an angle of approximately
14 ninety degrees to the direction of the highway and at a place where
15 no obstruction prevents a quick and safe crossing;

16 (b) The vehicle is brought to a complete stop before
17 crossing the shoulder or roadway of the highway;

18 (c) The operator yields the right-of-way to all oncoming
19 traffic that constitutes an immediate potential hazard;

20 (d) In crossing a divided highway, the crossing is made
21 only at an intersection of such highway with another highway; and

22 (e) Both the headlight and taillight of the vehicle are
23 on when the crossing is made.

24 ~~(5)~~ (6) All-terrain vehicles may be operated on highways
25 outside the corporate limits of any municipality by electric

1 utility personnel within the course of their employment in
2 accordance with the operation requirements of subsection (3) of
3 this section, except that the operation of the vehicle pursuant to
4 this subsection need not be ~~incidental to the use of the vehicle~~
5 ~~for agricultural purposes~~, limited to the hours between sunrise and
6 sunset.

7 (7) A city or village may adopt an ordinance authorizing
8 the operation of all-terrain vehicles within the corporate limits
9 of the city or village if the operation is in accordance with
10 subsection (3) of this section. The city or village may place other
11 restrictions on the operation of all-terrain vehicles within its
12 corporate limits.

13 (8) A county board may adopt a resolution authorizing the
14 operation of all-terrain vehicles within any unincorporated village
15 within the county if the operation is in accordance with subsection
16 (3) of this section. The county may place other restrictions on
17 the operation of all-terrain vehicles within the unincorporated
18 village.
