A BILL

1 FOR AN ACT relating to all-terrain vehicles; to amend section  
2 60-6,356, Reissue Revised Statutes of Nebraska; to  
3 restrict operation of all-terrain vehicles as prescribed;  
4 and to repeal the original section.  
5 Be it enacted by the people of the State of Nebraska,

1           Section 1. Section 60-6,356, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3           60-6,356 (1) Except as provided in subsections (2)  
4 through (5) of this section, an all-terrain vehicle shall not  
5 be operated on any highway of this state. The crossing of any  
6 controlled-access highway shall not be permitted.

7           (2) The crossing of a highway shall be permitted only if:

8           (a) The crossing is made at an angle of approximately  
9 ninety degrees to the direction of the highway and at a place where  
10 no obstruction prevents a quick and safe crossing;

11           (b) The vehicle is brought to a complete stop before  
12 crossing the shoulder or roadway of the highway;

13           (c) The operator yields the right-of-way to all oncoming  
14 traffic that constitutes an immediate potential hazard;

15           (d) In crossing a divided highway, the crossing is made  
16 only at an intersection of such highway with another highway; and

17           (e) Both the headlight and taillight of the vehicle are  
18 on when the crossing is made.

19           (3) An all-terrain vehicle may be operated on a highway  
20 outside the corporate limits of a municipality when such operation  
21 occurs only between the hours of sunrise and sunset and such  
22 operation is incidental to the vehicle's use for agricultural  
23 purposes. Any person operating an all-terrain vehicle on a highway  
24 shall have a valid Class O operator's license or a farm permit as  
25 provided in section 60-4,126 and shall not operate such vehicle at

1 a speed in excess of thirty miles per hour. When operated on a  
2 highway, the headlight and taillight of the vehicle shall be on  
3 and the vehicle shall be equipped with a bicycle safety flag which  
4 extends not less than five feet above ground attached to the rear  
5 of such vehicle. The bicycle safety flag shall be triangular in  
6 shape with an area of not less than thirty square inches and shall  
7 be day-glow in color.

8 (4) All-terrain vehicles may be operated on highways in  
9 parades which have been authorized by the State of Nebraska or  
10 any department, board, commission, or political subdivision of the  
11 state.

12 (5) All-terrain vehicles may be operated on highways  
13 outside the corporate limits of any municipality by electric  
14 utility personnel within the course of their employment in  
15 accordance with the operation requirements of subsection (3) of  
16 this section, except that the operation of the vehicle pursuant to  
17 this subsection need not be incidental to the use of the vehicle  
18 for agricultural purposes.
