A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid in
2 carrying out the provisions of Legislative Bill 388, One
3 Hundred Second Legislature, First Session, 2011; and to
4 reduce appropriations.

5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$2,028,000
2 from the Site and Building Development Fund for FY2011-12 and (2)
3 \$3,028,000 from the Site and Building Development Fund for FY2012-13
4 to the Department of Economic Development, for Program 603, to aid in
5 carrying out the provisions of Legislative Bill 388, One Hundred
6 Second Legislature, First Session, 2011.

7 Total expenditures for permanent and temporary salaries
8 and per diems from funds appropriated in this section shall not
9 exceed \$20,000 for FY2011-12 or \$20,000 for FY2012-13.

10 There is included in the appropriation to this program
11 for FY2011-12 \$2,000,000 Cash Funds for state aid, which shall only
12 be used for such purpose. There is included in the appropriation to
13 this program for FY2012-13 \$3,000,000 Cash Funds for state aid, which
14 shall only be used for such purpose.

15 Sec. 2. The appropriation to the Department of Economic
16 Development, for Program 601, is hereby reduced by \$2,000,000 Cash
17 Funds for FY2011-12 and by \$2,000,000 Cash Funds for FY2012-13, to
18 aid in carrying out the provisions of Legislative Bill 388, One
19 Hundred Second Legislature, First Session, 2011.

20 It is the intent of the Legislature that the reductions
21 contained in this section shall reduce the amount allocated for state
22 aid by \$2,000,000 Cash Funds for FY2011-12 and by \$2,000,000 Cash
23 Funds for FY2012-13.

24 Sec. 3. There is hereby appropriated (1) \$275,000 from
25 the Industrial Recovery Fund for FY2011-12 and (2) \$275,000 from the

1 Industrial Recovery Fund for FY2012-13 to the Department of Economic
2 Development, for Program 603, to aid in carrying out the provisions
3 of Legislative Bill 388, One Hundred Second Legislature, First
4 Session, 2011.

5 There is included in the appropriation to this program
6 for FY2011-12 \$275,000 Cash Funds for state aid, which shall only be
