A BILL

1 FOR AN ACT relating to the Nebraska statutes; to amend section
2 49-707, Reissue Revised Statutes of Nebraska; to create
3 funds; to change disposition of certain receipts; and to
4 repeal the original section.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 49-707, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 49-707 The Revisor of Statutes shall cause the
4 supplements and reissued volumes to be copyrighted under the
5 copyright laws of the United States for the benefit of the people of
6 Nebraska.

7 The supplements and reissued or replacement volumes shall
8 be sold and distributed by the Supreme Court at such price as shall
9 be prescribed by the Executive Board of the Legislative Council,
10 which price shall be sufficient to recover all costs of publication
11 and distribution.

12 The Supreme Court may sell for one dollar per volume any
13 compilation or revision of the statutes of Nebraska that has been
14 superseded by a later official revision, compilation, or replacement
15 volume. The Supreme Court may dispose of any unsold superseded
16 volumes in any manner it deems proper.

17 All money received by the Supreme Court from the sale of
18 the supplements and reissued or replacement volumes shall be paid
19 into the state treasury to the credit of the ~~General—Nebraska~~
20 Statutes Cash Fund or the Nebraska Statutes Distribution Cash Fund,
21 as appropriate. That portion of the money received that represents
22 the costs of publication shall be credited to the Nebraska Statutes
23 Cash Fund, and that portion of the money received that represents the
24 costs of distribution shall be credited to the Nebraska Statutes
25 Distribution Cash Fund. The court shall take receipts for all such

1 money paid into the ~~state treasury.~~ funds.

2 Supplements and reissued volumes shall be furnished and
3 delivered free of charge in the same number and to the same parties
4 as are designated in section 49-617.

5 Sec. 2. The Nebraska Statutes Cash Fund is created. The
6 fund shall consist of funds received pursuant to section 49-707. The
7 fund shall be used by the Revisor of Statutes to perform the duties
8 required by subdivision (4) of section 49-702 and section 49-704,
9 except that transfers may be made from the fund to the General Fund
10 at the direction of the Legislature. Any money in the Nebraska
11 Statutes Cash Fund available for investment shall be invested by the
12 state investment officer pursuant to the Nebraska Capital Expansion
13 Act and the Nebraska State Funds Investment Act.

14 The Nebraska Statutes Distribution Cash Fund is created.
15 The fund shall consist of funds received pursuant to section 49-707.
16 The fund shall be used by the Supreme Court to perform the duties
17 required by such section. Any money in the fund available for
18 investment shall be invested by the state investment officer pursuant
19 to the Nebraska Capital Expansion Act and the Nebraska State Funds
20 Investment Act.

21 Sec. 3. Original section 49-707, Reissue Revised Statutes
22 of Nebraska, is repealed.
