A BILL

1 FOR AN ACT relating to secured transactions; to amend section 9-530,  
2 Uniform Commercial Code, Reissue Revised Statutes of  
3 Nebraska; to change provisions relating to filing  
4 information; and to repeal the original section.  
5 Be it enacted by the people of the State of Nebraska,

1                   Section 1. Section 9-530, Uniform Commercial Code,  
2 Reissue Revised Statutes of Nebraska, is amended to read:

3                   9-530 Filing information; Secretary of State; duties.

4                   (a) Upon receipt of a financing statement relating to any  
5 collateral except collateral described in section 9-501(a)(1), the  
6 Secretary of State shall on the day of receipt enter into the  
7 centralized computer system the following document information:

8                   (1) Identification of the document and the fact that the  
9 original document was filed with the Secretary of State;

10                   (2) Document number;

11                   (3) Name and address of the obligor or obligors;

12                   (4) Name and address of the secured party or secured  
13 parties;

14                   (5) Type or types of goods or property covered; and

15                   (6) Date and time of filing. ~~; and~~

16                   ~~(7) Social security number or federal tax identification~~  
17 ~~number of the obligor or obligors, if available.~~

18                   (b)(1) Upon receipt of a notice of lien upon real  
19 property or a certificate or a notice affecting the lien presented  
20 for filing pursuant to the Uniform Federal Lien Registration Act or a  
21 notice of lien upon real property, release, continuation,  
22 subordination, or termination presented for filing pursuant to the  
23 Uniform State Tax Lien Registration and Enforcement Act, the  
24 Secretary of State shall on the date of receipt enter into the  
25 centralized computer system the following document information:

1           (i) Identification of the document and any county  
2 designated as a county in which the real property is situated;

3           (ii) Document number;

4           (iii) Type or types of property covered; and

5           (iv) The information entered pursuant to section 52-1003  
6 or 77-3903, Reissue Revised Statutes of Nebraska.

7           (2) Upon receipt of a notice of lien upon personal  
8 property or a certificate or a notice affecting the lien filed  
9 pursuant to the Uniform Federal Lien Registration Act or a notice of  
10 lien upon personal property, release, continuation, subordination, or  
11 termination filed pursuant to the Uniform State Tax Lien Registration  
12 and Enforcement Act, the Secretary of State shall on the date of  
13 receipt enter into the centralized computer system the following  
14 document information:

15           (i) Identification of the document;

16           (ii) Document number;

17           (iii) Type or types of property covered; and

18           (iv) The information entered pursuant to section 52-1003  
19 or 77-3903, Reissue Revised Statutes of Nebraska.

20           (c) The Secretary of State shall maintain the information  
21 received under subsections (a) and (b) of this section so that such  
22 information shall be available for the following types of inquiry: In  
23 person, written, ~~and telephone~~ and other electronic media, including  
24 computers.
