## Introduced by Ashford

(1) The Legislature finds that while serious 4 crime in the State of Nebraska has not increased in the past five 5 years, the prison population continues to increase as does the 6 amount spent on correctional issues. The Legislature further finds 7 that a need exists to closely examine the criminal justice system 8 of the State of Nebraska in order to increase public safety while 9 concurrently reducing correctional spending and reinvesting in 10 strategies that decrease crime and strengthen Nebraska communities. 11 (2) The State of Nebraska shall work cooperatively with 12 the Council of State Governments Justice Center to study and 13 identify innovative solutions and evidence-based practices to 14 develop a data-driven approach to reduce correctional spending 15 and reinvest savings in strategies that can decrease recidivism and 16 increase public safety. Governments Justice Center in this process and to ensure that the 1 2 report required by subsection (6) of this section is delivered. 3 Upon delivery of the report, the working group shall be dissolved 4 and discharged of any further duties. 5 (4) The working group shall be comprised of four members 6 selected by the Governor, four members selected by the Speaker 7 of the Legislature, four members selected by the Chief Justice of 8 the Supreme Court, and four representatives of local governments 9 selected jointly by the Governor, the Speaker of the Legislature, 10 and the Chief Justice.
