Speakers were hired to elaborate upon the message delivered to students via group and individual counseling sessions. REAP monies were used to "level the playing field" and purchase additional laptops and i-pads for elementary classrooms that had the highest percentage of students needing intervention.

Our district partners with parents and students through parent-teacher-student conferences, parent-administrative-student conferences, Board of Education interaction, district advisory groups, and individual contacts. The district mission statement requires a focus on partnerships related to academics, behavior and civic engagement. These elements were given a high priority. The elementary and middle school, with our highest percentage of poverty students, received a higher percentage of funds. All buildings received funds to address their academic, behavioral and civic engagement needs. Research based programs were reviewed and selected to meet the needs of students in poverty. Professional development and curriculum support was designed to address issues of poverty.

We use a comprehensive approach to supporting students in poverty. Students are effectively supported because the district uses partnerships to review data and address academics, behavior and civic engagement needs,. PK-12 and grade level professional learning communities continually review academic data as well as data related to behavior. It is the intent of LPS to enhance the math and science achievement and offerings in the secondary school while maintaining class sections of less than 25 students. We also recognize the need for students in poverty to be in small classes, and to have extra-curricular activities and opportunities such as music, art, physical education and counseling, therefore we have allocated the funds to insure students have access to non-academic classes, we believe in the holistic approach to educating students, and believe our students will be more successful with a well rounded education. Therefore, we have allocated funds to insure all of our students have these opportunities. Also, through funding these positions, we are able to significantly reduce class size.

There is no specific method for allocating funds within the Poverty Program. With a significant number of our students being poverty students (61%) the funds are allocated within the program to meet the needs of all students. We do not have targeted poverty programs, we believe in the whole school approach and allocate funds within the program that will meet the needs of all students, therefore the needs of the poverty students are met. Growth for poverty students can best be obtained by developing programs that allows the students to be educated in a program where all children are involved, therefore the poverty students have a more enriching experience by learning along side more privileged students.

One of the most effective programs we have, is maybe the simplest one, providing transportation for our poverty students. We have many students who would not have the opportunity to participate in extra-curricular activities if we did not allocated funding to provide transportation for those students. The NCLB Consolidated Application requires that Title I money be allocated for specific uses such as salaries, benefits, staff development, purchase of equipment, etc. Since we have a non-public school within our district boundaries we also allocate funds, based upon the percentage of contact time, to offer Title I services to the non-public school students requiring extra help. The REAP funds are very flexible in their use and do not require a formal application or budgeting process. General Fund money is budgeted to support what we call our "Advantage Program", which is an after school program to help students that are struggling academically. This program is provided for students in both our elementary and secondary buildings.

Within the Title I-Part A program money is budgeted to cover salaries, benefits and staff development activities for Title I staff and also for purchasing supplies to be used within the Title I program. Title II monies have, in the past, been transferred into the Title V program and used to support technology and safety issues for all students throughout the district. Future Title II monies will be used to hire an additional teacher to support class size reduction. REAP funds are used primarily to support the purchase of computers and iPads, improve the technology infrastructure within all of our buildings, and to purchase security cameras to improve student safety within our buildings. General Fund monies are used to further support the previously mentioned programs and to entirely support our after school program.

Our school-wide Title I program for grades K-6 offers students with the greatest academic needs in the areas of reading and mathematics opportunities for small group instruction. Our Title I staff also goes into individual classrooms and provides support to all students. Money spent through the Title II (Title V) program and the REAP grant has been used to purchase technology to provide additional learning opportunities to all students. Also, these monies have been used to purchase security cameras and a security door lock system to improve the safety and security of our students. Staff members are paid to sponsor and provide tutoring to students as part of our after school Advantage Program. This program is not specifically designed for poverty students, although students of poverty are statistically the students in most need of such a program. Many times students, especially at the elementary level, stay and do homework so they do not have to go home to an empty house.
