Re: Developmental Disabilities Court-Ordered Custody Act Report

Dear Mr. O'Donnell,

Per Neb. Rev. Stat. §71-1134, the Division of Developmental Disabilities is submitting this communication as its third annual Developmental Disabilities Court-Ordered Custody Act (DDCOCA) report. While the DDCOCA was created in 2005, the Act was first utilized during the 2009-10 fiscal year.

When an individual has been adjudicated as a person “in need of court-ordered custody and treatment” under the DDCOCA, the Department of Health and Human Services is required to “evaluate” the individual and develop “a plan for custody and treatment...in the least restrictive alternative.” If the court approves the plan, such custody and treatment will continue until an annual review hearing before the same court, where the plan may be continued, revised or discontinued, depending on the circumstances.

During the 2013-2014 fiscal year, \$1,444,142.04 was spent to provide evaluations and/or services to individuals affected by the Developmental Disabilities Court Ordered Custody Act actions. A summary of the cases is as follows:
