A BILL

1 FOR AN ACT relating to motor vehicles; to amend sections 60-3,123 and  
2 60-3,125, Reissue Revised Statutes of Nebraska, sections  
3 60-301, 60-393, 60-395, 60-396, and 60-3,104, Revised  
4 Statutes Cumulative Supplement, 2012, and sections  
5 60-3,130.04 and 80-414, Revised Statutes Supplement,  
6 2013; to provide for Military Honor Plates; to change fee  
7 provisions relating to prisoner-of-war and Purple Heart  
8 license plates; to harmonize provisions; and to repeal  
9 the original sections.

10 Be it enacted by the people of the State of Nebraska,

1           Section 1. Section 60-301, Revised Statutes Cumulative  
2 Supplement, 2012, is amended to read:

3           60-301 Sections 60-301 to 60-3,222 and sections 9 and 10  
4 of this act shall be known and may be cited as the Motor Vehicle  
5 Registration Act.

6           Sec. 2. Section 60-393, Revised Statutes Cumulative  
7 Supplement, 2012, is amended to read:

8           60-393 Any owner who has two or more motor vehicles or  
9 trailers required to be registered under the Motor Vehicle  
10 Registration Act may register all such motor vehicles or trailers on  
11 a calendar-year basis or on an annual basis for the same registration  
12 period beginning in a month chosen by the owner. When electing to  
13 establish the same registration period for all such motor vehicles or  
14 trailers, the owner shall pay the registration fee, the motor vehicle  
15 tax imposed in section 60-3,185, the motor vehicle fee imposed in  
16 section 60-3,190, and the alternative fuel fee imposed in section  
17 60-3,191 on each motor vehicle for the number of months necessary to  
18 extend its current registration period to the registration period  
19 under which all such motor vehicles or trailers will be registered.  
20 Credit shall be given for registration paid on each motor vehicle or  
21 trailer when the motor vehicle or trailer has a later expiration date  
22 than that chosen by the owner except as otherwise provided in  
23 sections 60-3,121, 60-3,122.02, and 60-3,128 and section 10 of this  
24 act. Thereafter all such motor vehicles or trailers shall be  
25 registered on an annual basis starting in the month chosen by the

1 owner.

2           Sec. 3. Section 60-395, Revised Statutes Cumulative  
3 Supplement, 2012, is amended to read:

4           60-395 (1) Except as otherwise provided in subsection (2)  
5 of this section and sections 60-3,121, 60-3,122.02, and 60-3,128 and  
6 section 10 of this act, the registration shall expire and the  
7 registered owner or lessee may, by returning the registration  
8 certificate, the license plates, and, when appropriate, the  
9 validation decals and by either making application on a form  
10 prescribed by the department to the county treasurer of the  
11 occurrence of an event described in subdivisions (a) through (e) of  
12 this subsection or, in the case of a change in situs, displaying to  
13 the county treasurer the registration certificate of such other state  
14 as evidence of a change in situs, receive a refund of that part of  
15 the unused fees and taxes on motor vehicles or trailers based on the  
16 number of unexpired months remaining in the registration period from  
17 the date of any of the following events:

18           (a) Upon transfer of ownership of any motor vehicle or  
19 trailer;

20           (b) In case of loss of possession because of fire, theft,  
21 dismantlement, or junking;

22           (c) When a salvage branded certificate of title is  
23 issued;

24           (d) Whenever a type or class of motor vehicle or trailer  
25 previously registered is subsequently declared by legislative act or

1 court decision to be illegal or ineligible to be operated or towed on  
2 the public roads and no longer subject to registration fees, the  
3 motor vehicle tax imposed in section 60-3,185, the motor vehicle fee  
4 imposed in section 60-3,190, and the alternative fuel fee imposed in  
5 section 60-3,191;

6 (e) Upon a trade-in or surrender of a motor vehicle under  
7 a lease; or

8 (f) In case of a change in the situs of a motor vehicle  
9 or trailer to a location outside of this state.

10 (2) If the date of the event falls within the same  
11 calendar month in which the motor vehicle or trailer is acquired, no  
12 refund shall be allowed for such month.

13 (3) If the transferor or lessee acquires another motor  
14 vehicle at the time of the transfer, trade-in, or surrender, the  
15 transferor or lessee shall have the credit provided for in this  
16 section applied toward payment of the motor vehicle fees and taxes  
17 then owing. Otherwise, the transferor or lessee shall file a claim  
18 for refund with the county treasurer upon an application form  
19 prescribed by the department.

20 (4) The registered owner or lessee shall make a claim for  
21 refund or credit of the fees and taxes for the unexpired months in  
22 the registration period within sixty days after the date of the event  
23 or shall be deemed to have forfeited his or her right to such refund  
24 or credit.

25 (5) For purposes of this section, the date of the event

1 shall be: (a) In the case of a transfer or loss, the date of the  
2 transfer or loss; (b) in the case of a change in the situs, the date  
3 of registration in another state; (c) in the case of a trade-in or  
4 surrender under a lease, the date of trade-in or surrender; (d) in  
5 the case of a legislative act, the effective date of the act; and (e)  
6 in the case of a court decision, the date the decision is rendered.

7 (6) Application for registration or for reassignment of  
8 license plates and, when appropriate, validation decals to another  
9 motor vehicle or trailer shall be made within thirty days of the date  
10 of purchase.

11 (7) If a motor vehicle or trailer was reported stolen  
12 under section 60-178, a refund under this section shall not be  
13 reduced for a lost plate charge and a credit under this section may  
14 be reduced for a lost plate charge but the applicant shall not be  
15 required to pay the plate fee for new plates.

16 (8) The county treasurer shall refund the motor vehicle  
17 fee and registration fee from the fees which have not been  
18 transferred to the State Treasurer. The county treasurer shall make  
19 payment to the claimant from the undistributed motor vehicle taxes of  
20 the taxing unit where the tax money was originally distributed. No  
21 refund of less than two dollars shall be paid.

22 Sec. 4. Section 60-396, Revised Statutes Cumulative  
23 Supplement, 2012, is amended to read:

24 60-396 Whenever the registered owner files an application  
25 with the county treasurer showing that a motor vehicle or trailer is

1 disabled and has been removed from service, the registered owner may,  
2 by returning the registration certificate, the license plates, and,  
3 when appropriate, the validation decals or, in the case of the  
4 unavailability of such registration certificate or certificates,  
5 license plates, or validation decals, then by making an affidavit to  
6 the county treasurer of such disablement and removal from service,  
7 receive a credit for a portion of the registration fee from the fee  
8 deposited with the State Treasurer at the time of registration based  
9 upon the number of unexpired months remaining in the registration  
10 year except as otherwise provided in sections 60-3,121, 60-3,122.02,  
11 and 60-3,128 and section 10 of this act. The owner shall also receive  
12 a credit for the unused portion of the motor vehicle tax and fee  
13 based upon the number of unexpired months remaining in the  
14 registration year. When the owner registers a replacement motor  
15 vehicle or trailer at the time of filing such affidavit, the credit  
16 may be immediately applied against the registration fee and the motor  
17 vehicle tax and fee for the replacement motor vehicle or trailer.  
18 When no such replacement motor vehicle or trailer is so registered,  
19 the county treasurer shall forward the application and affidavit, if  
20 any, to the State Treasurer who shall determine the amount, if any,  
21 of the allowable credit for the registration fee and issue a credit  
22 certificate to the owner. For the motor vehicle tax and fee, the  
23 county treasurer shall determine the amount, if any, of the allowable  
24 credit and issue a credit certificate to the owner. When such motor  
25 vehicle or trailer is removed from service within the same month in

1 which it was registered, no credits shall be allowed for such month.  
2 The credits may be applied against taxes and fees for new or  
3 replacement motor vehicles or trailers incurred within one year after  
4 cancellation of registration of the motor vehicle or trailer for  
5 which the credits were allowed. When any such motor vehicle or  
6 trailer is reregistered within the same registration year in which  
7 its registration has been canceled, the taxes and fees shall be that  
8 portion of the registration fee and the motor vehicle tax and fee for  
9 the remainder of the registration year.

5           Sec. 6. Section 60-3,123, Reissue Revised Statutes of  
6 Nebraska, is amended to read:

7           60-3,123 (1) Any person who was captured and incarcerated  
8 by an enemy of the United States during a period of conflict with  
9 such enemy and who was discharged or otherwise separated with a  
10 characterization of honorable from or is currently serving in the  
11 United States Armed Forces may, in addition to the application  
12 required in section 60-385, apply to the department for license  
13 plates designed to indicate that he or she is a former prisoner of  
14 war.

15           (2) The license plates shall be issued upon the applicant  
16 paying the regular license fee ~~and an additional fee of five dollars~~  
17 and furnishing proof satisfactory to the department that the  
18 applicant was formerly a prisoner of war. ~~The additional fee shall be~~  
19 ~~remitted to the State Treasurer for credit to the Nebraska Veteran~~  
20 ~~Cemetery System Operation Fund.~~ Any number of motor vehicles,  
21 trailers, semitrailers, or cabin trailers owned by the applicant may  
22 be so licensed at any one time. Motor vehicles and trailers  
23 registered under section 60-3,198 shall not be so licensed.

25 lost, stolen, or mutilated, the recipient of the license plates shall

1 be issued replacement license plates upon request and without charge.

2           Sec. 7. Section 60-3,125, Reissue Revised Statutes of  
3 Nebraska, is amended to read:

4           60-3,125 (1) Any person may, in addition to the  
5 application required by section 60-385, apply to the department for  
6 license plates designed by the department to indicate that the  
7 applicant has received from the federal government an award of a  
8 Purple Heart. The inscription of the plates shall be designed so as  
9 to include a facsimile of the award and beneath any numerical  
10 designation upon the plates pursuant to section 60-370 the words  
11 Purple Heart separately on one line and the words Combat Wounded on  
12 the line below.

13           (2) The license plates shall be issued upon payment of  
14 the regular license fee ~~and an additional fee of five dollars and~~  
15 furnishing proof satisfactory to the department that the applicant  
16 was awarded the Purple Heart. ~~The additional fee shall be remitted to~~  
17 ~~the State Treasurer for credit to the Nebraska Veteran Cemetery~~  
18 ~~System Operation Fund.~~ Any number of motor vehicles, trailers,  
19 semitrailers, or cabin trailers owned by the applicant may be so  
20 licensed at any one time. Motor vehicles and trailers registered  
21 under section 60-3,198 shall not be so licensed.

22           (3) If license plates issued pursuant to this section are  
23 lost, stolen, or mutilated, the recipient of the plates shall be  
24 issued replacement license plates upon request and without charge.

25           Sec. 8. Section 60-3,130.04, Revised Statutes Supplement,

1 2013, is amended to read:

2           60-3,130.04 (1) An owner of a historical vehicle eligible  
3 for registration under section 60-3,130 may use a license plate or  
4 plates designed by this state in the year corresponding to the model  
5 year when the vehicle was manufactured in lieu of the plates designed  
6 pursuant to section 60-3,130.03 subject to the approval of the  
7 department. The department shall inspect the plate or plates and may  
8 approve the plate or plates if it is determined that the model-year  
9 license plate or plates are legible and serviceable and that the  
10 license plate numbers do not conflict with or duplicate other numbers  
11 assigned and in use. An original-issued license plate or plates that  
12 have been restored to original condition may be used when approved by  
13 the department.

14           (2) The department may consult with a recognized car club  
15 in determining whether the year of the license plate or plates to be  
16 used corresponds to the model year when the vehicle was manufactured.

17           (3) If only one license plate is used on the vehicle, the  
18 license plate shall be placed on the rear of the vehicle. The owner  
19 of a historical vehicle may use only one plate on the vehicle even  
20 for years in which two license plates were issued for vehicles in  
21 general.

22           (4) License plates used pursuant to this section  
23 corresponding to the year of manufacture of the vehicle shall not be  
24 personalized message license plates, Pearl Harbor license plates,  
25 prisoner-of-war license plates, disabled veteran license plates,

1 Purple Heart license plates, amateur radio station license plates,  
2 Nebraska Cornhusker Spirit Plates, handicapped or disabled person  
3 license plates, specialty license plates, ~~or~~ special interest motor  
4 vehicle license plates, or Military Honor Plates.

5           Sec. 9. (1) The department shall design license plates to  
6 be known as Military Honor Plates. The department shall create  
7 designs honoring persons who have served or are serving in the United  
8 States Army, United States Navy, United States Marine Corps, United  
9 States Coast Guard, United States Air Force, or National Guard. There  
10 shall be six designs, one for each of such armed forces reflecting  
11 its official emblem, official seal, or other official image. The  
12 issuance of plates for each of such armed forces shall be conditioned  
13 on the approval of the armed forces owning the copyright to the  
14 official emblem, official seal, or other official image. A person may  
15 qualify for a Military Honor Plate by registering with the Department  
16 of Veterans' Affairs pursuant to section 80-414. The Department of  
17 Motor Vehicles shall verify the applicant's eligibility for a plate  
18 created pursuant to this section by consulting the registry  
19 established by the Department of Veterans' Affairs.

20           (2) The design shall be selected on the basis of limiting  
21 the manufacturing cost of each plate to an amount less than or equal  
22 to the amount charged for license plates pursuant to section  
23 60-3,102. The Department of Motor Vehicles shall make applications  
24 available for each type of plate when it is designed. The department  
25 may adopt and promulgate rules and regulations to carry out this

1 section and section 10 of this act.

2 (3) One type of Military Honor Plates shall be  
3 alphanumeric plates. The department shall:

4 (a) Assign a designation up to five characters; and

5 (b) Not use a county designation.

6 (4) One type of Military Honor Plates shall be  
7 personalized message plates. Such plates shall be issued subject to  
8 the same conditions specified for personalized message license plates  
9 in section 60-3,118, except that a maximum of five characters may be  
10 used.

11 Sec. 10. (1) Beginning January 2, 2016, an eligible  
12 person may apply to the department for Military Honor Plates in lieu  
13 of regular license plates on an application prescribed and provided  
14 by the department for any motor vehicle, trailer, semitrailer, or  
15 cabin trailer, except for a motor vehicle or trailer registered under  
16 section 60-3,198. An applicant receiving a Military Honor Plate for a  
17 farm truck with a gross weight of over sixteen tons shall affix the  
18 appropriate tonnage decal to the plate. The department shall make  
19 forms available for such applications through the county treasurers.  
20 The license plates shall be issued upon payment of the license fee  
21 described in subsection (2) of this section and verification by the  
22 department of an applicant's eligibility using the registry  
23 established by the Department of Veterans' Affairs pursuant to  
24 section 80-414. To be eligible an applicant shall be (a) active duty  
25 armed forces personnel serving in any of the armed forces listed in

1 subsection (1) of section 9 of this act or (b) a veteran of any of  
2 such armed forces who was discharged or otherwise separated with a  
3 characterization of honorable or general (under honorable  
4 conditions). Any person using Military Honor Plates shall surrender  
5 the plates to the county treasurer if such person is no longer  
6 eligible for the plates. Regular plates shall be issued to any such  
7 person upon surrender of the Military Honor Plates for a three-dollar  
8 transfer fee and forfeiture of any of the remaining annual fee. The  
9 three-dollar transfer fee shall be remitted to the State Treasurer  
10 for credit to the Department of Motor Vehicles Cash Fund.

11 (2)(a) In addition to all other fees required for  
12 registration under the Motor Vehicle Registration Act, each  
13 application for initial issuance or renewal of alphanumeric Military  
14 Honor Plates shall be accompanied by a fee of five dollars. County  
15 treasurers collecting fees pursuant to this subdivision shall remit  
16 them to the State Treasurer. The State Treasurer shall credit five  
17 dollars of the fee to the Nebraska Veteran Cemetery System Operation  
18 Fund.

19 (b) In addition to all other fees required for  
20 registration under the Motor Vehicle Registration Act, each  
21 application for initial issuance or renewal of personalized message  
22 Military Honor Plates shall be accompanied by a fee of forty dollars.  
23 County treasurers collecting fees pursuant to this subdivision shall  
24 remit them to the State Treasurer. The State Treasurer shall credit  
25 twenty-five percent of the fee for initial issuance and renewal of

1 such plates to the Department of Motor Vehicles Cash Fund and  
2 seventy-five percent of the fee to the Nebraska Veteran Cemetery  
3 System Operation Fund.

4 (3) When the Department of Motor Vehicles receives an  
5 application for Military Honor Plates, the department shall deliver  
6 the plates to the county treasurer of the county in which the motor  
7 vehicle or cabin trailer is registered. The county treasurer shall  
8 issue Military Honor Plates in lieu of regular license plates when  
9 the applicant complies with the other provisions of the Motor Vehicle  
10 Registration Act for registration of the motor vehicle or cabin  
11 trailer. If Military Honor Plates are lost, stolen, or mutilated, the  
12 licensee shall be issued replacement license plates upon request  
13 pursuant to section 60-3,157.

14 (4) The owner of a motor vehicle or cabin trailer bearing  
15 Military Honor Plates may apply to the county treasurer to have such  
16 plates transferred to a motor vehicle other than the vehicle for  
17 which such plates were originally purchased if such vehicle is owned  
18 by the owner of the plates. The owner may have the unused portion of  
19 the fee for the plates credited to the other vehicle which will bear  
20 the plates at the rate of eight and one-third percent per month for  
21 each full month left in the registration period. Application for such  
22 transfer shall be accompanied by a fee of three dollars. Fees  
23 collected pursuant to this subsection shall be remitted to the State  
24 Treasurer for credit to the Department of Motor Vehicles Cash Fund.

25 (5) If the cost of manufacturing Military Honor Plates at

1 any time exceeds the amount charged for license plates pursuant to  
2 section 60-3,102, any money to be credited to the Nebraska Veteran  
3 Cemetery System Operation Fund shall instead be credited first to the  
4 Highway Trust Fund in an amount equal to the difference between the  
5 manufacturing costs of Military Honor Plates and the amount charged  
6 pursuant to section 60-3,102 with respect to such plates and the  
7 remainder shall be credited to the Nebraska Veteran Cemetery System  
8 Operation Fund.

9 (6) If the director discovers evidence of fraud in an  
10 application for Military Honor Plates or that the holder is no longer  
11 eligible to have Military Honor Plates, the director may summarily  
12 cancel the plates and registration and send notice of the  
13 cancellation to the holder of the license plates.

14 Sec. 11. Section 80-414, Revised Statutes Supplement,  
15 2013, is amended to read:

16 80-414 (1) The Department of Veterans' Affairs shall  
17 create and maintain a registry of residents of Nebraska who meet the  
18 requirements of subdivision (1)(a) or (b) of section 10 of this act  
19 or subsection (1) of section 60-4,189. The Department of Veterans'  
20 Affairs may adopt and promulgate rules and regulations governing the  
21 establishment and maintenance of the registry. The registry may be  
22 used to assist the department in carrying out the duties of the  
23 department and shall provide for the collection of sufficient  
24 information to identify an individual who qualifies for Military  
25 Honor Plates or a notation of "veteran" on his or her operator's

1 license or state identification card issued by the Department of  
2 Motor Vehicles. The registry may include information such as  
3 identifying information on an individual, an individual's records on  
4 active duty in the armed forces of the United States, or an  
5 individual's status of active duty, retired, discharged, or other.

6 (2) Any resident of Nebraska who meets the requirements  
7 of subdivision (1)(a) or (b) of section 10 of this act or subsection  
8 (1) of section 60-4,189 shall register with the Department of  
9 Veterans' Affairs using the registry created by this section before  
10 being eligible for Military Honor Plates or a notation of "veteran"  
11 on his or her operator's license or state identification card issued  
12 by the Department of Motor Vehicles. No person shall be deemed  
13 eligible until his or her status has been verified on the registry.

14 (3) The Department of Motor Vehicles may adopt and  
15 promulgate rules and regulations governing use of the registry of the  
16 Department of Veterans' Affairs for determination of eligibility for  
17 the issuance of Military Honor Plates or the notation of "veteran" on  
18 operators' licenses and state identification cards.
