FOR AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 507, One Hundred Third Legislature, First Session, 2013; and to declare an emergency.

1 Section 1. There is hereby appropriated (1) \$313,467 from

- 2 the General Fund for FY2013-14 and (2) \$1,179,046 from the General
- 3 Fund for FY2014-15 to the State Department of Education, for Program
- 4 25, to aid in carrying out the provisions of Legislative Bill 507,
- 5 One Hundred Third Legislature, First Session, 2013.
- 6 Total expenditures for permanent and temporary salaries
- 7 and per diems from funds appropriated in this section shall not
- 8 <u>exceed \$107,461 for FY2013-14 or \$282,618 for FY2014-15.</u>
- 9 Sec. 2. There is hereby appropriated (1) \$50,460 from the
- 10 General Fund and \$9,612 from federal funds for FY2013-14 and (2)
- 11 \$100,921 from the General Fund and \$19,223 from federal funds for
- 12 FY2014-15 to the Department of Health and Human Services, for Program
- 13 33, to aid in carrying out the provisions of Legislative Bill 507,
- 14 One Hundred Third Legislature, First Session, 2013.
- 15 <u>Total expenditures for permanent and temporary salaries</u>
- 16 and per diems from funds appropriated in this section shall not
- 17 <u>exceed \$28,992 for FY2013-14 or \$57,984 for FY2014-15.</u>
- 18 Sec. 3. There is hereby appropriated \$126,700 from the
- 19 General Fund for FY2014-15 to the State Department of Education, for
- 20 Program 158, to aid in carrying out the provisions of Legislative
- 21 Bill 507, One Hundred Third Legislature, First Session, 2013.
- 22 There is included in the amount shown for this program
- 23 \$100,000 General Funds provided as state aid for FY2014-15 for
- 24 scholarships for early childhood education providers.
- 25 There is included in the amount shown for this program

- 1 \$26,700 General Funds provided as state aid for FY2014-15 for
- 2 incentive bonuses for providers of child care and early childhood
- 3 <u>education programs</u>.
- 4 Sec. 4. There is hereby appropriated (1) \$857,077 from
- 5 the General Fund for FY2013-14 and (2) \$1,714,153 from the General
- 6 Fund for FY2014-15 to the Department of Health and Human Services,
- 7 for Program 347, to aid in carrying out the provisions of Legislative
- 8 Bill 507, One Hundred Third Legislature, First Session, 2013.
- 9 There is included in the amount shown for this program
- 10 \$857,077 General Funds provided as state aid for FY2013-14 and
- 11 \$1,714,153 General Funds provided as state aid for FY2014-15 for aid
- 12 <u>for the Child Care Subsidy Program.</u>
- Sec. 5. Since an emergency exists, this act takes effect
- 14 when passed and approved according to law.
