- 4 for FY2014-15 to the Department of Health and Human Services, for
- 5 Program 33, to aid in carrying out the provisions of Legislative Bill
- 6 <u>216, One Hundred Third Legislature, First Session, 2013.</u>
- 7 Total expenditures for permanent and temporary salaries
- 8 and per diems from funds appropriated in this section shall not
- 9 <u>exceed \$326,374 for FY2013-14 or \$665,802 for FY2014-15.</u>
- 10 Sec. 2. There is hereby appropriated (1) \$143,300 from
- 11 the General Fund and \$398,597 from federal funds for FY2013-14 and
- 12 (2) \$305,546 from the General Fund and \$807,361 from federal funds
- 13 for FY2014-15 to the Department of Health and Human Services, for
- 14 Program 347, to aid in carrying out the provisions of Legislative
- 15 Bill 216, One Hundred Third Legislature, First Session, 2013.
- 16 No expenditures for permanent and temporary salaries and
- 17 per diems for state employees shall be made from funds appropriated
- 18 <u>in this section.</u>
- 19 Sec. 3. There is hereby appropriated \$720,000 from the
- 20 General Fund and \$880,000 from federal funds for FY2013-14 to the
- 21 Department of Health and Human Services, for Program 348, to aid in
- 22 carrying out the provisions of Legislative Bill 216, One Hundred
- 23 Third Legislature, First Session, 2013.
- No expenditures for permanent and temporary salaries and
- 25 per diems for state employees shall be made from funds appropriated

- Sec. 4. There is hereby appropriated (1) \$54,239 from the
- 3 General Fund and \$44,377 from federal funds for FY2013-14 and (2)
- 4 \$105,728 from the General Fund and \$86,504 from federal funds for
- 5 FY2014-15 to the Foster Care Review Office, for Program 116, to aid
- 6 in carrying out the provisions of Legislative Bill 216, One Hundred
- 7 Third Legislature, First Session, 2013.
- 8 Total expenditures for permanent and temporary salaries
- 9 and per diems from funds appropriated in this section shall not
- 10 <u>exceed \$50,469 for FY2013-14 or \$100,939 for FY2014-15.</u>
- 11 Sec. 5. Since an emergency exists, this act takes effect
- 12 when passed and approved according to law.
