A BILL

1 FOR AN ACT relating to agriculture; to amend sections 2-1072, 2-1074,
 2 2-1083, 2-1091, 2-1091.01, 2-1095, 2-10,102, 2-10,103,
 3 2-10,103.01, 2-10,103.02, 2-10,103.04, 2-10,104,
 4 2-10,105, 2-10,106, and 2-10,115, Reissue Revised
 5 Statutes of Nebraska; to change and eliminate provisions
 6 of the Plant Protection and Plant Pest Act; to harmonize
 7 provisions; to repeal the original sections; and to
 8 outright repeal sections 2-1075.01, 2-1077, 2-1080,
 9 2-1092, 2-1093, 2-1094, 2-1096, 2-1097, 2-1098, 2-1099,
 10 2-10,100, 2-10,100.01, 2-10,100.02, 2-10,101, and
 11 2-10,116.01, Reissue Revised Statutes of Nebraska.
 12 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-1072, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 2-1072 Sections 2-1072 to 2-10,117 and sections 3, 4, 5,
4 7, 11, and 21 of this act shall be known and may be cited as the
5 Plant Protection and Plant Pest Act.

6 Sec. 2. Section 2-1074, Reissue Revised Statutes of
7 Nebraska, is amended to read:

8 2-1074 For purposes of the Plant Protection and Plant
9 Pest Act, unless the context otherwise requires, the definitions
10 found in sections 2-1074.01 to 2-1089 and sections 3, 4, 5, and 7 of
11 this act shall be used.

12 Sec. 3. Certification inspection of Nebraska-grown
13 nursery stock shall mean an inspection performed pursuant to section
14 2-1095.

15 Sec. 4. Grow shall mean to produce a plant or plant
16 product, by propagation or cultivation, including, but not limited
17 to, division, transplant, seed, or cutting, generally over a period
18 of one year or greater. Grow does not include transferring nursery
19 stock from one container to another or potting bare-root nursery
20 stock, if the stock will be distributed within twelve months.

21 Sec. 5. Harmonization plan shall mean any agreement
22 between states, or a state or states and the federal government,
23 designed to limit the spread of a plant pest into or out of a
24 designated area.

25 Sec. 6. Section 2-1083, Reissue Revised Statutes of

1 Nebraska, is amended to read:

2 2-1083 Nursery stock shall mean ~~all field grown or~~
3 ~~container grown perennial plants, including, but not limited to,~~
4 ~~vegetative or propagative parts or perennial plants dug from the~~
5 ~~wild, so labeled, and distributed, and excluding, among other things,~~
6 ~~greenhouse plants grown for indoor use, annual plants, biennial~~
7 ~~plants, florist stock, cut flowers, sod, turf, onions, or potatoes,~~
8 ~~or seeds of any such plant. all botanically classified hardy~~
9 ~~perennial or biennial plants, trees, shrubs, and vines, either~~
10 ~~domesticated or wild, cuttings, grafts, scions, buds, bulbs,~~
11 ~~rhizomes, or roots thereof, and such plants and plant parts for, or~~
12 ~~capable of, propagation, excluding plants grown for indoor use,~~
13 ~~annual plants, florist stock, cut flowers, sod, turf, onions,~~
14 ~~potatoes, or seeds of any such plant.~~

15 Sec. 7. Nursery stock distributor shall mean any person
16 involved in:

17 (1) The acquisition and further distribution of nursery
18 stock;

19 (2) The utilization of nursery stock for landscaping or
20 purchase of nursery stock for other persons;

21 (3) The distribution of nursery stock with a mechanical
22 digger, commonly known as a tree spade, or by other means;

23 (4) The solicitation of or taking orders for sales of
24 nursery stock in the state; or

25 (5) The growing and distribution of nursery stock or

1 active involvement in the management or supervision of a nursery.

2 Sec. 8. Section 2-1091, Reissue Revised Statutes of
3 Nebraska, is amended to read:

4 2-1091 For the purpose of enforcement of the Plant
5 Protection and Plant Pest Act or any rule or regulation, the
6 department may:

7 (1) Enter ~~and inspect~~ at reasonable times and in a
8 reasonable manner without being subject to any action for trespass or
9 damages, if reasonable care is exercised, all property where plants
10 are grown, packed, held prior to distribution, or distributed ~~and to~~
11 inspect all plants, structures, vehicles, equipment, packing
12 materials, containers, records, and labels on such property. The
13 department may inspect and examine all records and property relating
14 to compliance with the act. Such records and property shall be made
15 available to the department for review at all reasonable times;

16 (2) In a reasonable manner, hold for inspection and take
17 samples of any plants and associated materials which may not be in
18 compliance with the act;

19 (3) Inspect or reinspect at any time or place any plants
20 that are in the state or being shipped into or through the state and
21 treat, seize, destroy, require treatment or destruction of, or return
22 to the state of origin any plants in order to inhibit or prevent the
23 movement of plant pests throughout the state;

24 (4) Obtain an inspection warrant in the manner prescribed
25 in sections 29-830 to 29-835 from a court of record if any person

1 refuses to allow the department to inspect pursuant to this section;

2 (5) Issue a written or printed withdrawal-from-
3 distribution order and post signs to delineate sections not marked
4 pursuant to ~~subdivision (6)~~ subsection (4) of section ~~2-1092~~ 2-1095
5 or sections of distribution locations and to notify persons of any
6 withdrawal-from-distribution order when the department has reasonable
7 cause to believe any lot of nursery stock is being distributed in
8 violation of the act or any rule or regulation;

9 (6) Apply for a restraining order, a temporary or
10 permanent injunction, or a mandatory injunction against any person
11 violating or threatening to violate the act or the rules and
12 regulations. The district court of the county where the violation is
13 occurring or is about to occur shall have jurisdiction to grant such
14 relief upon good cause shown. Relief may be granted notwithstanding
15 the existence of any other remedy at law and shall be granted without
16 bond;

17 (7) Issue a quarantine or establish a quarantine area;

18 (8) Cooperate and enter into agreements, including
19 harmonization plans, with any person in order to carry out the
20 purpose of the act;

21 (9) Establish a restricted plant pest list to prohibit
22 the movement into the state of plant pests not known to occur in
23 Nebraska and to prohibit the movement of those plant pests present in
24 the state but known to be destructive to the plant industry;

25 (10) Issue European corn borer quarantine certificates,

1 phytosanitary certificates, and export certificates on plants for
2 individual shipment to other states or foreign countries if those
3 plants comply with the requirements or regulations of such state or
4 foreign country or issue quarantine compliance agreements or European
5 corn borer quarantine certification licenses;

6 (11) Inspect plants that any person desires to ship into
7 another state or country when such person has made an application to
8 the department for such inspection. The inspection shall determine
9 the presence of plant pests to determine the acceptance of the plants
10 into other states or countries. The department may accept the
11 inspections of laboratories authorized by the department or field
12 inspectors of the department;

13 (12) Certify plants or property to meet the requirements
14 of specific quarantines imposed on Nebraska or Nebraska plants. The
15 quarantine certification requirements shall be set forth in the rules
16 and regulations;

17 (13) ~~Assess~~ Until increased or decreased by rules or
18 regulations, assess and collect charges—fees set forth in section 11
19 of this act for inspections, services, or work performed in carrying
20 out subdivisions (8) and (10) through (12) of this section. Such
21 charges shall not exceed the actual cost of accomplishing such work.
22 Inspection time shall include the driving to and from the location of
23 the inspection in addition to the time spent conducting the
24 inspection and the mileage charge shall be for the purpose of
25 inspection. Any fee charged to the department relating to such

1 subdivisions shall be paid by the person requesting the inspection,
2 services, or work. The department may for purposes of administering
3 ~~subdivisions (10) through (12) of this section~~ such subdivisions
4 establish in rules and regulations ~~such items as charges,~~ inspection
5 requirements, standards, and issuance, renewal, or revocation of
6 licenses, certificates, or permits ~~agreements~~ necessitated by such
7 subdivisions;

8 (14) Conduct continuing survey and detection programs on
9 plant pests to monitor the population or spread of plant pests;

10 (15) Issue, place on probation, suspend, or revoke
11 licenses ~~required by~~ issued or agreements entered into pursuant to
12 the act or deny applications for such licenses or agreements pursuant
13 to the act; and

14 (16) Issue orders imposing administrative fines or cease
15 and desist orders pursuant to the act.

16 Sec. 9. Section 2-1091.01, Reissue Revised Statutes of
17 Nebraska, is amended to read:

18 2-1091.01 (1) A person shall not operate as a ~~grower, a~~
19 ~~dealer, or a collector~~ nursery stock distributor without a valid
20 license issued by the department. ~~A person licensed as a grower shall~~
21 ~~not be required to obtain a separate dealer's license.~~ Any person
22 validly licensed as a grower, a dealer, or a broker under the Plant
23 Protection and Plant Pest Act as it existed on the day before the
24 effective date of this act shall remain validly licensed until
25 December 31, 2013.

1 ~~On or after December 31, 1993, a person shall not operate~~
2 ~~as a broker without a valid license issued by the department.~~

3 (2) ~~Application~~ Each nursery stock distributor shall
4 apply for a license required by subsection (1) of this section shall
5 ~~be made to the director~~ on forms furnished by the department due on
6 January 1 for the current license year. Such application shall
7 include the full name and mailing address of the applicant, the names
8 and addresses of any partners, limited liability company members, or
9 corporate officers, the name and address of the person authorized by
10 the applicant to receive notices and orders of the department as
11 provided in the Plant Protection and Plant Pest Act, whether the
12 applicant is an individual, partnership, limited liability company,
13 corporation, or other legal entity, the location of the operation,
14 and the signature of the applicant. A person distributing greenhouse
15 plants grown for indoor use, annual plants, ~~biennial plants,~~ florist
16 stock, cut flowers, sod, turf, onions, or potatoes, or seeds of any
17 such plant, shall not be required to obtain a license but may do so
18 pursuant to section 2-10,105.

19 (3) A nursery stock distributor license shall expire on
20 December 31 of each year unless previously lapsed or revoked.

21 (4) All applications shall be accompanied by a license
22 fee for the first acre on which nursery stock is located. If the
23 nursery stock distributor does not have physical possession of
24 nursery stock, the nursery stock distributor shall pay a license fee
25 based on one acre. Additionally the applicant shall pay an acreage

1 fee for each additional acre on which nursery stock is located. The
2 fees for a nursery stock distributor are set forth in section 11 of
3 this act and may be increased or decreased by rules and regulations.
4 If the applicant has distributed nursery stock prior to applying for
5 a license, the applicant shall pay an additional administrative fee
6 as set forth in section 11 of this act.

7 (5) All nursery stock distributed by a nursery stock
8 distributor shall be only sound, healthy nursery stock that is
9 reasonably capable of growth, labeled correctly, free from injurious
10 plant pests, and stored or displayed under conditions which maintain
11 its vigor as provided in the rules and regulations. Any fee charged
12 to the department for diagnostic services or shipping costs shall be
13 paid by the nursery stock distributor.

14 (6) A valid copy of the nursery stock distributor's
15 license shall be posted in a conspicuous place at the distribution
16 location.

17 (7) A nursery stock distributor shall obtain a license
18 for each distribution location.

19 ~~(3)~~ (8) Each applicant for a nursery stock distributor
20 license shall furnish a signed written statement that such person
21 will acquire and distribute only nursery stock which has been
22 distributed by a person who is duly licensed pursuant to the act or
23 approved by an authorizing agency within the state of origin
24 recognized by the department.

25 ~~(4)~~ (9) Every licensee—nursery stock distributor shall

1 continually maintain a complete and accurate list with the department
2 of all sources from which nursery stock is ~~obtained~~, received.

3 ~~(5)-(10)~~ Each licensee-nursery stock distributor shall
4 keep and make available for examination by the department for a
5 period of three years an accurate record of all transactions
6 conducted in the ordinary course of business. Records pertaining to
7 such business shall at a minimum include the names of the persons
8 from which nursery stock was received, the receiving date, the amount
9 received, and the variety and place of origin of the nursery stock
10 received and all documents accompanying each shipment indicating
11 compliance with state or federal requirements and quarantines. A
12 ~~broker's records shall also include the names of the persons to which~~
13 ~~nursery stock was delivered, the delivery date, the amount delivered,~~
14 ~~and the variety and place of origin of the nursery stock delivered.~~

15 ~~(6)-(11)~~ A nursery stock distributor license shall lapse
16 automatically upon a change of ownership, and the subsequent owner
17 must obtain a new license. The nursery stock distributor license ~~of a~~
18 ~~grower, dealer, or collector~~ shall lapse automatically upon a change
19 of location, and such licensee must obtain a new license. A licensee
20 shall notify the department in writing at least thirty days prior to
21 any change in ownership, name, or address. A ~~licensee-nursery stock~~
22 distributor shall notify the department in writing before there is a
23 change of the name or address of the person authorized to receive
24 notices and orders of the department. When a ~~licensee-nursery stock~~
25 distributor permanently ceases operating, he or she shall return the

1 license to the department.

2 Sec. 10. Section 2-1095, Reissue Revised Statutes of
3 Nebraska, is amended to read:

4 2-1095 (1) All nursery stock distributors that distribute
5 any nursery stock that they grow shall apply for an additional
6 inspection for the certification of the Nebraska-grown nursery stock
7 as provided in this section. The nursery stock distributor shall
8 apply for such certification inspection of the Nebraska-grown nursery
9 stock as part of the application for the nursery stock distributor
10 license described in section 2-1091.01.

11 (2)(a) Applications for certification inspection of
12 Nebraska-grown nursery stock that are due on January 1 pursuant to
13 section 2-1091.01 and are not received prior to February 1 and
14 initial applications not received prior to beginning of distribution
15 shall be considered delinquent. Such applications shall have an
16 inspection fee of actual costs assessed to the applicant as set forth
17 in section 11 of this act. Such fees may be increased or decreased by
18 rules and regulations.

19 (b) Inspection time shall include the driving time to and
20 from the location of the inspection in addition to the time spent
21 conducting the inspection, and the mileage charge shall be for the
22 purpose of inspection.

23 (3) Each nursery stock distributor shall post signs
24 delineating sections of all growing areas. A section shall be not
25 larger than five acres.

1 (4) All growing areas within the state shall be inspected
2 by the department at least once per year for certification and
3 compliance with the act.

4 ~~(1)---(5)~~ Following the certification inspection of
5 Nebraska-grown nursery stock, the department shall provide a copy of
6 the plant inspection report to the ~~grower~~nursery stock distributor
7 specifying any area of the nursery from which nursery stock cannot be
8 distributed or any plants which may not be distributed as nursery
9 stock. When deemed necessary to maintain compliance with the purposes
10 of the Plant Protection and Plant Pest Act, the department shall
11 require the ~~grower~~nursery stock distributor to withdraw from
12 distribution any variety or amount of nursery stock. A reinspection
13 may be conducted by the department at the ~~grower's~~nursery stock
14 distributor's request and cost. The department may also reinspect to
15 determine compliance with the act. To determine the cost of any
16 reinspection, the department shall use ~~rates~~fees as outlined in
17 ~~subdivision (4) of section 2-1092.~~ subsection (2) of this section.
18 The ~~grower~~nursery stock distributor shall comply with the
19 recommendations of the department as to the treatment or destruction
20 of nursery stock.

21 ~~(2)---(6)~~ The department may require the treatment or
22 destruction of any nursery stock that is infested or infected with
23 plant pests, nonviable, damaged, or desiccated to the point of not
24 being reasonably capable of growth.

25 ~~(3)---(7)~~ Any nursery stock on which a withdrawal-from-

1 distribution order has been issued shall be released for distribution
 2 only by authorized department employees or after written permission
 3 has been obtained from the department. Each ~~grower~~nursery stock
 4 distributor shall promptly report to the department, in writing, the
 5 amount and type of plants treated or destroyed under requirements on
 6 withdrawal-from-distribution orders. The department may withhold a
 7 ~~grower's license~~ or certification of Nebraska-grown nursery stock
 8 until conditions have been met by the ~~grower~~nursery stock
 9 distributor as specified in the plant inspection report or any other
 10 order issued by the department. A ~~grower's license~~certification of
 11 Nebraska-grown stock may be issued covering portions of the nursery
 12 which are not infested or infected if the ~~grower~~nursery stock
 13 distributor agrees to treat, destroy, or remove as specified by the
 14 department those plants found to be infested or infected.

 20 shall be considered delinquent and the person owing the fee shall pay
 21 an additional administrative fee of twenty-five percent of the
 22 delinquent amount for each month it remains unpaid, not to exceed one

1 hundred percent of the original amount due. The department may waive
2 the additional administrative fee based upon the existence and extent
3 of any mitigating circumstances that have resulted in the late
4 payment of such fee. The purpose of the additional administrative fee
5 is to cover the administrative costs associated with collecting fees
6 and all money collected as an additional administrative fee shall be
7 remitted to the State Treasurer for credit to the Plant Protection
8 and Plant Pest Cash Fund.

9 Sec. 12. Section 2-10,102, Reissue Revised Statutes of
10 Nebraska, is amended to read:

11 2-10,102 Collectors shall be required to obtain a
12 ~~grower's nursery stock distributor's license~~ and shall be ~~subject to~~
13 ~~all the requirements that apply to the inspection of nursery stock.~~
14 required to apply for an additional inspection for the certification
15 of the collected nursery stock as provided in section 2-1095. All
16 collected nursery stock shall be labeled as such.

17 Sec. 13. Section 2-10,103, Reissue Revised Statutes of
18 Nebraska, is amended to read:

19 2-10,103 A ~~licensee nursery stock distributor~~ shall:

20 (1) Comply with the Plant Protection and Plant Pest Act
21 and the rules and regulations:

22 (a) In the care of nursery stock;

23 (b) In the distribution of nursery stock including
24 nursery stock that has been withdrawn from distribution;

25 (c) Regarding treatment or destruction of nursery stock

1 as required by a withdrawal-from-distribution order;

2 (d) In maintaining the nursery stock in a manner
3 accessible to the department; and

4 (e) In the payment of license fees;

5 (2) Comply with any order of the director issued pursuant
6 to the act;

7 (3) Not distribute nursery stock obtained from an

14 Nebraska, is amended to read:

15 2-10,103.01 (1) A ~~licensee~~ nursery stock distributor may
16 be placed on probation requiring such person to comply with the
17 conditions set out in an order of probation issued by the director or
18 be ordered to cease and desist from failing to comply or be ordered
19 to pay an administrative fine pursuant to section 2-10,103.02 after:

20 (a) The director determines the ~~licensee~~ nursery stock
21 distributor has not complied with section 2-10,103;

22 (b) The ~~licensee~~ nursery stock distributor is given
23 written notice to comply and written notice of the right to a hearing
24 to show cause why the specified order should not be issued; and

25 (c) The director finds that issuing the specified order

1 is appropriate based on the hearing record or the available
2 information if the hearing is waived by the ~~licensee~~ nursery stock
3 distributor.

4 (2) A ~~license~~ nursery stock distributor may be suspended
5 after:

6 (a) The director determines the ~~licensee~~ nursery stock
7 distributor has not complied with section 2-10,103;

8 (b) The ~~licensee~~ nursery stock distributor is given
9 written notice to comply and written notice of the right to a hearing
10 to show cause why the license should not be suspended; and

11 (c) The director finds that issuing an order suspending
12 the license is appropriate based on the hearing record or the
13 available information if the hearing is waived by the ~~licensee~~.
14 nursery stock distributor.

15 (3) A license may be immediately suspended and the
16 director may order the ~~licensee's~~ nursery stock distributor's
17 operation to cease prior to hearing when:

18 (a) The director determines an immediate danger to the
19 public health, safety, or welfare exists; ~~in the licensee's~~
20 ~~operation~~; and

21 (b) The ~~licensee~~ nursery stock distributor receives
22 written notice to comply and written notice of the right to a hearing
23 to show cause why the suspension should not be sustained. Within
24 fifteen days after the suspension, the ~~licensee~~ nursery stock
25 distributor may request in writing a date for a hearing and the

1 director shall consider the interests of the licensee-nursery stock
2 distributor when the director establishes the date and time of the
3 hearing, except that no hearing shall be held sooner than is
4 reasonable under the circumstances. When a licensee-nursery stock
5 distributor does not request a hearing date within such fifteen-day
6 period, the director shall establish a hearing date and notify the
7 licensee-nursery stock distributor of the date and time of such
8 hearing.

9 (4) A license may be revoked after:

10 (a) The director determines the licensee-nursery stock
11 distributor has committed serious, repeated, or multiple violations
12 of any of the requirements of section 2-10,103;

13 (b) The licensee-nursery stock distributor is given
14 written notice to comply and written notice of the right to a hearing
15 to show cause why the license should not be revoked; and

16 (c) The director finds that issuing an order revoking the
17 license is appropriate based on the hearing record or on the
18 available information if the hearing is waived by the licensee-
19 nursery stock distributor.
