A BILL

FOR AN ACT relating to health and human services; to provide duties

for the Department of Health and Human Services; to

require application for a federal grant as prescribed; to

create and provide duties for a task force; and to

declare an emergency.

Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) The Department of Health and Human

- 2 Services shall apply to the United States Department of Health and
- 3 Human Services for a grant under the State Balancing Incentive
- 4 Payments Program enacted in section 10202 of the federal Patient
- 5 Protection and Affordable Care Act. Funds from the grant shall be
- 6 used to develop a comprehensive and coordinated system of home and
- 7 community-based long-term care services. The department shall file
- 8 the grant application not later than September 1, 2014, and the
- 9 application shall meet the requirements of section 10202 of the
- 10 <u>federal Patient Protection and Affordable Care Act.</u>
- 11 (2) On or before December 1, 2014, the Department of
- 12 <u>Health and Human Services shall report to the Health and Human</u>
- 13 Services Committee of the Legislature on the status of the grant
- 14 application.
- Sec. 2. (1) The Aging Nebraskans Task Force is created.
- 16 The purpose of the task force is to develop and facilitate
- 17 implementation of a statewide strategic plan for addressing the needs
- 18 of the aging population in the state. The task force shall provide a
- 19 permanent forum for collaboration among state, local, community,
- 20 public, and private stakeholders in long-term care programs.
- 21 (2) The task force shall consist of nine members
- 22 representing the legislative, judicial, and executive branches of
- 23 government and an array of public and private stakeholders. The
- 24 <u>executive committee of the task force shall consist of:</u>
- 25 (a) The chief executive officer of the Department of

- 1 <u>Health and Human Services or his or her designee;</u>
- 2 (b) The Chief Justice of the Nebraska Supreme Court or
- 3 <u>his or her designee;</u>
- 4 (c) The chairperson of the Health and Human Services
- 5 Committee of the Legislature; and
- 6 (d) A member of the Appropriations Committee of the
- 7 <u>Legislature and a member of the Health and Human Services Committee</u>
- 8 of the Legislature, appointed by the Executive Board of the
- 9 <u>Legislative Council.</u>
- 10 The remaining four members of the task force shall be
- 11 appointed by the executive committee of the task force through an
- 12 application and selection process, representing stakeholders in the
- 13 long-term care system and may include a representative of the
- 14 Division of Medicaid and Long-Term Care Advisory Committee on Aging,
- 15 representatives of health care providers, elder law attorneys,
- 16 representatives of the long-term care ombudsman program, health care
- 17 <u>economists</u>, <u>geriatric</u> <u>specialists</u>, <u>family</u> <u>caregivers</u> <u>of</u> <u>seniors</u> in
- 18 at-home care, providers of services to the elderly, seniors currently
- 19 or previously in institutional care, and aging advocacy
- 20 organizations.
- 21 (3) The executive committee of the task force shall
- 22 advise the task force regarding the interaction among the three
- 23 branches of government related to long-term care programs and
- 24 services. The members of the executive committee shall each represent
- 25 his or her own branch of government, and no member of the executive

1 committee shall participate in actions that could be deemed to be the

- 2 exercise of the duties and prerogatives of another branch of
- 3 government or that improperly delegate the powers and duties of any
- 4 branch of government to another branch of government.
- 5 (4) The task force shall work with administrators of area
- 6 agencies on aging, nursing home and assisted-living residence
- 7 providers, hospitals, rehabilitation centers, managed care companies,
- 8 senior citizen centers, community stakeholders, advocates for elder
- 9 services and programs, the Center for Public Affairs Research of the
- 10 College of Public Affairs and Community Service at the University of
- 11 Nebraska at Omaha, and seniors statewide to establish effective
- 12 community collaboration for informed decisionmaking that supports the
- 13 provisions of effective and efficient long-term care services.
- 14 <u>(5) The task force shall create a statewide strategic</u>
- 15 plan for long-term care services in Nebraska which shall consider,
- 16 <u>but not be limited to:</u>
- 17 (a) Promotion of independent living through provision of
- 18 long-term services and support that enable an individual to live in
- 19 the setting of his or her choice;
- 20 (b) Provision of leadership to support sound fiscal
- 21 management of long-term care budgets so that Nebraska will be able to
- 22 meet the increasing demand for long-term care services as a growing
- 23 portion of the state's population reaches the age of eighty years;
- 24 (c) Expedited creation of workforce development and
- 25 training programs specific to the needs of and in response to

- 1 Nebraska's growing aging population;
- 2 (d) A system-wide evaluation by a national entity with
- 3 <u>expertise in evaluating long-term state budgeting for long-term care</u>
- 4 services and support that is necessary to sustain an efficient and
- 5 effective system of care;
- 6 (e) The identification of gaps in the service delivery
- 7 system that contribute to the inefficient and ineffective delivery of
- 8 <u>services; and</u>
- 9 (f) Development of a process for evaluating the quality
- 10 <u>of residential and home and community-based long-term services and</u>
- 11 support.
- 12 (6) The executive committee may hire staff to fulfill the
- 13 <u>responsibilities of the task force within the limits of</u>
- 14 appropriations.
- Sec. 3. On or before December 15, 2014, the Aging
- 16 Nebraskans Task Force shall present to the Legislature a report of
- 17 recommendations for the statewide strategic plan described in section
- 18 2 of this act.
- 19 Sec. 4. Since an emergency exists, this act takes effect
- 20 when passed and approved according to law.
