A BILL

1 FOR AN ACT relating to crimes and offenses; to amend sections 28-830
2 and 28-831, Revised Statutes Supplement, 2013; to change
3 provisions and redefine terms relating to labor
4 trafficking and sex trafficking; to harmonize provisions;
5 and to repeal the original sections.
6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-830, Revised Statutes Supplement,
2 2013, is amended to read:

3 28-830 For purposes of sections 28-830 and 28-831, the
4 following definitions apply:

5 (1) Actor means a person who solicits, procures, or
6 supervises the services or labor of another person;

7 (2) Commercial sexual activity means any sex act on
8 account of which anything of value is given, promised to, or received
9 by any person;

10 (3) Debt bondage means inducing another person to
11 provide:

12 (a) Commercial sexual activity in payment toward or
13 satisfaction of a real or purported debt; or

14 (b) Labor or services in payment toward or satisfaction
15 of a real or purported debt if:

16 (i) The reasonable value of the labor or services is not
17 applied toward the liquidation of the debt; or

18 (ii) The length of the labor or services is not limited
19 and the nature of the labor or services is not defined.

20 ~~(3)~~(4) Financial harm means theft by extortion as
21 described by section 28-513;

22 ~~(4)~~(5) Forced labor or services means labor or services
23 that are performed or provided by another person and are obtained or
24 maintained through:

25 (a) Inflicting or threatening to inflict serious personal

1 injury, ~~to the other person~~ as defined by section 28-318, on another
2 person;

3 (b) Physically restraining or threatening to physically
4 restrain the other person;

5 (c) Abusing or threatening to abuse the legal process
6 against another person;

7 (d) Controlling or threatening to control another
8 person's access to a controlled substance as defined in section
9 28-401;

10 (e) Using another person's physical or mental impairment
11 when the impairment has a substantial adverse effect on the other
12 person's cognitive or volitional function;

13 ~~(e)~~—(f) Knowingly destroying, concealing, removing,
14 confiscating, or possessing any actual or purported passport or other
15 immigration document or any other actual or purported government
16 identification document of the other person; or

17 ~~(d)~~—(g) Causing or threatening to cause financial harm to
18 the other person; another person, including debt bondage;

19 ~~(5)~~—(6) Labor means work of economic or financial value;

20 ~~(6)~~—(7) Labor trafficking means knowingly recruiting,
21 enticing, harboring, transporting, providing, or obtaining by any
22 means or attempting to recruit, entice, harbor, transport, provide,
23 or obtain by any means a person eighteen years of age or older
24 intending or knowing that the person will be subjected to forced
25 labor or services;

1 ~~(7)~~(8) Labor trafficking of a minor means knowingly
2 recruiting, enticing, harboring, transporting, providing, or
3 obtaining by any means or attempting to recruit, entice, harbor,
4 transport, provide, or obtain by any means a minor intending or
5 knowing that the minor will be subjected to forced labor or services;

6 ~~(8)~~(9) Maintain means, in relation to labor or services,
7 to secure continued performance thereof, regardless of any initial
8 agreement by the other person to perform such type of service;

9 ~~(9)~~(10) Minor means a person younger than eighteen years
10 of age;

11 ~~(10)~~(11) Obtain means, in relation to labor or services,
12 to secure performance thereof;

13 ~~(11)~~(12) Services means an ongoing relationship between
14 the actor and another person in which the person performs activities
15 under the supervision of or for the benefit of the actor. Commercial
16 sexual activity and sexually-explicit performances are forms of
17 services under this section. Nothing in this subdivision shall be
18 construed to legalize prostitution;

19 ~~(12)~~(13) Sex trafficking means knowingly recruiting,
20 enticing, harboring, transporting, providing, or obtaining by any
21 means or knowingly attempting to recruit, entice, harbor, transport,
22 provide, or obtain by any means a person eighteen years of age or
23 older for the purpose of having such person engage in commercial
24 sexual activity, sexually explicit performance, or the production of
25 pornography or to cause or attempt to cause a person eighteen years

1 of age or older to engage in commercial sexual activity, sexually
 2 explicit performance, or the production of pornography;

3 ~~(13)~~ (14) Sex trafficking of a minor means knowingly
 4 recruiting, enticing, harboring, transporting, providing, or
 5 obtaining by any means or knowingly attempting to recruit, entice,
 6 harbor, transport, provide, or obtain by any means a minor for the
 7 purpose of having such minor engage in commercial sexual activity,
 8 sexually explicit performance, or the production of pornography or to
 9 cause or attempt to cause a minor to engage in commercial sexual
 10 activity, sexually explicit performance, or the production of
 11 pornography;

12 ~~(14)~~ (15) Sexually-explicit performance means a live or
 13 public play, dance, show, or other exhibition intended to arouse or
 14 gratify sexual desire or to appeal to prurient interests; and

15 ~~(15)~~ (16) Trafficking victim means a person subjected to
 16 any act or acts prohibited by section 28-831.

17 Sec. 2. Section 28-831, Revised Statutes Supplement,
 18 2013, is amended to read:

19 28-831 (1) No person shall knowingly engage in labor
 20 trafficking or sex trafficking. If an actor engages in labor
 21 trafficking or sex trafficking, the actor is guilty of a Class IV
 22 felony.

23 (2) If an actor knowingly engages in labor trafficking or
 24 sex trafficking by:

25 (a) Inflicting or threatening to inflict serious personal

1 injury, ~~to the other person~~ as defined by section 28-318, on another
2 person, the actor is guilty of a Class III felony;

3 (b) Physically restraining or threatening to physically
4 restrain the other person, the actor is guilty of a Class III felony;

5 (c) Abusing or threatening to abuse the legal process
6 against another person, the actor is guilty of a Class III felony;

7 (d) Controlling or threatening to control another
8 person's access to a controlled substance as defined in section
9 28-401, the actor is guilty of a Class III felony;

10 (e) Using another person's physical or mental impairment
11 when the impairment has a substantial adverse effect on the other
12 person's cognitive or volitional function, the actor is guilty of a
13 Class III felony;

14 ~~(e)~~ (f) Knowingly destroying, concealing, removing,
15 confiscating, or possessing any actual or purported passport or other
16 immigration document, or any other actual or purported government
17 identification document, of the other person, the actor is guilty of
18 a Class IV felony; or

19 ~~(d)~~ (g) Causing or threatening to cause financial harm to
20 the other person, including debt bondage, the actor is guilty of a
21 Class I misdemeanor.

22 ~~(2)~~ (3) No person shall engage in labor trafficking of a
23 minor or sex trafficking of a minor. An actor who engages in labor
24 trafficking of a minor or sex trafficking of a minor shall be
25 punished as follows:

1 (a) In cases in which the actor uses overt force or the
2 threat of force against the trafficking victim, the actor is guilty
3 of a Class II felony;

4 (b) In cases in which the trafficking victim has not
5 attained the age of fifteen years, the actor is guilty of a Class II
6 felony; or

7 (c) In cases involving a trafficking victim between the
8 ages of fifteen and eighteen years, and the actor does not use overt
9 force or threat of force against the trafficking victim, the actor is
10 guilty of a Class III felony.

11 ~~(3)~~ (4) Any person who benefits, financially or by
12 receiving anything of value, from participation in a venture which
13 has, as part of the venture, an act that is in violation of this
14 section, is guilty of a Class IV felony.
