3 4 71-7611 (1) The Nebraska Health Care Cash Fund is created. The State Treasurer shall transfer (a) fifty-six million one hundred thousand 5 dollars no later than July 15, 2009, (b) fifty-nine million one hundred 6 thousand dollars on or before July 15, 2010, July 15, 2011, July 15, 7 2012, and July 15, 2013, and (c) sixty million one hundred thousand 8 9 dollars on or before July 15, 2014, (d) sixty million three hundred fifty thousand dollars on or before July 15, 2015, (e) sixty million three 10 hundred fifty thousand dollars on or before July 15, 2016, (f) sixty 11 12 million three hundred fifty thousand dollars on or before July 15, 2017, (g) sixty million three hundred fifty thousand dollars on or before July 13 15, 2018, and (h) sixty million one hundred thousand dollars and on or 14 thereafter from the 15 every July 15 Nebraska Medicaid Intergovernmental Trust Fund and the Nebraska Tobacco Settlement Trust 16 Fund to the Nebraska Health Care Cash Fund, except that such amount shall 17 be reduced by the amount of the unobligated balance in the Nebraska 18 19 Health Care Cash Fund at the time the transfer is made. The state investment officer upon consultation with the Nebraska Investment Council 20 shall advise the State Treasurer on the amounts to be transferred from 21 the Nebraska Medicaid Intergovernmental Trust Fund and from the Nebraska 22 Tobacco Settlement Trust Fund under this section in order to sustain such 23 transfers in perpetuity. The state investment officer shall report 24 electronically to the Legislature on or before October 1 of every even-25 numbered year on the sustainability of such transfers. Except as 26
