This bill would provide additional powers and duties for guardians ad litem.

The Supreme Court states that the bill will increase court workload, but the fiscal impact is not expected to be significant.

The Foster Care Review Office and the Department of Health and Human Services both estimate no fiscal impact.

The Lancaster County Juvenile Court estimates no fiscal impact from this bill.

The Nebraska Association of County Officials (NACO) states that the requirements of this bill could increase the cost to counties but any increase is indeterminate.

Lancaster County estimates costs of \$100,888 in FY16 (partial year) and \$403,552 in FY17 (full-year) to comply with the requirements of this bill. See their attached response for details.

Douglas County states this bill will have an unknown fiscal impact to the county.

LB 15 would add additional duties and powers for guardians ad litem. Guardians ad litem would be required to fulfill training prescribed by Supreme Court Rule. Further reporting requirements for a guardian ad litem as well as a potential added attorney for the juvenile's interests would increase the costs to counties in certain circumstances. The increase is indeterminate. Prohibiting the use of a flat-fee scale payment of attorneys by some counties is also unknown.
