Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 465 is the Electronic Notary Public Act.

Section 2 provides definitions for the Act.

Section 3 through 5 establish criteria under which a person shall be eligible to register as an electronic notary public.

Section 6 requires a fifty dollar fee for registering or reregistering as an electronic notary. This fee is in addition to the fee required in section 33-102. The fees shall be remitted and credited to the Administration Cash Fund and used to administer the Act.

The Secretary of State would need to enact application programming to add eNotary registration to their current database. In addition, the Secretary of State would need to add 1.0 FTE to administer the program. This position will design, set up and oversee the program application development, processes and requirements, draft and promulgate rules and regulations, provide ongoing educational materials and training.

The Secretary of State estimates the cost of such activity to be \$120,915 in fiscal year 2015-16 and \$73,556 thereafter. There is no basis to disagree with these estimates. Revenue for the first year are estimated to be \$3,500. Renewals occur every 4 years, therefore additional revenue wouldn't be realized until fiscal year 2019-20. Revenue is based on a projected 50 applicants and 50 Certificates of Authority. The bill's provisions allow for this revenue to be applied toward program costs. Since the revenue would be realized in fiscal year 2015-16, \$3,500 of Cash Funds are being applied to expenditure costs in fiscal year 2016-17.

## **Explanation of Estimate:**

LB465 creates an Electronic Notary Public Act that will allow commissioned Notaries Public to register and be commissioned as Electronic Notaries Public in order to perform electronic notarial acts. The Act requires the use of electronic technology, has educational requirements, and requires the signer to be in the physical presence of the notary at the time the electronic notarial act is performed. The fee for registration is \$50 and the commission will match the current notary commission renewal term. The Secretary of State may charge \$20 for issuing an electronic certificate of authority.

## Fiscal Impact:

There will be application programming costs to add eNotary registration to our current Notary database necessary to administer the program, track eNotary applications, track education requirements, track technology vendors and provide eNotary commission data and statistics as necessary for administering the program, to provide commission certificates and to match commission expiration dates with current the Notary commission term. The eNotary will also create additional database access and usage fees on an annual basis and are included in our fiscal note.

In order to implement and administer this program we will need one additional staff person devoted specifically to eNotary, as seen in other states have which have implemented the program. The Program Specialist will design, set up and oversee the program application development, processes and requirements, draft and promulgate rules and regulations, provide ongoing education materials and training to meet statutory requirements, work with the OCIO technology developers to define and set up programming application for eNotary registration within the current notary database, answer questions of applicants and run the program. This person will also create and maintain website materials. It is anticipated that this position will also be the liaison for associated vendors that provide eNotary technology for administration of the program.
