LB 657 contains the Governors recommendation for mainline new appropriations for the FY2015-16 and FY2016-17 biennial budget. In addition to the appropriations contained in this bill, the Governors recommendation for the FY15-16 and FY16-17 biennial budget is also contained in LB 658 – Legislators Salaries, LB 659 - Constitutional Officers Salaries, and LB 660 – Capital Construction.

LB 657 also contains transfer of funds between funds in Section 262. Also in addition to the new appropriation amounts contained in the bill, LB 657 generally reappropriates FY14-15 unexpended General Fund balances for operations only. Reappropriation of aid amounts are provided for in selected instance.
