LB 657 as amended contains the Appropriations Committee recommendation for mainline new appropriations for the FY2015-16 and FY2016-17 biennial budget. In addition to the appropriations contained in this bill, the Committee proposed budget for the FY15-16 and FY16-17 biennial budget is also contained in LB 658 – Legislators Salaries, LB 659 - Constitutional Officers Salaries, and LB 660 – Capital Construction.

LB 657 also contains transfer of monies between funds in Section 271. Also in addition to the new appropriation amounts contained in the bill, LB 657 reappropriates FY14-15 unexpended General Fund balances for selected budget programs.
