- 3 Fourth Legislature, First Session, 2015; to provide an operative
- 4 date; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$39,903 from the
- 2 General Fund for FY2015-16 and (2) \$81,202 from the General Fund for
- 3 FY2016-17 to the Supreme Court, for Program 3, to aid in carrying out the
- 4 provisions of Legislative Bill 663, One Hundred Fourth Legislature, First
- 5 Session, 2015.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$39,332
- 8 <u>for FY2015-16 or \$80,041 for FY2016-17.</u>
- 9 Sec. 2. There is hereby appropriated (1) \$32,492 from the General
- 10 Fund for FY2015-16 and (2) \$66,122 from the General Fund for FY2016-17 to
- 11 <u>the Supreme Court, for Program 4, to aid in carrying out the provisions</u>
- 12 <u>of Legislative Bill 663, One Hundred Fourth Legislature, First Session,</u>
- 13 2015.
- 14 <u>Total expenditures for permanent and temporary salaries and per</u>
- 15 diems from funds appropriated in this section shall not exceed \$32,028
- 16 for FY2015-16 or \$65,177 for FY2016-17.
- 17 Sec. 3. There is hereby appropriated (1) \$353,281 from the General
- 18 Fund for FY2015-16 and (2) \$718,927 from the General Fund for FY2016-17
- 19 to the Supreme Court, for Program 6, to aid in carrying out the
- 20 provisions of Legislative Bill 663, One Hundred Fourth Legislature, First
- 21 <u>Session</u>, 2015.
- 22 Total expenditures for permanent and temporary salaries and per
- 23 diems from funds appropriated in this section shall not exceed \$348,232
- 24 <u>for FY2015-16 or \$708,652 for FY2016-17.</u>
- Sec. 4. <u>There is hereby appropriated (1) \$297,560 from the General</u>
- 26 Fund for FY2015-16 and (2) \$605,535 from the General Fund for FY2016-17
- 27 <u>to the Supreme Court, for Program 7, to aid in carrying out the</u>
- 28 provisions of Legislative Bill 663, One Hundred Fourth Legislature, First
- 29 Session, 2015.
- 30 <u>Total expenditures for permanent and temporary salaries and per</u>
- 31 diems from funds appropriated in this section shall not exceed \$293,307

- 1 <u>for FY2015-16 or \$596,880 for FY2016-17.</u>
- 2 Sec. 5. There is hereby appropriated (1) \$39,254 from the
- 3 Compensation Court Cash Fund for FY2015-16 and (2) \$80,059 from the
- 4 Compensation Court Cash Fund for FY2016-17 to the Nebraska Workers'
- 5 <u>Compensation Court, for Program 526, to aid in carrying out the</u>
- 6 provisions of Legislative Bill 663, One Hundred Fourth Legislature, First
- 7 <u>Session</u>, 2015.
- 8 Total expenditures for permanent and temporary salaries and per
- 9 diems from funds appropriated in this section shall not exceed \$36,383
- 10 <u>for FY2015-16 or \$74,038 for FY2016-17.</u>
- 11 Sec. 6. This act becomes operative on July 1, 2015.
- 12 Sec. 7. Since an emergency exists, this act takes effect when
- 13 passed and approved according to law.
