1 Section 1. Section 79-1302, Reissue Revised Statutes of Nebraska, is

amended to read: 79-1302 The Legislature finds that the utilization of appropriate 3 4 technologies and high-quality digital educational content can provide 5 enhanced educational services and broadened educational opportunities for all Nebraska learners. It is the intent of the Legislature: (1) To 6 7 utilize technology to provide effective and efficient synchronous and asynchronous digital and distance learning opportunities distance 8 9 learning; (2) to provide assistance and direction in the training of 10 Nebraska teachers in uses of technology for instruction through electronic means; (3) to establish and support digital academic content, 11 textbooks, learning objects, courses, and media systems in addition to a 12 13 an electronic data network and student information data systems for the benefit of Nebraska parents, educators, students, and all other data 14 bases for Nebraska educators and learners; (4) to support the evaluation 15 and dissemination of models of successful technology-supported learning 16 17 tools technologies which improve instruction or learning in all of Nebraska's educational settings, including public, private, 18 19 denominational, parochial, and exempt schools; (5) to provide support for cooperative technology supported learning systems education-technology 20 ventures in partnership with public or private entities; and (6) to 21 22 provide support for agreements for software as a service, cooperative purchase, or leasing of administrative or instructional software or 23 24 software licenses in partnership with schools, educational service units, 25 and other states; and (7) to develop an instructional support and improvement system plan consistent with the Nebraska Information 26 Technology Commission statewide technology plan, model school improvement 27 plans, and educational technology used by Nebraska schools and districts. 28

- 19 into Nebraska elementary and secondary schools in order to provide
- 20 quality education and equal opportunity for <u>all</u> Nebraska learners.
- 21 The position of PK-12 Chief Integration Officer is created to lead
- 22 the work of the center. The PK-12 Chief Integration Officer shall lead
- 23 and coordinate the statewide efforts to achieve the mission of the
- 24 center.

- 3 that assists in ensuring the privacy and security of users and overall
- 4 integrity of data systems;
- 5 (3) To serve as a demonstration site for state-of-the-art hardware

- 7 (4) To provide technical assistance to educators in working with \underline{or}
- 8 accessing digital systems and resources hardware and software;

- 10 conjunction with other educational entities as defined in section

- 17 (8) To experiment with various applications or technology in

- 19 (9) To assist schools in planning for and selecting appropriate
- 20 technologies and to establish and maintain industry standards for data
- 21 and digital educational systems used in Nebraska;
- 22 (10) To design, implement, and evaluate technology integration pilot
- 23 projects to assess the usefulness of technologies in school management,
- 24 curriculum, instruction, and learning that enhance educational
- 25 opportunities for all Nebraska learners;
- 26 (11) To <u>develop and lead</u> seek partnerships with the Nebraska
- 27 Educational Telecommunications Commission, the University of Nebraska,
- 28 the state colleges, community colleges, the Educational Service Unit
- 29 <u>Coordinating Council</u>, <u>educational service units</u>, <u>school districts</u>,
- 30 <u>learning communities</u> educational service units, the Nebraska Library
- 31 Commission, and other public and private entities in order to make

- 1 effective use of limited resources;
- 2 (12) To encourage sharing among school districts to deliver cost-
- 3 efficient and effective distance learning and digital resources; and
- 4 (13) To identify, evaluate, and disseminate information on school
- 5 projects which have the potential to enhance the quality of instruction
- 6 or level of learning or improve the achievement of students and other
- 7 <u>learners; and learning.</u>
- 8 (14) To develop a statewide instructional improvement system that
- 9 supports personal learning consisting of, but not limited to, the
- 10 <u>following: (a) Virtual educator standards; (b) Nebraska meta tag</u>
- 11 <u>standards; (c) a Nebraska open education resources library; (d) a digital</u>
- 12 books library; (e) a Nebraska digital learning teacher certification
- 13 process; and (f) integrated instructional resources connected to an
- 14 <u>education data dashboard system.</u>
