- 2 section 84-602.02, Revised Statutes Supplement, 2015; to change
- 3 provisions relating to exempt contracts; and to repeal the original
- 4 section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 84-602.02, Revised Statutes Supplement, 2015, is

- 2 amended to read:
- 3 84-602.02 (1)(a) Not later than January 1, 2010, the web site
- 4 established, developed, and maintained by the State Treasurer pursuant to
- 5 subdivision (9) of section 84-602 shall provide such information as will
- 6 document the sources of all tax receipts and the expenditure of state
- 7 funds by all agencies, boards, commissions, and departments of the state.
- 8 (b) The State Treasurer shall, in appropriate detail, cause to be
- 9 published on the web site:
- 10 (i) The identity, principal location, and amount of funds received
- 11 or expended by the State of Nebraska and all of its agencies, boards,
- 12 commissions, and departments;
- 13 (ii) The funding or expending agency, board, commission, or
- 14 department;
- 15 (iii) The budget program source;
- 16 (iv) The amount, date, purpose, and recipient of all disbursed
- 17 funds; and
- 18 (v) Such other relevant information as will further the intent of
- 19 enhancing the transparency of state government financial operations to
- 20 its citizens and taxpayers. The web site shall include data for fiscal
- 21 year 2008-09 and each fiscal year thereafter.
- 22 (2) Beginning July 1, 2010, the data shall be available on the web
- 23 site no later than thirty days after the end of the preceding fiscal
- 24 year.
- 25 (3)(a) Beginning July 1, 2014, the web site described in this
- 26 section shall include a link to the web site of the Department of
- 27 Administrative Services. The department's web site shall contain:
- 28 (i) A data base that includes a copy of each active contract that is
- 29 a basis for an expenditure of state funds, including any amendment to
- 30 such contract and any document incorporated by reference in such
- 31 contract. For purposes of this subdivision, amendment means an agreement

- 1 to modify a contract which has been reduced to writing and signed by each
- 2 party to the contract, an agreement to extend the duration of a contract,
- 3 or an agreement to renew a contract. The data base shall be accessible by
- 4 the public and searchable by vendor, by agency, board, commission, or
- 5 department, and by dollar amount. All agencies, boards, commissions, and
- 6 departments of the state shall provide to the Department of
- 7 Administrative Services, in electronic form, copies of such contracts for
- 8 inclusion in the data base beginning with contracts that are active on
- 9 and after January 1, 2014; and
- 10 (ii) A data base that includes copies of all expired contracts which
- 11 were previously included in the data base described in subdivision (3)(a)
- 12 (i) of this section and which have not been disposed of pursuant to
- policies and procedures adopted under subdivision (3)(e) of this section.
- 14 The data base required under this subdivision shall be accessible by the
- 15 public and searchable by vendor, by agency, board, commission, or
- 16 department, and by dollar amount.
- 17 (b) The following shall be redacted or withheld from any contract
- 18 before such contract is included in a data base pursuant to subdivision
- 19 (3)(a) of this section:
- 20 (i) The social security number or federal tax identification number
- 21 of any individual or business;
- 22 (ii) Protected health information as such term is defined under the
- 23 federal Health Insurance Portability and Accountability Act of 1996, as
- 24 such act existed on January 1, 2013;
- 25 (iii) Any information which may be withheld from the public under
- 26 section 84-712.05; or
- 27 (iv) Any information that is confidential under state or federal
- 28 law, rule, or regulation.
- 29 (c) The following contracts shall be exempt from the requirements of
- 30 subdivision (3)(a) of this section:
- 31 (i) Contracts entered into by the Department of Health and Human

- 1 Services that are letters of agreement for the purpose of providing
- 2 specific services to a specifically named individual and his or her
- 3 family;
- 4 (ii) Contracts entered into by the University of Nebraska or any of
- 5 the Nebraska state colleges for the purpose of providing specific
- 6 services or financial assistance to a specifically named individual and
- 7 his or her family;
- 8 (iii) Contracts entered into by the Department of Veterans' Affairs
- 9 under section 80-401 or 80-403 for the purpose of providing aid to a
- 10 specifically named veteran and his or her family;
- 11 (iv) Contracts entered into by the State Energy Office for the
- 12 purpose of providing financing from the Dollar and Energy Saving Loan
- 13 program; and
- 14 <u>(v) Contracts entered into by the State Department of Education</u>
- 15 under sections 79-11,121 to 79-11,132 for the purpose of providing
- 16 specific goods, services, or financial assistance on behalf of or to a
- 17 specifically named individual; and
- 18 $(\underline{vi} \ \forall)$ Contracts of employment for employees of any agency, board,
- 19 commission, or department of the state. The exemption provided in this
- 20 subdivision shall not apply to contracts entered into by any agency,
- 21 board, commission, or department of the state to obtain the services of
- 22 an independent contractor.
- 23 (d) No agency, board, commission, or department of the state shall
- 24 structure a contract to avoid any of the requirements of subdivision (3)
- 25 (a) of this section.
- 26 (e) The Department of Administrative Services shall adopt policies
- 27 and procedures regarding the creation, maintenance, and disposal of
- 28 records pursuant to section 84-1212.02 contained in the data bases
- 29 required under this section and the process by which agencies, boards,
- 30 commissions, and departments of the state provide copies of the contracts
- 31 required under this section.

- 1 (4) All agencies, boards, commissions, and departments of the state
- 2 shall provide to the State Treasurer, at such times and in such form as
- 3 designated by the State Treasurer, such information as is necessary to
- 4 accomplish the purposes of the Taxpayer Transparency Act.
- 5 (5) Nothing in this section requires the disclosure of information
- 6 which is considered confidential under state or federal law or is not a
- 7 public record under section 84-712.05.
- 8 (6)(a) For purposes of this section, expenditure of state funds
- 9 means all expenditures of appropriated or nonappropriated funds by an
- 10 agency, board, commission, or department of the state from the state
- 11 treasury in forms including, but not limited to:
- 12 (i) Grants;
- 13 (ii) Contracts;
- 14 (iii) Subcontracts;
- 15 (iv) State aid to political subdivisions; and
- 16 (v) Tax refunds or credits that may be disclosed pursuant to the
- 17 Nebraska Advantage Act, the Nebraska Advantage Microenterprise Tax Credit
- 18 Act, the Nebraska Advantage Research and Development Act, or the Nebraska
- 19 Advantage Rural Development Act.
- 20 (b) Expenditure of state funds does not include the transfer of
- 21 funds between two agencies, boards, commissions, or departments of the
- 22 state or payments of state or federal assistance to an individual.
