**LEGISLATIVE BILL 735**

Introduced by Friesen, 34.

- 1 A BILL FOR AN ACT relating to the Nebraska Rules of the Road; to amend
- 2 section 60-6,290, Revised Statutes Cumulative Supplement, 2014; to
- 3 provide a length limit exception for an articulated bus vehicle
- 4 operated by a transit authority as prescribed; and to repeal the
- 5 original section.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-6,290, Revised Statutes Cumulative Supplement,  
2 2014, is amended to read:

3 60-6,290 (1)(a) No vehicle shall exceed a length of forty feet,  
4 extreme overall dimensions, inclusive of front and rear bumpers including  
5 load, except that:

6 (i) A bus or a motor home, as defined in section 71-4603, may exceed  
7 the forty-foot limitation but shall not exceed a length of forty-five  
8 feet;

9 (ii) A truck-tractor may exceed the forty-foot limitation;

10 (iii) A semitrailer operating in a truck-tractor single semitrailer  
11 combination, which semitrailer was actually and lawfully operating in the  
12 State of Nebraska on December 1, 1982, may exceed the forty-foot  
13 limitation;

14 (iv) A semitrailer operating in a truck-tractor single semitrailer  
15 combination, which semitrailer was not actually and lawfully operating in  
16 the State of Nebraska on December 1, 1982, may exceed the forty-foot  
17 limitation but shall not exceed a length of fifty-three feet including  
18 load;~~and~~

19 (v) A semitrailer operating in a truck-tractor single semitrailer  
20 combination, while transporting baled livestock forage, may exceed the  
21 forty-foot limitation but shall not exceed a length of fifty-nine feet  
22 six inches including load; and -

23 (vi) An articulated bus vehicle operated by a transit authority  
24 created pursuant to section 14-1803 may exceed the forty-foot limitation.  
25 For purposes of this subdivision (vi), an articulated bus vehicle shall  
26 not exceed sixty-five feet in length.

27 (b) No combination of vehicles shall exceed a length of sixty-five  
28 feet, extreme overall dimensions, inclusive of front and rear bumpers and  
29 including load, except:

30 (i) One truck and one trailer, loaded or unloaded, used in  
31 transporting implements of husbandry to be engaged in harvesting, while

1 being transported into or through the state during daylight hours if the  
2 total length does not exceed seventy-five feet including load;

3 (ii) A truck-tractor single semitrailer combination;

4 (iii) A truck-tractor semitrailer trailer combination, but the  
5 semitrailer trailer portion of such combination shall not exceed sixty-  
6 five feet inclusive of connective devices; and

7 (iv) A driveaway saddlemount vehicle transporter combination and  
8 driveaway saddlemount with fullmount vehicle transporter combination, but  
9 the total overall length shall not exceed ninety-seven feet.

10 (c) A truck shall be construed to be one vehicle for the purpose of  
11 determining length.

12 (d) A trailer shall be construed to be one vehicle for the purpose  
13 of determining length.

14 (2) Subsection (1) of this section shall not apply to:

15 (a) Extra-long vehicles which have been issued a permit pursuant to  
16 section 60-6,292;

17 (b) Vehicles which have been issued a permit pursuant to section  
18 60-6,299;

19 (c) The temporary moving of farm machinery during daylight hours in  
20 the normal course of farm operations;

21 (d) The movement of unbaled livestock forage vehicles, loaded or  
22 unloaded;

23 (e) The movement of public utility or other construction and  
24 maintenance material and equipment at any time;

25 (f) Farm equipment dealers or their representatives as authorized  
26 under section 60-6,382 driving, delivering, or picking up farm equipment  
27 or implements of husbandry within the county in which the dealer  
28 maintains his or her place of business, or in any adjoining county or  
29 counties, and return;

30 (g) The overhang of any motor vehicle being hauled upon any lawful  
31 combination of vehicles, but such overhang shall not exceed the distance

1 from the rear axle of the hauled motor vehicle to the closest bumper  
2 thereof;

3 (h) The overhang of a combine to be engaged in harvesting, while  
4 being transported into or through the state driven during daylight hours  
5 by a truck-tractor semitrailer combination, but the length of the  
6 semitrailer, including overhang, shall not exceed sixty-three feet and  
7 the maximum semitrailer length shall not exceed fifty-three feet;

8 (i) Any self-propelled specialized mobile equipment with a fixed  
9 load when the requirements of subdivision (2)(i) of section 60-6,288 are  
10 met; or

11 (j) One truck-tractor two trailer combination or one truck-tractor  
12 semitrailer trailer combination used in transporting equipment utilized  
13 by custom harvesters under contract to agricultural producers to harvest  
14 wheat, soybeans, or milo during the months of April through November but  
15 the length of the property-carrying units, excluding load, shall not  
16 exceed eighty-one feet six inches.

17 (3) The length limitations of this section shall be exclusive of  
18 safety and energy conservation devices such as rearview mirrors,  
19 turnsignal lights, marker lights, steps and handholds for entry and  
20 egress, flexible fender extensions, mudflaps and splash and spray  
21 suppressant devices, load-induced tire bulge, refrigeration units or air  
22 compressors, and other devices necessary for safe and efficient operation  
23 of commercial motor vehicles, except that no device excluded from the  
24 limitations of this section shall have by its design or use the  
25 capability to carry cargo.
