- 2 Reissue Revised Statutes of Nebraska; to change provisions relating
- 3 to motor vehicle registration; to provide an operative date; and to
- 4 repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 60-370, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 60-370 (1) Except as provided in subsection (3) of this section:
- 4 (a) In counties having a population of one hundred thousand
- 5 <u>inhabitants</u> or more according to the most recent federal decennial
- 6 census, registration of motor vehicles or trailers shall be by the
- 7 alphanumeric system.
- 8 (b) In all other counties, registration of motor vehicles or
- 9 trailers shall be, at the option of each county board, by either the
- 10 alphanumeric system or the county number system Each county in the state
- 11 shall use the county number system except as otherwise provided in this
- 12 section.
- 13 (b) Registration of motor vehicles or trailers as farm trucks or
- 14 farm trailers shall be by the county number system.
- 15 (2) Counties using the county number system shall show on motor
- 16 vehicles or trailers licensed therein a county number on the license
- 17 plate preceding a dash which shall then be followed by the registration
- 18 number assigned to the motor vehicle or trailer. The county numbers
- 19 assigned to the counties in Nebraska shall be as follows:

- (b) Except as provided in subdivision (1)(b) of this section,
 registration of motor vehicles or trailers in all other counties shall
 be, at the option of each county board, by either the alphanumeric system
 or the county number system.
- 16 (3 e) Counties using the alphanumeric system shall show on the license plates of motor vehicles or trailers licensed therein a 17 18 combination of three letters followed by a combination of three numerals. 19 The department may adopt and promulgate rules and regulations creating 20 alphanumeric distinctions on the license plates based upon the 21 registration of the motor vehicle or trailer and designating plate types 22 that shall display county numbers on a statewide basis, taking into consideration cost, the need for uniformity, factors applicable to the 23 production, distribution, and use of specific plate types, and any other 24 25 factors consistent with the purposes of the Motor Vehicle Registration 26 Act that the director deems relevant.
- 27 Sec. 2. This act becomes operative on January 1, 2017.
- Sec. 3. Original section 60-370, Reissue Revised Statutes of Nebraska, is repealed.
