NORRIS LEGISLATIVE CHAMBER OF THE STATE CAPITOL, AT THIS HOUR OF 10:00 A.M. ON WEDNESDAY, JANUARY 7, 2015, IS NOW CALLED TO ORDER. MR. PRESIDENT NELSON: THANK YOU, MR. CLERK. WE WILL NOW PROCEED TO APPOINTMENT OF TEMPORARY OFFICERS. THE CHAIR RECOGNIZES SENATOR KRIST.

CLERK: MR. PRESIDENT, I HAVE A SERIES OF RESIGNATION AND APPOINTMENT LETTERS. THE FIRST IS A RESIGNATION LETTER SUBMITTED FROM LIEUTENANT GOVERNOR LAVON HEIDEMANN DATED SEPTEMBER 9. I HAVE A SECOND RESIGNATION LETTER FROM SENATOR JOHN NELSON, AS A MEMBER OF THE LEGISLATURE. DATED SEPTEMBER 29. PURSUANT TO THAT RESIGNATION, I HAVE AN APPOINTMENT LETTER FROM GOVERNOR HEINEMAN APPOINTING JOHN E. NELSON AS LIEUTENANT GOVERNOR. EFFECTIVE MONDAY, SEPTEMBER 29, AT 1:30. ATTACHED TO THAT APPOINTMENT IS THE ACCOMPANYING OATH OF OFFICE. IN ADDITION, RESIGNATION LETTERS FROM SENATOR SCOTT LAUTENBAUGH, FROM SENATOR CHARLIE JANSSEN. PURSUANT TO THE RESIGNATION LETTER FROM SENATOR JANSSEN, I HAVE AN APPOINTMENT LETTER FROM GOVERNOR HEINEMAN APPOINTING MR. DAVID A. SCHNOOR TO FILL THE SEAT VACANCY AS CREATED IN THE 15th LEGISLATIVE DISTRICT. ACCOMPANYING THAT ARE THE APPROPRIATE DOCUMENTATION. INCLUDING THE OATH OF OFFICE. THAT'S ALL THAT I HAVE AT THIS TIME, MR. PRESIDENT. (LEGISLATIVE JOURNAL PAGES 2-8.)

SENATOR GARRETT: MR. PRESIDENT, I MOVE THAT THE RULES THAT IS NOW IN OUR POSSESSION BE ADOPTED FOR TODAY ONLY, WEDNESDAY, JANUARY 7, 2015.

PRESIDENT NELSON: THANK YOU. THE MOTION BEFORE YOU IS THE ADOPTION OF TEMPORARY RULES. ALL THOSE IN FAVOR SAY AYE. SENATOR KINTNER, YOU ARE RECOGNIZED.

SENATOR KINTNER: WELL, THANK YOU, MR. PRESIDENT. YOU KNOW, THE SALVATION OF THE STATE IS THE WATCHFULNESS OF ITS CITIZENS. AND THAT INSCRIPTION IS ON...IT'S THE INSPIRING MOTTO THAT'S CARVED INTO THE MAIN ENTRANCE OF THE CAPITOL. HAVING CITIZENS WATCH AND PARTICIPATE IN THE ACTIONS OF THEIR GOVERNMENT LEADERS IS A HALLMARK OF OUR STATE. THIS IS ESPECIALLY SO IN THE DESIGN OF THE UNICAMERAL SYSTEM. BUT YOU CAN'T HAVE OPEN AND TRANSPARENT LEGISLATURE IF ELECTED OFFICIALS DO NOT MAKE IT EASY FOR CITIZENS TO KNOW HOW THEY VOTE. YOU KNOW, GEORGE NORRIS SAID THAT EVERY ACT

OF THE LEGISLATURE AND EVERY ACT OF EACH INDIVIDUAL MUST BE TRANSACTED IN THE SPOTLIGHT OF PUBLICITY. AND I THINK IT'S ONE AREA THAT WE'VE NOT DONE WELL IN, IS THE ELECTION OF OUR SPEAKER AND CHAIRMAN. AND IF THE PEOPLE ARE TO BE THE SECOND HOUSE, THEY SHOULD BE ABLE TO SEE HOW WE VOTED AND WE NEED TO BE ABLE TO JUSTIFY IT TO THE CITIZENS OF OUR STATE. I THINK THE BEST WAY DO THAT IS TO HAVE OUR RULES COMMITTEE, WHICH IS GOING TO MEET THIS WEEK, TO DO THEIR JOB. AND I'M GOING TO ASK THREE THINGS OF THE LEGISLATURE. FIRST, I'M GOING TO ASK MY FELLOW LEGISLATORS TO VOTE FOR THE TEMPORARY RULES AND TO DO IT QUICKLY. WE'VE GOT A LOT OF WORK TO DO TODAY. SECOND, I'M GOING ASK THOSE NEW MEMBERS OF THE RULES COMMITTEE TO TAKE A SERIOUS LOOK AT PUTTING INTO THE PERMANENT RULES A RECORDED VOTE FOR SPEAKER AND CHAIRMEN SO THAT THAT'S HOW WE DO THESE THINGS FROM NOW ON. I MEAN WE'VE ONLY BEEN DOING THE SECRET BALLOT SINCE 1971; IT'S NOT SOMETHING THAT WAS DESIGNED INTO THE SYSTEM ORIGINALLY. AND THIRD, SINCE THAT'S NOT GOING TO HAPPEN TODAY BECAUSE IT HAS TO GO THROUGH THE RIGHT PROCESS, THAT I SUPPORT, I'M GOING TO REVEAL WHO I VOTED FOR SHORTLY AFTER I VOTE ON THE FLOOR, WITHIN MINUTES, AND I'M GOING TO ENCOURAGE ALL 48 OF MY COLLEAGUES TO DO THE SAME. IT OUGHT BE PRETTY EASY BECAUSE WE HAVE. ON A SIDE NOTE. I WOULD SAY. WE HAVE SOME GREAT, GREAT CANDIDATES FOR OFFICE. AS A MATTER OF FACT, WE DON'T HAVE ANYONE THAT CAN'T DO THE JOB. WHOEVER YOU VOTE FOR. IT WOULD BE VERY EASY TO JUSTIFY TO YOUR CONSTITUENTS, TO THE CITIZENS, AND YOUR FELLOW SENATORS, BECAUSE EVERYONE RUNNING FOR OFFICE, BOTH SPEAKER AND FOR LEADERSHIP OF COMMITTEES, IS FULLY QUALIFIED AND CAN DO A GREAT JOB. AND I AM HOPEFUL THAT I CAN BE OF SERVICE TO YOU AS YOUR SPEAKER AND I THANK YOU FOR YOUR CONSIDERATION. THANK YOU, MR. PRESIDENT.

PRESIDENT NELSON: THE CHAIR RECOGNIZES SENATOR HADLEY.

SENATOR HADLEY: GOOD MORNING, COLLEAGUES. GREAT DAY--LIKE THE FIRST DAY OF SCHOOL. RIGHT? YOU GET ALL CLEANED UP. SHOES SHINED. TROUSERS PRESSED. IT IS AN HONOR TO BE HERE. WE HAD 18 NEW SENATORS. I HOPE YOU ALL GROW TO LOVE THE PLACE AS MUCH AS THE 31 SENATORS THAT HAVE BEEN HERE TWO, FOUR, OR SIX YEARS. IT'S A GREAT INSTITUTION. IT'S A GREAT THIRD PART OF NEBRASKA GOVERNMENT AND A VERY IMPORTANT PART OF NEBRASKA GOVERNMENT. IT WOULD BE A GREAT HONOR TO REPRESENT EACH OF YOU AS YOUR SPEAKER OF THE NEBRASKA LEGISLATURE. I SEE THE POSITION AS A LEADERSHIP POSITION WHOSE PRIMARY RESPONSIBILITY IS TO HELP ALL 48 SENATORS DO THEIR OUTSTANDING WORK FOR THE CITIZENS OF NEBRASKA. I ALSO SEE THE POSITION AS ONE THAT REPRESENTS THE UNIQUE, IMPORTANT LEGISLATIVE BRANCH OF NEBRASKA GOVERNMENT TO THE PEOPLE OF NEBRASKA. WHAT WOULD I BRING IN WAY OF EXPERIENCE TO THIS POSITION? I WAS MAYOR OF THE FIFTH-LARGEST CITY IN NEBRASKA. SERVED ON THE CITY COUNCIL OF THE FIFTH LARGEST-CITY IN NEBRASKA. THEY ACTUALLY ARE A SERVING COMMITTEE, A STANDING COMMITTEE THAT WILL RECEIVE HEARINGS ON LEGISLATIVE BILLS. THE THIRD THING IS THE REFERENCING COMMITTEE. AND THE FOURTH THING IS THE APPOINTMENT OF SPECIAL COMMITTEE MEMBERS. AND I PLEDGE TODAY TO LOOK AT THAT IN THE MOST UNBIASED WAY THAT I POSSIBLY CAN. I PROMISE TO YOU TODAY THAT IN ALL FOUR OF THOSE POSITIONS I WILL DO THE VERY BEST I CAN. WHEN I LOOKED AT THIS POSITION A YEAR AGO AND I DECIDED AT THAT TIME I WANTED TO RUN. I REALLY LOOKED AT THE EXECUTIVE BOARD IN TWO THINGS, JUST THE ADMINISTRATIVE DUTIES THAT I JUST MENTIONED. OUR CLERK'S OFFICE IS HEADS AND SHOULDERS ABOVE THE REST OF THE COUNTRY. THE DIFFERENT DIVISIONS THAT WE HAVE--THE FISCAL OFFICE. THE OMBUDSMAN'S OFFICE, PERFORMANCE AUDIT, THE RESEARCH...LEGISLATIVE RESEARCH--AS I'VE SPENT THE LAST YEAR AND A HALF REALLY WORKING INSIDE THESE DIVISIONS, IT BECOMES SO APPARENT TO ME THAT THAT LEGISLATIVE HISTORY WE HAVE IN THIS BODY IS SECOND TO NONE. AND I

IT HAS PREPARED ME WELL NOT ONLY FOR UNDERSTANDING AGRIBUSINESS BUT WORKING WITH PEOPLE AND BUILDING CONSENSUS AND GROWING COMPANIES AND GROWING AGRICULTURE. I WORKED FOR FARMERS. I HAVE WORKED WITH FARMERS. I'VE BEEN INVOLVED IN BOARDS DEALING WITH AGRICULTURE. DURING THAT SAME TIME, I'VE SERVED ON THREE DIFFERENT RURAL PLANNING AND ZONING BOARDS. DURING THAT TIME FRAME I LED A 4-H CLUB FOR 20 YEARS. I WAS A MEMBER OF THE TRI COUNTY FFA ALUMNI ASSOCIATION. MY HISTORY GOES BACK TO MY BIRTH, THE FOURTH GENERATION INVOLVED IN AGRICULTURE. MY SIX YEARS IN CITY GOVERNMENT. BOTH AS A COUNCIL MEMBER AND COMMITTEE MEMBER AND AS A MAYOR. HELPED ME UNDERSTAND THE BUSINESS OF GOVERNMENT AND AGAIN. PREPARED ME WELL FOR THE LEGISLATURE. I HAVE GOVERNED OVER TAXPAYERS. THEN WHEN FUNDING FOR SENIOR MEALS IN OUR COUNTY WAS CUT BECAUSE OF COUNTY BUDGET, WENT TO BAT AND WE GOT SENIORS' MEALS SUPPORTED AGAIN AT A LOCAL LEVEL AND IT MAINTAINS THEIR PROGRAM TODAY. AND AS YOUR CHAIRMAN OF APPROPRIATIONS FOR THE NEXT TWO YEARS. OUR COMMITTEE WILL CONSIDER THOSE. OUR COMMITTEE WILL HOPEFULLY ACT ON THOSE. BUT WE DON'T DO IN IT A VACUUM. WE DO IT WITH THE EDUCATION COMMITTEE. WE DO IT WITH THE TRANSPORTATION AND TELECOMMUNICATIONS COMMITTEE, THE REVENUE COMMITTEE. ALL THE LEGISLATIVE COMMITTEES HAVE AN IMPACT AND A SAY IN REGARDS TO THE FUTURE OF OUR STATE BUDGET AND THE FUTURE OF OUR STATE FISCAL POLICY. THAT WILL CONTINUE THE NEXT TWO YEARS AND WELL BEYOND THAT. WITH THAT SAID, WE HAVE GOT A LOT OF CHALLENGES AHEAD OF US, COLLEAGUES. YOU DON'T NEED TO HEAR THAT FROM ME AS YOU HAVE HEARD IT FROM CONSTITUENTS; YOU'VE HEARD IT FROM NEW MEMBERS, OLD MEMBERS ALIKE, AS WELL AS A VARIETY OF INTERESTED PARTIES IN THE STATE.
