Explanation of Estimate:

LB 666 creates an exception to the offense of carrying a concealed weapon for possessing, carrying, transporting, shipping, or receiving a firearm for any lawful purpose to or from any place where such firearm may be lawfully possessed or carried by a person if such firearm is unloaded and stored in a case and such person is not otherwise prohibited from possessing such firearm. Carrying a concealed weapon is a class I misdemeanor for the first offense and a class IV felony for a second or subsequent conviction.

NDCS estimates no fiscal impact from LB 666 as the Department has no evidence of any admissions for carrying a concealed weapon by persons carrying an unloaded firearm in a case.
