1 A BILL FOR AN ACT relating to public health and welfare; to amend
2 sections 38-101, 38-121, and 38-186, Reissue Revised Statutes of
3 Nebraska, and section 71-448, Revised Statutes Cumulative
4 Supplement, 2016; to adopt the Dialysis Patient Care Technician
5 Registration Act; to harmonize provisions; to repeal the original
6 sections; and to declare an emergency.
7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Sections 1 to 7 of this act shall be known and may be
2 cited as the Dialysis Patient Care Technician Registration Act.

3 Sec. 2. The purpose of the Dialysis Patient Care Technician
4 Registration Act is to ensure the health, safety, and welfare of the
5 public by providing for the accurate, cost-effective, efficient, and safe
6 utilization of dialysis patient care technicians in the administration of
7 hemodialysis. The act applies to dialysis facilities in which
8 hemodialysis is provided.

9 Sec. 3. For purposes of the Dialysis Patient Care Technician
10 Registration Act:

11 (1) Dialysis patient care technician means a person who meets the
12 requirements of section 5 of this act; and

13 (2) Facility means a health care facility as defined in section
14 71-413 providing hemodialysis services.

15 Sec. 4. A dialysis patient care technician may administer
16 hemodialysis under the authority of a registered nurse licensed pursuant
17 to the Nurse Practice Act who may delegate tasks based on nursing
18 judgment to a dialysis patient care technician based on the technician's
19 education, knowledge, training, and skill.

20 Sec. 5. The minimum requirements for a dialysis patient care
21 technician are as follows: (1) Possession of a high school diploma or a
22 general educational development certificate, (2) training which follows
23 national recommendations for dialysis patient care technicians and is
24 conducted primarily in the work setting, (3) obtaining national
25 certification by successful passage of a certification examination within
26 eighteen months after becoming employed as a dialysis patient care
27 technician, and (4) recertification at intervals required by the
28 organization providing the certification examination including no fewer
29 than thirty and no more than forty patient contact hours since the
30 previous certification or recertification.

31 Sec. 6. (1) To register as a dialysis patient care technician, an

1 individual shall (a) possess a high school diploma or a general
2 educational development certificate, (b) demonstrate that he or she is
3 (i) employed as a dialysis patient care technician or (ii) enrolled in a
4 training course as described in subdivision (2) of section 5 of this act,
5 (c) file an application with the department, and (d) pay the applicable
6 fee.

7 (2) An applicant or a dialysis patient care technician shall report
8 to the department, in writing, any conviction for a felony or
9 misdemeanor. A conviction is not a disqualification for placement on the
10 registry unless it relates to the standards identified in section 5 of
11 this act or it reflects on the moral character of the applicant or
12 dialysis patient care technician.

13 (3) An applicant or a dialysis patient care technician may report
14 any pardon or setting aside of a conviction to the department. If a
15 pardon or setting aside has been obtained, the conviction for which it
16 was obtained shall not be maintained on the Dialysis Patient Care
17 Technician Registry.

18 (4) If a person registered as a dialysis patient care technician
19 becomes licensed as a registered nurse or licensed practical nurse, his
20 or her registration as a dialysis patient care technician becomes null
21 and void as of the date of licensure as a registered nurse or a licensed
22 practical nurse.

23 Sec. 7. (1) The department shall list each dialysis patient care
24 technician registration on the Dialysis Patient Care Technician Registry.
25 A listing in the registry shall be valid for the term of the registration
26 and upon renewal unless such listing is refused renewal or is removed.

27 (2) The registry shall contain the following information on each
28 registrant: (a) The individual's full name; (b) any conviction of a
29 felony or misdemeanor reported to the department; (c) a certificate
30 showing completion of a nationally recognized training program; and (d) a
31 certificate of completion of a nationally commercially available dialysis

1 patient care technician certification examination.

2 (3) Nothing in the Dialysis Patient Care Technician Registration Act
3 shall be construed to require a dialysis patient care technician to
4 register in the Medication Aide Registry.

15 If there is any conflict between any provision of sections 38-101 to
16 38-1,139 and 38-1,141 and any provision of a practice act, the provision
17 of the practice act shall prevail.

18 The Revisor of Statutes shall assign the Uniform Credentialing Act,
19 including the practice acts enumerated in subdivisions (1) through ~~(35)~~
20 ~~(33)~~ of this section, to articles within Chapter 38.

21 Sec. 9. Section 38-121, Reissue Revised Statutes of Nebraska, is
22 amended to read:

23 38-121 (1) No individual shall engage in the following practices
24 unless such individual has obtained a credential under the Uniform
25 Credentialing Act:

- 26 (a) Acupuncture;
- 27 (b) Advanced practice nursing;
- 28 (c) Alcohol and drug counseling;
- 29 (d) Asbestos abatement, inspection, project design, and training;
- 30 (e) Athletic training;
- 31 (f) Audiology;

- 1 (g) Speech-language pathology;
- 2 (h) Body art;
- 3 (i) Chiropractic;
- 4 (j) Cosmetology;
- 5 (k) Dentistry;
- 6 (l) Dental hygiene;
- 7 (m) Electrology;
- 8 (n) Emergency medical services;
- 9 (o) Esthetics;
- 10 (p) Funeral directing and embalming;
- 11 (q) Genetic counseling;
- 12 (r) Hearing instrument dispensing and fitting;
- 13 (s) Lead-based paint abatement, inspection, project design, and

- 15 (t) Licensed practical nurse-certified;
- 16 (u) Massage therapy;
- 17 (v) Medical nutrition therapy;
- 18 (w) Medical radiography;

8 (2) No individual shall hold himself or herself out as any of the
9 following until such individual has obtained a credential under the
10 Uniform Credentialing Act for that purpose:

- 11 (a) Registered environmental health specialist;
- 12 (b) Certified marriage and family therapist;
- 13 (c) Certified professional counselor; ~~or~~
- 14 (d) Social worker; or ~~or~~
- 15 (e) Dialysis patient care technician.

16 (3) No business shall operate for the provision of any of the
17 following services unless such business has obtained a credential under
18 the Uniform Credentialing Act:

- 19 (a) Body art;
- 20 (b) Cosmetology;
- 21 (c) Emergency medical services;
- 22 (d) Esthetics;
- 23 (e) Funeral directing and embalming;
- 24 (f) Massage therapy; or
- 25 (g) Nail technology.

26 Sec. 10. Section 38-186, Reissue Revised Statutes of Nebraska, is
27 amended to read:

28 38-186 (1) A petition shall be filed by the Attorney General in
29 order for the director to discipline a credential obtained under the
30 Uniform Credentialing Act to:

- 31 (a) Practice or represent oneself as being certified under any of

1 the practice acts enumerated in subdivisions (1) through ~~(19)~~ ~~(18)~~ and
2 ~~(21)~~ ~~(20)~~ through ~~(35)~~ ~~(32)~~ of section 38-101; or

3 (b) Operate as a business for the provision of services in body art;
4 cosmetology; emergency medical services; esthetics; funeral directing and
5 embalming; massage therapy; and nail technology in accordance with
6 subsection (3) of section 38-121.

7 (2) The petition shall be filed in the office of the director. The
8 department may withhold a petition for discipline or a final decision
9 from public access for a period of five days from the date of filing the
10 petition or the date the decision is entered or until service is made,
11 whichever is earliest.

12 (3) The proceeding shall be summary in its nature and triable as an
13 equity action and shall be heard by the director or by a hearing officer
14 designated by the director under rules and regulations of the department.
15 Affidavits may be received in evidence in the discretion of the director
16 or hearing officer. The department shall have the power to administer
17 oaths, to subpoena witnesses and compel their attendance, and to issue
18 subpoenas duces tecum and require the production of books, accounts, and
19 documents in the same manner and to the same extent as the district
20 courts of the state. Depositions may be used by either party.

21 Sec. 11. Section 71-448, Revised Statutes Cumulative Supplement,
22 2016, is amended to read:

23 71-448 The Division of Public Health of the Department of Health and
24 Human Services may take disciplinary action against a license issued
25 under the Health Care Facility Licensure Act on any of the following
26 grounds:

27 (1) Violation of any of the provisions of the Assisted-Living
28 Facility Act, the Health Care Facility Licensure Act, the Nebraska
29 Nursing Home Act, or the rules and regulations adopted and promulgated
30 under such acts;

31 (2) Committing or permitting, aiding, or abetting the commission of

1 any unlawful act;

2 (3) Conduct or practices detrimental to the health or safety of a
3 person residing in, served by, or employed at the health care facility or
4 health care service;

5 (4) A report from an accreditation body or public agency
6 sanctioning, modifying, terminating, or withdrawing the accreditation or
7 certification of the health care facility or health care service;

8 (5) Failure to allow an agent or employee of the Department of
9 Health and Human Services access to the health care facility or health
10 care service for the purposes of inspection, investigation, or other
11 information collection activities necessary to carry out the duties of
12 the Department of Health and Human Services;

13 (6) Discrimination or retaliation against a person residing in,
14 served by, or employed at the health care facility or health care service
15 who has submitted a complaint or information to the Department of Health
16 and Human Services;

17 (7) Discrimination or retaliation against a person residing in,
18 served by, or employed at the health care facility or health care service
19 who has presented a grievance or information to the office of the state
20 long-term care ombudsman;

21 (8) Failure to allow a state long-term care ombudsman or an
22 ombudsman advocate access to the health care facility or health care
23 service for the purposes of investigation necessary to carry out the
24 duties of the office of the state long-term care ombudsman as specified
25 in the rules and regulations adopted and promulgated by the Department of
26 Health and Human Services;

27 (9) Violation of the Emergency Box Drug Act or the Pharmacy Practice
28 Act;

29 (10) Failure to file a report required by section 38-1,127 or
30 71-552;

31 (11) Violation of the Medication Aide Act;

1 (12) Failure to file a report of suspected abuse or neglect as
2 required by sections 28-372 and 28-711;~~or~~

3 (13) Violation of the Automated Medication Systems Act;~~or~~

4 (14) Violation of the Dialysis Patient Care Technician Registration
5 Act.

6 Sec. 12. Original sections 38-101, 38-121, and 38-186, Reissue
7 Revised Statutes of Nebraska, and section 71-448, Revised Statutes
8 Cumulative Supplement, 2016, are repealed.

9 Sec. 13. Since an emergency exists, this act takes effect when
10 passed and approved according to law.
