- 1 A BILL FOR AN ACT relating to motor vehicles; to amend sections 60-301,
- 2 60-393, 60-395, 60-396, 60-3,104, and 60-3,130.04, Revised Statutes
- 3 Cumulative Supplement, 2016; to provide for Choose Life License
- 4 Plates; to change provisions relating to personalized message
- 5 license plates; to harmonize provisions; and to repeal the original
- 6 sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-301, Revised Statutes Cumulative Supplement,

- 2 2016, is amended to read:
- 3 60-301 Sections 60-301 to 60-3,231 and sections 7 and 8 of this act
- 4 shall be known and may be cited as the Motor Vehicle Registration Act.
- 5 Sec. 2. Section 60-393, Revised Statutes Cumulative Supplement,
- 6 2016, is amended to read:
- 7 60-393 Any owner who has two or more motor vehicles or trailers
- 8 required to be registered under the Motor Vehicle Registration Act may
- 9 register all such motor vehicles or trailers on a calendar-year basis or
- 10 on an annual basis for the same registration period beginning in a month
- 11 chosen by the owner. When electing to establish the same registration
- 12 period for all such motor vehicles or trailers, the owner shall pay the
- 13 registration fee, the motor vehicle tax imposed in section 60-3,185, the
- 14 motor vehicle fee imposed in section 60-3,190, and the alternative fuel
- 15 fee imposed in section 60-3,191 on each motor vehicle for the number of
- 16 months necessary to extend its current registration period to the
- 17 registration period under which all such motor vehicles or trailers will
- 18 be registered. Credit shall be given for registration paid on each motor
- 19 vehicle or trailer when the motor vehicle or trailer has a later
- 20 expiration date than that chosen by the owner except as otherwise
- 21 provided in sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128,
- 22 60-3,224, and 60-3,227 and section 8 of this act. Thereafter all such
- 23 motor vehicles or trailers shall be registered on an annual basis
- 24 starting in the month chosen by the owner.
- 25 Sec. 3. Section 60-395, Revised Statutes Cumulative Supplement,
- 26 2016, is amended to read:
- 27 60-395 (1) Except as otherwise provided in subsection (2) of this
- 28 section and sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128,
- 29 60-3,224, and 60-3,227 and section 8 of this act, the registration shall
- 30 expire and the registered owner or lessee may, by returning the
- 31 registration certificate, the license plates, and, when appropriate, the

- 1 validation decals and by either making application on a form prescribed
- 2 by the department to the county treasurer of the occurrence of an event
- 3 described in subdivisions (a) through (e) of this subsection or, in the
- 4 case of a change in situs, displaying to the county treasurer the
- 5 registration certificate of such other state as evidence of a change in
- 6 situs, receive a refund of that part of the unused fees and taxes on
- 7 motor vehicles or trailers based on the number of unexpired months
- 8 remaining in the registration period from the date of any of the
- 9 following events:
- (a) Upon transfer of ownership of any motor vehicle or trailer;

- (c) When a salvage branded certificate of title is issued;
- 14 (d) Whenever a type or class of motor vehicle or trailer previously
- 15 registered is subsequently declared by legislative act or court decision
- 16 to be illegal or ineligible to be operated or towed on the public roads
- 17 and no longer subject to registration fees, the motor vehicle tax imposed
- in section 60-3,185, the motor vehicle fee imposed in section 60-3,190,
- 19 and the alternative fuel fee imposed in section 60-3,191;
- (e) Upon a trade-in or surrender of a motor vehicle under a lease;
- 21 or
- 22 (f) In case of a change in the situs of a motor vehicle or trailer
- 23 to a location outside of this state.
- 24 (2) If the date of the event falls within the same calendar month in
- 25 which the motor vehicle or trailer is acquired, no refund shall be
- 26 allowed for such month.
- 27 (3) If the transferor or lessee acquires another motor vehicle at
- 28 the time of the transfer, trade-in, or surrender, the transferor or
- 29 lessee shall have the credit provided for in this section applied toward
- 30 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 31 transferor or lessee shall file a claim for refund with the county

- 1 treasurer upon an application form prescribed by the department.
- 2 (4) The registered owner or lessee shall make a claim for refund or
- 3 credit of the fees and taxes for the unexpired months in the registration
- 4 period within sixty days after the date of the event or shall be deemed
- 5 to have forfeited his or her right to such refund or credit.
- 6 (5) For purposes of this section, the date of the event shall be:
- 7 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 8 (b) in the case of a change in the situs, the date of registration in
- 9 another state; (c) in the case of a trade-in or surrender under a lease,
- 10 the date of trade-in or surrender; (d) in the case of a legislative act,
- 11 the effective date of the act; and (e) in the case of a court decision,
- 12 the date the decision is rendered.
- 13 (6) Application for registration or for reassignment of license
- 14 plates and, when appropriate, validation decals to another motor vehicle
- or trailer shall be made within thirty days of the date of purchase.
- 16 (7) If a motor vehicle or trailer was reported stolen under section
- 17 60-178, a refund under this section shall not be reduced for a lost plate
- 18 charge and a credit under this section may be reduced for a lost plate
- 19 charge but the applicant shall not be required to pay the plate fee for
- 20 new plates.
- 21 (8) The county treasurer shall refund the motor vehicle fee and
- 22 registration fee from the fees which have not been transferred to the
- 23 State Treasurer. The county treasurer shall make payment to the claimant
- 24 from the undistributed motor vehicle taxes of the taxing unit where the
- 25 tax money was originally distributed. No refund of less than two dollars
- 26 shall be paid.
- 27 Sec. 4. Section 60-396, Revised Statutes Cumulative Supplement,
- 28 2016, is amended to read:
- 29 60-396 Whenever the registered owner files an application with the
- 30 county treasurer showing that a motor vehicle or trailer is disabled and
- 31 has been removed from service, the registered owner may, by returning the

registration certificate, the license plates, and, when appropriate, the 1 2 validation decals or, in the case of the unavailability of such registration certificate or certificates, license plates, or validation 3 4 decals, then by making an affidavit to the county treasurer of such 5 disablement and removal from service, receive a credit for a portion of the registration fee from the fee deposited with the State Treasurer at 6 the time of registration based upon the number of unexpired months 7 remaining in the registration year except as otherwise provided in 8 9 sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128, 60-3,224, and 10 60-3,227 and section 8 of this act. The owner shall also receive a credit for the unused portion of the motor vehicle tax and fee based upon the 11 number of unexpired months remaining in the registration year. When the 12 owner registers a replacement motor vehicle or trailer at the time of 13 14 filing such affidavit, the credit may be immediately applied against the registration fee and the motor vehicle tax and fee for the replacement 15 16 motor vehicle or trailer. When no such replacement motor vehicle or trailer is so registered, the county treasurer shall forward the 17 application and affidavit, if any, to the State Treasurer who shall 18 19 determine the amount, if any, of the allowable credit for the registration fee and issue a credit certificate to the owner. For the 20 motor vehicle tax and fee, the county treasurer shall determine the 21 amount, if any, of the allowable credit and issue a credit certificate to 22 the owner. When such motor vehicle or trailer is removed from service 23 24 within the same month in which it was registered, no credits shall be 25 allowed for such month. The credits may be applied against taxes and fees for new or replacement motor vehicles or trailers incurred within one 26 year after cancellation of registration of the motor vehicle or trailer 27 for which the credits were allowed. When any such motor vehicle or 28 trailer is reregistered within the same registration year in which its 29 registration has been canceled, the taxes and fees shall be that portion 30 of the registration fee and the motor vehicle tax and fee for the 31

- 16 registration under section 60-3,130 may use a license plate or plates
- 17 designed by this state in the year corresponding to the model year when
- 18 the vehicle was manufactured in lieu of the plates designed pursuant to
- 19 section 60-3,130.03 subject to the approval of the department. The
- 20 department shall inspect the plate or plates and may approve the plate or
- 21 plates if it is determined that the model-year license plate or plates
- 22 are legible and serviceable and that the license plate numbers do not
- 23 conflict with or duplicate other numbers assigned and in use. An
- 24 original-issued license plate or plates that have been restored to
- 25 original condition may be used when approved by the department.

- 12 as Choose Life License Plates. The department shall create designs
- 13 <u>reflecting support for the protection of Nebraska's children. The design</u>
- 14 shall be selected on the basis of limiting the manufacturing cost of each
- 15 plate to an amount less than or equal to the amount charged for license
- 16 plates pursuant to section 60-3,102. The department shall make
- 17 applications available for this type of plate beginning January 1, 2018.
- 18 The department may adopt and promulgate rules and regulations to carry
- 19 <u>out this section and section 8 of this act.</u>
- 20 (2) One type of Choose Life License Plates shall be alphanumeric

1 registered under section 60-3,198. An applicant receiving a Choose Life

- 2 <u>License Plate for a farm truck with a gross weight of over sixteen tons</u>

- 4 or over shall affix the appropriate tonnage decal to the plate. The
- 5 department shall make forms available for such applications through the
- 6 <u>county treasurers</u>. The license plates shall be issued upon payment of the
- 7 license fee described in subsection (2) of this section.
- 8 (2)(a) In addition to all other fees required for registration under
- 9 the Motor Vehicle Registration Act, each application for initial issuance
- 10 of alphanumeric Choose Life License Plates shall be accompanied by a fee
- 11 of five dollars. An application for renewal of such plates shall be
- 12 accompanied by a fee of five dollars. County treasurers collecting fees
- 13 pursuant to this subdivision shall remit them to the State Treasurer. The
- 14 State Treasurer shall credit five dollars of the fee to the Health and
- 15 <u>Human Services Cash Fund to supplement federal funds available to the</u>
- 16 Department of Health and Human Services for the Temporary Assistance for
- 17 <u>Needy Families program, 42 U.S.C. 601, et seq.</u>
- 18 (b) In addition to all other fees required for registration under
- 19 the Motor Vehicle Registration Act, each application for initial issuance
- 20 or renewal of personalized message Choose Life License Plates shall be
- 21 accompanied by a fee of forty dollars. County treasurers collecting fees
- 22 pursuant to this subdivision shall remit them to the State Treasurer. The
- 23 State Treasurer shall credit twenty-five percent of the fee for initial
- 24 issuance and renewal of such plates to the Department of Motor Vehicles
- 25 Cash Fund and seventy-five percent of the fee to the Health and Human
- 26 Services Cash Fund to supplement federal funds available to the
- 27 <u>Department of Health and Human Services for the Temporary Assistance for</u>
- 28 Needy Families program.
- 29 (3) When the department receives an application for Choose Life
- 30 License Plates, the department shall deliver the plates to the county
- 31 treasurer of the county in which the motor vehicle or trailer is

1 registered. The county treasurer shall issue Choose Life License Plates

- 2 <u>in lieu of regular license plates when the applicant complies with the</u>
- 3 other provisions of the Motor Vehicle Registration Act for registration
- 4 of the motor vehicle or trailer. If Choose Life License Plates are lost,
- 5 stolen, or mutilated, the licensee shall be issued replacement license
- 6 plates upon request pursuant to section 60-3,157.
- 7 (4) The owner of a motor vehicle or trailer bearing Choose Life
- 8 License Plates may apply to the county treasurer to have such plates
- 9 transferred to a motor vehicle other than the vehicle for which such
- 10 plates were originally purchased if such vehicle is owned by the owner of
- 11 the plates. The owner may have the unused portion of the fee for the
- 12 plates credited to the other vehicle which will bear the plates at the
- 13 rate of eight and one-third percent per month for each full month left in
- 14 the registration period. Application for such transfer shall be
- 15 <u>accompanied by a fee of three dollars. Fees collected pursuant to this</u>
- 16 subsection shall be remitted to the State Treasurer for credit to the
- 17 Department of Motor Vehicles Cash Fund.
- 18 (5) If the cost of manufacturing Choose Life License Plates at any
- 19 time exceeds the amount charged for license plates pursuant to section
- 20 <u>60-3,102, any money to be credited to the Health and Human Services Cash</u>
- 21 Fund to supplement federal funds available to the Department of Health
- 22 and Human Services for the Temporary Assistance for Needy Families
- 23 program shall instead be credited first to the Highway Trust Fund in an
- 24 amount equal to the difference between the manufacturing costs of Choose
- 25 Life License Plates and the amount charged pursuant to section 60-3,102
- 26 with respect to such plates and the remainder shall be credited to the
- 27 Health and Human Services Cash Fund to supplement federal funds available
- 28 to the Department of Health and Human Services for the Temporary
- 29 <u>Assistance for Needy Families program.</u>

- 31 and 60-3,130.04, Revised Statutes Cumulative Supplement, 2016, are
