- 1 A BILL FOR AN ACT relating to county officers; to amend sections 32-101,
- 2 32-517, 32-518, 32-519, 32-520, 32-521, 32-522, 32-523, 32-524,
- 3 32-525, 32-526, 32-528, and 32-529, Reissue Revised Statutes of
- 4 Nebraska; to authorize voters to vote regarding partisan or
- 5 nonpartisan ballots for nomination and election of county officers;
- to harmonize provisions; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-101, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 32-101 Sections 32-101 to 32-1551 and section 2 of this act shall be
- 4 known and may be cited as the Election Act.
- 5 Sec. 2. (1) All county officers elected pursuant to sections 32-517
- 6 to 32-529 shall be nominated and elected on a partisan ballot except as
- 7 otherwise provided in this section.
- 8 (2) A county board may adopt a resolution requiring the submission
- 9 of the question to the voters of the county regarding nomination and
- 10 <u>election of all officers elected pursuant to sections 32-517 to 32-529 on</u>
- 11 <u>a nonpartisan ballot. The registered voters of a county may file a</u>
- 12 petition with the county clerk requesting the submission of the question
- 13 to the voters regarding nomination and election of all officers elected
- 14 pursuant to sections 32-517 to 32-529 on a nonpartisan ballot. The
- 15 question shall be submitted at the first statewide general election held
- 16 at least sixty days after the adoption of the resolution or the
- 17 <u>verification of signatures of registered voters of the county on such</u>
- 18 petition equal in number to at least five percent of the registered
- 19 voters in the county at the preceding statewide general election.
- 20 (3) If the vote on the question is in favor of the nomination and
- 21 election of all officers elected pursuant to sections 32-517 to 32-529 on
- 22 a nonpartisan ballot, such officers shall be so nominated and elected at
- 23 all subsequent elections except as provided in subsection (4) of this
- 24 section.
- 25 (4) The question may be submitted to the voters to change the
- 26 nomination and election of all officers elected pursuant to sections
- 27 <u>32-517 to 32-529 from the nonpartisan ballot to the partisan ballot in</u>
- 28 the same manner as provided in subsection (2) of this section.
- 29 (5) The question of changing the nomination and election of all
- 30 officers elected pursuant to sections 32-517 to 32-529 shall not be
- 31 submitted to the voters more often than once every three years.

The county assessor shall serve for a term of four years.

- (2) The county board of any county shall order the submission of the 8 9 question of electing a county assessor in the county to the registered voters of the county at the next statewide general election upon 10 presentation of a petition to the county board (a) conforming to the 11 provisions of section 32-628, (b) not less than sixty days before any 12 statewide general election, (c) signed by at least ten percent of the 13 registered voters of the county secured in not less than two-fifths of 14 the townships or precincts of the county, and (d) asking that the 15 question be submitted to the registered voters in the county. The form of 16 17 submission upon the ballot shall be as follows: For election of county assessor; Against election of county assessor. If a majority of the votes 18 19 cast on the question are against the election of a county assessor in such county, the duties of the county assessor shall be performed by the 20 county clerk and the office of county assessor shall either cease with 21 22 the expiration of the term of the incumbent or continue to be abolished if no such office exists at such time. If a majority of the votes cast on 23 24 the question are in favor of the election of a county assessor, the 25 office shall continue or a county assessor shall be elected at the next statewide general election. 26

- 6 sheriff shall be elected on the partisan ballot.

- 16 commissioners, one commissioner shall be elected in each odd-numbered

- 6 inhabitants as determined by the most recent federal decennial census,
- 7 one commissioner shall be nominated and elected from each district by the

- 9 (b) In counties having a population of more than one hundred fifty
- 10 thousand but not more than four hundred thousand inhabitants as
- 11 determined by the most recent federal decennial census, one commissioner
- 12 shall be nominated and elected from each district by the registered
- 13 voters of the district as provided in subsection (5) of this section.
- 14 (c) In counties having more than four hundred thousand inhabitants
- 15 as determined by the most recent federal decennial census, one
- 16 commissioner shall be nominated and elected from each district by the
- 17 registered voters of the district.
- 18 (4) In counties in which a majority has voted to have five
- 19 commissioners as provided in section 23-148, the three commissioners of
- 20 such county whose terms of office will expire after the election shall
- 21 continue in office until the expiration of the terms for which they were
- 22 elected and until their successors are elected and qualified. Two

- 5 nominated from each odd-numbered district, and at the ensuing general
- 6 election, one commissioner shall be elected from each odd-numbered
- 7 district. Their successors shall be nominated and elected every four
- 8 years thereafter; and
- 9 (b) At the primary election in 2012, one commissioner shall be
- 10 nominated from each even-numbered district, and at the ensuing general
- 11 election, one commissioner shall be elected from each even-numbered
- 12 district. Their successors shall be nominated and elected every four
- 13 years thereafter.
- 14 Sec. 14. Section 32-529, Reissue Revised Statutes of Nebraska, is
- 15 amended to read:
- 16 32-529 At the first general election after the adoption of township
- 17 organization by a county, one supervisor shall be elected in each
- 18 supervisor district. Thereafter one supervisor shall be elected in each
- 19 odd-numbered supervisor district at the general election two years after
- 20 the first general election and each four years thereafter, and one
- 21 supervisor shall be elected in each even-numbered supervisor district at
- 22 the general election four years after the first general election and each
- 23 four years thereafter. Each county supervisor shall be nominated and
- 24 elected by the registered voters of the district from which he or she is
- 25 elected. Except for supervisors first elected after the county has
- 26 adopted township organization, the term of each county supervisor shall
- 27 be four years or until his or her successor is elected and qualified. The
- 28 county supervisors shall meet the qualifications found in section 23-268.
- 29 The county supervisors shall be elected on the partisan ballot.
