- A BILL FOR AN ACT relating to the Address Confidentiality Act; to amend sections 42-1203, 42-1204, and 43-1209, Reissue Revised Statutes of Nebraska, and section 81-1429.02, Revised Statutes Cumulative Supplement, 2016; to define a term; to provide for application formats as prescribed; to provide powers and duties; to change provisions relating to a fund; to provide for a transfer of funds; to harmonize provisions; to repeal the original sections; and to
- 9 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 42-1203, Reissue Revised Statutes of Nebraska, is

- 3 42-1203 For purposes of the Address Confidentiality Act:
- 4 (1) Abuse means causing or attempting to cause physical harm,
- 5 placing another person in fear of physical harm, or causing another
- 6 person to engage involuntarily in sexual activity by force, threat of
- 7 force, or duress, when committed by (a) a person against his or her
- 8 spouse, (b) a person against his or her former spouse, (c) a person
- 9 residing with the victim if such person and the victim are or were in a
- 10 dating relationship, (d) a person who formerly resided with the victim if
- 11 such person and the victim are or were in a dating relationship, (e) a
- 12 person against a parent of his or her children, whether or not such
- 13 person and the victim have been married or resided together at any time,
- 14 (f) a person against a person with whom he or she is in a dating
- 15 relationship, (g) a person against a person with whom he or she formerly
- 16 was in a dating relationship, or (h) a person related to the victim by
- 17 consanguinity or affinity;
- 18 (2) Address means a residential street address, school address, or
- 19 work address of an individual as specified on the individual's
- 20 application to be a program participant;
- 21 (3) Dating relationship means an intimate or sexual relationship;
- 22 (4) Program participant means a person certified as a program
- 23 participant under section 42-1204;
- 24 (5) Sexual assault has the same meaning as in section 28-319,
- 25 28-319.01, 28-320, 28-320.01, or 28-386; and
- 26 (6) Stalking has the same meaning as in sections 28-311.02 to
- 27 28-311.05; and -
- 28 (7) Trafficking victim has the same meaning as in section 28-830.
- 29 Sec. 2. Section 42-1204, Reissue Revised Statutes of Nebraska, is
- 30 amended to read:
- 31 42-1204 (1) An adult, a parent or guardian acting on behalf of a

- 1 minor, or a guardian acting on behalf of an incapacitated person as
- 2 defined in section 30-2601 may apply to the Secretary of State to have an
- 3 address designated by the Secretary of State serve as the substitute
- 4 address of such adult, minor, or incapacitated person. The Secretary of
- 5 State shall approve an application if it is filed in the manner and on
- 6 the form prescribed by the Secretary of State and if it contains:
- 7 (a) A sworn statement by the applicant that the applicant has good
- 8 reason to believe (i) that the applicant, or the minor or incapacitated
- 9 person on whose behalf the application is made, is a victim of abuse,
- 10 sexual assault, or stalking or is a trafficking victim and (ii) that the
- 11 applicant fears for his or her safety, his or her children's safety, or
- 12 the safety of the minor or incapacitated person on whose behalf the
- 13 application is made;
- 14 (b) A designation of the Secretary of State as agent for purposes of
- 15 service of process and receipt of mail;
- 16 (c) The mailing address and the telephone number or numbers where
- 17 the applicant can be contacted by the Secretary of State;
- 18 (d) The new address or addresses that the applicant requests not be
- 19 disclosed for the reason that disclosure will increase the risk of abuse,
- 20 sexual assault, or stalking, or trafficking; and
- 21 (e) The signature of the applicant and of any individual or
- 22 representative of any office designated in writing under section 42-1209
- 23 who assisted in the preparation of the application and the date on which
- 24 the applicant signed the application.
- 25 (2) Applications shall be filed in the office of the Secretary of
- 26 State.
- 27 (3) Upon filing a properly completed application, the Secretary of
- 28 State shall certify the applicant as a program participant. Such
- 29 certification shall be valid for four years following the date of filing
- 30 unless the certification is withdrawn or invalidated before that date.
- 31 The Secretary of State may by rule and regulation establish a renewal

- 1 procedure.
- 2 (4) A person who falsely attests in an application that disclosure
- 3 of the applicant's address would endanger the applicant, the applicant's
- 4 children, or the minor or incapacitated person on whose behalf the
- 5 application is made, or who knowingly provides false or incorrect
- 6 information upon making an application, is quilty of a Class II
- 7 misdemeanor.
- 8 Sec. 3. Section 42-1209, Reissue Revised Statutes of Nebraska, is
- 9 amended to read:
- 10 42-1209 The Secretary of State shall designate state and local
- 11 agencies and nonprofit entities that provide counseling and shelter
- 12 services to victims of abuse, sexual assault, or stalking or trafficking
- 13 <u>victims</u> to assist persons applying to be program participants. Any
- 14 assistance or counseling rendered by the office of the Secretary of State
- or its designees to such applicants shall not be deemed legal advice or
- 16 the practice of law.
- 17 Sec. 4. Section 81-1429.02, Revised Statutes Cumulative Supplement,
- 18 2016, is amended to read:
- 19 81-1429.02 The Human Trafficking Victim Assistance Fund is created.
- 20 The fund shall contain money donated as gifts, bequests, or other
- 21 contributions from public or private entities. Funds made available by
- 22 any department or agency of the United States may also be credited to the
- 23 fund if so directed by such department or agency. The fund shall be
- 24 administered by the Nebraska Commission on Law Enforcement and Criminal
- 25 Justice. All money credited to such fund shall be used to support care,
- 26 treatment, and other services for victims of human trafficking and
- 27 commercial sexual exploitation of a child. Any money in the fund
- 28 available for investment shall be invested by the state investment
- 29 officer pursuant to the Nebraska Capital Expansion Act and the Nebraska
- 30 State Funds Investment Act.
- 31 Sec. 5. On July 1, 2017, the State Treasurer shall transfer [XX

- 4 Sec. 6. Original sections 42-1203, 42-1204, and 42-1209, Reissue
- 5 Revised Statutes of Nebraska, and section 81-1429.02, Revised Statutes
- 6 Cumulative Supplement, 2016, are repealed.
- 7 Sec. 7. Since an emergency exists, this act takes effect when
- 8 passed and approved according to law.
