















#### Chart 1: Statewide percentage of monthly visits with parent, child and provider




#### Chart 2: Percentage of visits with parent, child and provider by service area;








#### Wards in residential treatment settings by service area


#### Wards in Residential Treatment Settings by Age


#### Wards in residential treatment settings by gender





For any individual involved in the child welfare system receiving a service or a placement through the department or its agent for which referral is necessary, the date when such referral was made by the department or its agent and the date and the method by which the individual receiving the services was notified of such referral. To the extent the department becomes aware of the date when individual receiving the referral began receiving such services, the department or its agent shall document such date.

Data is not available. Heritage Health plans can track referral dates for specialty care; however, there is no accurate methodology to track the date and the method by which the individual receiving the service was notified of such referral.

8. This report is to comply with the requirement of Nebraska Revised Statutes 71-1904 for an annual report to the Legislature regarding the waiver of training requirements for relative foster care. The statute specifically requires the Department to report the number of waivers granted and the total number of children placed in relative foster homes.

During the state fiscal year 2020, the Department of Health and Human Services had 419 licensed relative foster homes. Of the 419 homes, 357 of them had a waiver granted. There were a total of 289 children placed in relative foster homes with a waiver.
