1 A BILL FOR AN ACT relating to the Nebraska Children's Commission; to amend sections 43-4201, 43-4202, 43-4204, 43-4206, 43-4216, 43-4217, 2 3 and 68-1212, Reissue Revised Statutes of Nebraska, and sections 4 43-4203, 43-4207, 43-4218, 43-4513, and 43-4701, Revised Statutes Cumulative Supplement, 2018; to provide, change, and eliminate 5 6 administration, membership, and duties of the commission; to change 7 and eliminate reporting requirements; to harmonize provisions; to 8 eliminate obsolete provisions; to provide an operative date; to 9 repeal the original sections; to outright repeal sections 43-4205, 43-4208, 43-4209, 43-4210, 43-4211, 43-4213, and 43-4214, Reissue 10 Revised Statutes of Nebraska; and to declare an emergency. 11 12 Be it enacted by the people of the State of Nebraska,

Section 1. Section 43-4201, Reissue Revised Statutes of Nebraska, is
 amended to read:

3 43-4201 (1) The Legislature finds and declares that:

4 (a) The Health and Human Services Committee of the Legislature
5 documented serious problems with the child welfare system in its 2011
6 report of the study that was conducted under Legislative Resolution 37,
7 One Hundred Second Legislature, First Session, 2011;

8 (b) Improving the safety and well-being of Nebraska's children and 9 families is a critical priority which must guide policy decisions in a 10 variety of areas;

(c) To improve the safety and well-being of children and families in Nebraska, the legislative, judicial, and executive branches of government must work together to ensure:

(i) The integration, coordination, and accessibility of all services
provided <u>to children and families</u> by the state, whether directly or
pursuant to contract;

17 (ii) Reasonable access to appropriate services statewide and18 efficiency in service delivery; and

(iii) The availability of accurate and complete data as well as
ongoing data analysis to identify important trends and problems as they
arise; and

(d) As the primary state agency serving children and families, the Department of Health and Human Services must exemplify leadership, responsiveness, transparency, and efficiency and program managers within the agency must strive cooperatively to ensure that their programs view the needs of children and families comprehensively as a system rather than individually in isolation, including pooling funding when possible and appropriate.

(2) It is the intent of the Legislature in creating the Nebraska
Children's Commission to provide for the needs identified in subsection
(1) of this section, to provide <u>strategic priorities for research or</u>

policy development within a broad restructuring of the goals of the child welfare system and juvenile justice systems, and to provide a structure to the commission that maintains the framework of the three branches of government and their respective powers and duties.

5 Sec. 2. Section 43-4202, Reissue Revised Statutes of Nebraska, is 6 amended to read:

7 43-4202 (1) The Nebraska Children's Commission is created as a high-8 level leadership body to (a) create a statewide strategic plan for reform 9 of child welfare and juvenile justice programs and services in the State 10 of Nebraska, (b) review the operations of the Department of Health and Human Services regarding child welfare programs and services and 11 12 recommend, as a part of the statewide strategic plan, options for 13 attaining the legislative intent stated in section 43-4201, either by the establishment of a new division within the department or the 14 15 establishment of a new state agency to provide all child welfare programs and services which are the responsibility of the state, and (c) monitor 16 17 and evaluate the child welfare and juvenile justice systems. The 18 commission shall provide a permanent forum for collaboration among state, local, community, public, and private stakeholders in child welfare and 19 juvenile justice programs and services. 20

(2) The commission shall include the following voting members:

(a) The chairperson of the Health and Human Services Committee of
 the Legislature or a member of such committee designated by such
 chairperson;

(b) The chairperson of the Judiciary Committee of the Legislature or

30 (d) Two additional members of the Legislature appointed by the

1	(3) The voting members of the commission shall meet within sixty
2	<u>days after July 1, 2019, and shall select from among its members a</u>
3	chairperson and vice-chairperson and conduct any other business necessary
4	to the commission. The commission shall meet not less often than once
5	every three months, and meetings of the commission may be held at any
6	time on the call of the chairperson. The commission may hire staff to
7	carry out the responsibilities of the commission.
8	<u>(4)</u> (2) The commission shall include the following <u>nonvoting</u> voting
9	members who shall serve in an advisory capacity based on their expertise

27	members appointed pursuant to this subdivision shall represent
28	stakeholders with experience in the child welfare and juvenile justice
29	systems <u>as designated by the commission.</u> and shall include: (i) A
30	director of a child advocacy center; (ii) an administrator of a
31	behavioral health region established pursuant to section 71-807; (iii) a

community representative from each of the service areas designated 1 2 pursuant to section 81-3116. In the eastern service area designated 3 pursuant to such section, the representative may be from a lead agency of 4 a pilot project established under section 68-1212 or a collaborative 5 member; (iv) a prosecuting attorney who practices in juvenile court; (v) 6 a guardian ad litem; (vi) a biological parent currently or previously 7 involved in the child welfare system or juvenile justice system; (vii) a foster parent; (viii) a court appointed special advocate volunteer; (ix) 8 9 a member of a local foster care review board; (x) a child welfare service 10 agency that directly provides a wide range of child welfare services and 11 is not a member of a lead agency collaborative; (xi) a young adult 12 previously in foster care; (xii) a representative of a child advocacy 13 organization that deals with legal and policy issues that include child 14 welfare; and (xiii) a representative of a federally recognized Indian 15 tribe residing within the State of Nebraska and appointed within thirty 16 days after June 5, 2013, from a list of three nominees submitted by the 17 Commission on Indian Affairs.

18 (3) The Nebraska Children's Commission shall have the following 19 nonvoting, ex officio members: (a) The chairperson of the Health and 20 Human Services Committee of the Legislature or a committee member 21 designated by the chairperson; (b) the chairperson of the Judiciary 22 Committee of the Legislature or a committee member designated by the chairperson; (c) the chairperson of the Appropriations Committee of the 23 24 Legislature or a committee member designated by the chairperson; (d) 25 three persons appointed by the State Court Administrator; (e) the chief executive officer of the Department of Health and Human Services or his 26 27 or her designee; (f) the Director of Children and Family Services of the 28 Division of Children and Family Services of the Department of Health and Human Services or his or her designee; (g) the Commissioner of Education 29 30 or his or her designee; and (h) the Inspector General of Nebraska Child Welfare. 31

1 (5) The nonvoting, ex officio members may attend commission meetings 2 and participate in the discussions of the commission, provide information 3 to the commission on the policies, programs, and processes within their 4 areas of expertise of each of their respective bodies, and gather 5 information for the commission, and provide information back to their respective bodies from the commission. The nonvoting, ex officio members 6 7 shall not vote on decisions by the commission or on the direction or development of the statewide strategic plan pursuant to section 43-4204. 8

9 (4) The commission shall meet within sixty days after April 12, 10 2012, and shall select from among its members a chairperson and vice-11 chairperson and conduct any other business necessary to the organization 12 of the commission. The commission shall meet not less often than once 13 every three months, and meetings of the commission may be held at any 14 time on the call of the chairperson. The commission may hire staff to 15 carry out the responsibilities of the commission.

16 <u>(6)</u> For administrative purposes, the offices of the staff of the 17 commission shall be located in the <u>office of Public Counsel</u> Foster Care 18 Review Office. The commission may hire a consultant with experience in 19 facilitating strategic planning to provide neutral, independent 20 assistance in updating the statewide strategic plan. The commission shall 21 terminate on June 30, 2019, unless continued by the Legislature.

22 (7) (5) The office of Public Counsel commission, with assistance 23 from the commission and approval of the voting members of the commission 24 executive director of the Foster Care Review Office, shall employ a policy analyst to provide research and expertise to the commission 25 relating to the child welfare system. The policy analyst shall work in 26 conjunction with the staff of the commission. His or her responsibilities 27 28 may include, but are not limited to: (a) Monitoring the Nebraska child welfare system and juvenile justice system to provide information to the 29 commission; (b) analyzing child welfare and juvenile justice public 30 31 policy through research and literature reviews and drafting policy

reports when requested; (c) managing or leading projects or tasks and providing resource support to commission members and committees as determined by the chairperson of the commission; (d) serving as liaison among child welfare and juvenile justice stakeholders and the public and responding to information inquiries as required; and (e) other duties as assigned by the commission.

7 <u>(8)</u> (6) Members of the commission shall be reimbursed for their 8 actual and necessary expenses as members of such commission as provided 9 in sections 81-1174 to 81-1177. No member of the commission shall have 10 any private financial interest, profit, or benefit from any work of the 11 commission.

Sec. 3. Section 43-4203, Revised Statutes Cumulative Supplement, and 2018, is amended to read:

43-4203 (1) Any committee or subcommittee created by the Nebraska
Children's Commission shall include representatives from all three
branches of government, and the representatives from the executive and
judicial branches of government shall be nonvoting, ex officio members.
Committees and subcommittees may collaborate with subject matter experts
to assist in the work of the commission.

(2) The commission shall create a committee to examine state policy
 regarding the prescription of psychotropic drugs for children who are
 wards of the state and the administration of such drugs to such children.
 Such committee shall review the policy and procedures for prescribing and
 administering such drugs and make recommendations to the commission for
 changes in such policy and procedures.

26 (3) The commission shall create a committee to examine the Office of 27 Juvenile Services and the Juvenile Services Division of the Office of 28 Probation Administration. 30 (c) Evidence-based training requirements for persons who work in the

3 <u>(6) The Foster Care Reimbursement Rate Committee created pursuant to</u> 4 <u>section 43-4216, the Nebraska Strengthening Families Act Committee</u> 5 <u>created pursuant to section 12 of this act, and the Bridge to</u> 6 <u>Independence Advisory Committee created pursuant to section 43-4513 are</u> 7 <u>under the jurisdiction of the commission.</u>

8 <u>(7) The commission shall work with the office of the State Court</u> 9 <u>Administrator, as appropriate, and entities which coordinate facilitated</u> 10 <u>conferencing as described in section 43-247.03.</u>

(8) The Nebraska Children's Commission shall work with 11 administrators from each of the service areas designated pursuant to 12 section 81-3116, the teams created pursuant to section 28-728, local 13 foster care review boards, child advocacy centers, the teams created 14 15 pursuant to the Supreme Court's Through the Eyes of the Child Initiative, community stakeholders, and advocates for child welfare programs and 16 17 services to establish networks in each of such service areas. Such networks shall permit collaboration to strengthen the continuum of 18 19 services available to child welfare agencies and to provide resources for children and juveniles outside the child protection system. 20

21 (9) The commission may organize subcommittees as it deems necessary. 22 Members of the subcommittees may be members of the commission or may be individuals who have knowledge of the subcommittee's subject matter, 23 24 professional expertise to assist the subcommittee in completing its 25 assigned responsibilities, or the ability to collaborate within the subcommittee and with the commission to carry out the powers and duties 26 27 of the commission. Subcommittees shall meet as necessary to complete the work delegated by the commission and shall report its findings to the 28 relevant committee within the commission. 29

30 (10) No member of any committee or subcommittee created pursuant to
 31 this section shall have any private financial interest, profit, or

benefit from any work of such committee or subcommittee.

2 (1) The Nebraska Children's Commission shall work with 3 administrators from each of the service areas designated pursuant to 4 section 81-3116, the teams created pursuant to section 28-728, local 5 foster care review boards, child advocacy centers, the teams created 6 pursuant to the Supreme Court's Through the Eyes of the Child Initiative, 7 community stakeholders, and advocates for child welfare programs and services to establish networks in each of such service areas. Such 8 9 networks shall permit collaboration to strengthen the continuum of 10 services available to child welfare agencies and to provide resources for children and juveniles outside the child protection system. Each service 11 12 area shall develop its own unique strategies to be included in the 13 statewide strategic plan. The Department of Health and Human Services shall assist in identifying the needs of each service area. 14

15 (2)(a) The commission shall create a committee to examine state 16 policy regarding the prescription of psychotropic drugs for children who 17 are wards of the state and the administration of such drugs to such 18 children. Such committee shall review the policy and procedures for 19 prescribing and administering such drugs and make recommendations to the 20 commission for changes in such policy and procedures.

21 (b) The commission shall create a committee to examine the Office of 22 Juvenile Services and the Juvenile Services Division of the Office of 23 Probation Administration. Such committee shall review the role and 24 effectiveness of out-of-home placements utilized in the juvenile justice 25 system, including the youth rehabilitation and treatment centers, and make recommendations to the commission on the juvenile justice continuum 26 27 of care, including what populations should be served in out-of-home 28 placements and what treatment services should be provided at the centers in order to appropriately serve those populations. 13 (c) The commission may organize committees as it deems necessary. 14 Members of the committees may be members of the commission or may be 15 appointed, with the approval of the majority of the commission, from 16 individuals with knowledge of the committee's subject matter, 17 professional expertise to assist the committee in completing its assigned 18 responsibilities, and the ability to collaborate within the committee and 19 with the commission to carry out the powers and duties of the commission. No member of any committee created pursuant to this section shall have 20 21 any private financial interest, profit, or benefit from any work of such 22 committee.

(d) The Title IV-E Demonstration Project Committee created pursuant
 to section 43-4208 and the Foster Care Reimbursement Rate Committee
 appointed pursuant to section 43-4216 are under the jurisdiction of the
 commission.

27 (3) The commission shall work with the office of the State Court 28 Administrator, as appropriate, and entities which coordinate facilitated 29 conferencing as described in section 43-247.03. Facilitated conferencing 30 shall be included in statewide strategic plan discussions by the 31 commission. Facilitated conferencing shall continue to be utilized and maximized, as determined by the court of jurisdiction, during the development of the statewide strategic plan. Funding and contracting with mediation centers approved by the Office of Dispute Resolution to provide facilitated conferencing shall continue to be provided by the office of the State Court Administrator at an amount of no less than the General Fund transfer under subsection (1) of section 43-247.04.

7 (4) The commission shall gather information and communicate with 8 juvenile justice specialists of the Office of Probation Administration 9 and county officials with respect to any county-operated practice model 10 participating in the Crossover Youth Program of the Center for Juvenile 11 Justice Reform at Georgetown University.

12 (5) The commission shall coordinate and gather information about the
 progress and outcomes of the Nebraska Juvenile Service Delivery Project
 14 established pursuant to section 43-4101.

(6) The commission shall develop a system-of-care plan beginning 15 16 with prevention services through treatment services for the child welfare 17 system based on relevant data and evidence-based practices to meet the 18 specific needs of each area of the state. Such system-of-care plan shall 19 include services that are goal-driven and outcome-based and shall evaluate the feasibility of utilizing performance-based contracting for 20 21 specific child welfare services, including the feasibility of additional 22 contractual requirements for service providers requiring services to all 23 children without an option to deny service.

24 (7) The commission shall analyze case management workforce issues
25 and make recommendations to the Health and Human Services Committee of
26 the Legislature regarding:

27 (a) Salary comparisons with other states and the current pay
 28 structure based on job descriptions;

29 (b) Utilization of incentives for persons who work in the area of 30 child welfare;

31 (c) Evidence-based training requirements for persons who work in the

2 (d) Collaboration with the University of Nebraska to increase and 3 sustain such workforce.

4 Sec. 4. Section 43-4204, Reissue Revised Statutes of Nebraska, is 5 amended to read:

(1) The Nebraska Children's Commission shall determine 6 43-4204 7 three to five strategic child welfare priorities for research or policy development for each biennium create a statewide strategic plan to carry 8 9 out the legislative intent stated in section 43-4201 for child welfare 10 program and service reform in Nebraska. In <u>determining</u> developing the statewide strategic child welfare priorities plan, the commission shall 11 consider the findings and recommendations set forth in the annual report 12 13 of the Foster Care Review Board, the annual report of the Office of Inspector General for Child Welfare, and the federal Child and Family 14 15 <u>Services Reviews outcomes.</u>, but not be limited to:

16 (a) The potential of contracting with private nonprofit entities as a lead agency, subject to the requirements of subsection (2) of this 17 18 section. Such lead-agency utilization shall be in a manner that maximizes 19 the strengths, experience, skills, and continuum of care of the lead 20 agencies. Any lead-agency contracts entered into or amended after April 21 12, 2012, shall detail how qualified licensed agencies as part of efforts 22 to develop the local capacity for a community-based system of coordinated care will implement community-based care through competitively procuring 23 24 either (i) the specific components of foster care and related services or 25 (ii) comprehensive services for defined eligible populations of children 26 and families;

27 (b) Provision of leadership for strategies to support high-quality evidence-based prevention and early intervention services that reduce 28 risk and enhance protection for children; 29

30 (c) Realignment of service areas designated pursuant to section 81-3116 to be coterminous with the judicial districts described in 31

1 section 24-301.02; 2 (d) Identification of the type of information needed for a clear and 3 thorough analysis of progress on child welfare indicators; and 4 (e) Such other elements as the commission deems necessary and 5 appropriate. 6 (2) A lead agency used after April 12, 2012, shall: 7 (a) Have a board of directors of which at least fifty-one percent of 8 the membership is comprised of Nebraska residents who are not employed by 9 the lead agency or by a subcontractor of the lead agency; 10 (b) Complete a readiness assessment as developed by the Department 11 of Health and Human Services to determine the lead agency's viability. 12 The readiness assessment shall evaluate organizational, operational, and 13 programmatic capabilities and performance, including review of: The 14 strength of the board of directors; compliance and oversight; financial 15 risk management; financial liquidity and performance; infrastructure 16 maintenance; funding sources, including state, federal, and external 17 private funding; and operations, including reporting, staffing, evaluation, training, supervision, contract monitoring, and program 18 19 performance tracking capabilities;

21 local network of providers the services required of a lead agency. A lead
22 agency shall not directly provide more than thirty-five percent of direct
23 services required under the contract; and

(d) Provide accountability for meeting the outcomes and performance
 standards related to child welfare services established by Nebraska child
 welfare policy and the federal government.

27 (3) The commission shall review the operations of the department 28 regarding child welfare programs and services and recommend, as a part of 29 the statewide strategic plan, options for attaining the legislative 30 intent stated in section 43-4201, either by the establishment of a new 31 division within the department or the establishment of a new state agency 1 to provide all child welfare programs and services which are the 2 responsibility of the state.

3 Sec. 5. Section 43-4206, Reissue Revised Statutes of Nebraska, is
4 amended to read:

43-4206 The Department of Health and Human Services and the Office 5 of Probation Administration shall fully cooperate with the activities of 6 the Nebraska Children's Commission. The department shall provide to the 7 commission all requested information on children and juveniles in 8 9 Nebraska, including, but not limited to, departmental reports, data, 10 programs, processes, finances, and policies. The department shall collaborate with the commission regarding the development of a plan for a 11 12 statewide automated child welfare information system to integrate child 13 welfare information into one system if the One Hundred Second Legislature, Second Session, 2012, enacts legislation to require the 14 development of such a plan. The department shall coordinate and 15 16 collaborate with the commission regarding engagement of an evaluator to 17 provide an evaluation of the child welfare system if the One Hundred 18 Second Legislature, Second Session, 2012, enacts legislation to require 19 such evaluation.

20 Sec. 6. Section 43-4207, Revised Statutes Cumulative Supplement, 21 2018, is amended to read:

43-4207 The Nebraska Children's Commission shall annually provide a 22 written report to the Governor and an electronic report to the Health and 23 24 Human Services Committee of the Legislature defining its strategic child 25 welfare priorities and progress toward addressing such priorities, summarizing reports from each committee and subcommittee of the 26 27 commission, and making recommendations of its activities during the 28 previous year on or before December 1, 2015. If the commission is 29 continued by the Legislature as provided in section 43-4202, the 30 commission shall provide such report on or before September 1 of each year the commission is continued. The commission shall present a summary 31

of such report in an annual public hearing before the Health and Human
 Services Committee of the Legislature on or before December 1 of each
 year.

Sec. 7. (1) Effective July 1, 2019, all duties and functions of the
Foster Care Review Office related to the Nebraska Children's Commission
shall be transferred to the office of Public Counsel.

7 (2) On July 1, 2019, all items of property, real and personal, 8 including office furniture and fixtures, books, documents, and records of 9 the Foster Care Review Office pertaining to the duties and functions 10 transferred to the office of Public Counsel pursuant to this section 11 shall become the property of the office of Public Counsel.

(3) On and after July 1, 2019, whenever the Foster Care Review 12 13 Office is referred to or designated by any contract or other document in connection with the duties and functions transferred to the office of 14 15 Public Counsel pursuant to this section, such reference or designation shall apply to the office of Public Counsel. All contracts entered into 16 17 by the Foster Care Review Office prior to July 1, 2019, in connection with the duties and functions transferred to the office of Public Counsel 18 19 are hereby recognized, with the office of Public Counsel succeeding to all rights and obligations under such contracts. 20
