## Medicaid Expansion Programs 249 (Administration) & 349 (Aid)

The Department of Health and Human Services, Division of Medicaid and Long-Term Care (MLTC), provides the following update regarding Medicaid Expansion Administrative and Aid decisions for the calendar month of July 2021:

Expansion was launched successfully on October 1, 2020. Details on enrollment for the month of July 2021 are below:

As discussed in last month's report, effective October 1, 2021, DHHS will automatically provide full state plan benefits to all Medicaid expansion (also known as Heritage Health Adult or HHA) beneficiaries. To put this change into effect, the following activities occurred in July 2021:

On July 2, 2021, DHHS concluded its public and tribal comment periods related to a state plan amendment and the termination of the section 1115 demonstration waiver (1115 waiver). DHHS is preparing an 1115 waiver conclusion statement for the federal government.

On July 10, 2021, DHHS concluded a tribal comment period regarding changes to the state's 1915(b) managed care waiver. This waiver amendment was submitted to the federal government for approval on July 14, 2021. Additionally, DHHS completed drafts of the necessary contract amendments for its contracted Medicaid managed care entities<sup>3</sup>. These draft contract

amendments include updated capitation rates and are now being reviewed through the state's procurement process.

DHHS scheduled a public hearing for necessary regulation changes on August 18, 2021.


Internally, DHHS continues to design and develop changes to its technology systems. To support these changes, DHHS submitted an implementation advanced planning document to the federal government on July 26, 2021, in order to request federal financial participation for these changes.

DHHS eligibility staff have completed additional training on changes coming to the expansion program.
