- A BILL FOR AN ACT relating to motor vehicle registration; to amend sections 60-301, 60-393, 60-395, 60-396, 60-3,104, and 60-3,130.04, Revised Statutes Cumulative Supplement, 2020; to provide for Nebraska History Plates; to create a fund; to provide powers and
- 5 duties; to harmonize provisions; and to repeal the original
- 6 sections.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 60-301, Revised Statutes Cumulative Supplement,
- 2 2020, is amended to read:
- 3 60-301 Sections 60-301 to 60-3,254 and sections 7 and 8 of this act
- 4 shall be known and may be cited as the Motor Vehicle Registration Act.
- 5 Sec. 2. Section 60-393, Revised Statutes Cumulative Supplement,
- 6 2020, is amended to read:
- 7 60-393 Any owner who has two or more motor vehicles or trailers
- 8 required to be registered under the Motor Vehicle Registration Act may
- 9 register all such motor vehicles or trailers on a calendar-year basis or
- 10 on an annual basis for the same registration period beginning in a month
- 11 chosen by the owner. When electing to establish the same registration
- 12 period for all such motor vehicles or trailers, the owner shall pay the
- 13 registration fee, the motor vehicle tax imposed in section 60-3,185, the
- 14 motor vehicle fee imposed in section 60-3,190, and the alternative fuel
- 15 fee imposed in section 60-3,191 on each motor vehicle for the number of
- 16 months necessary to extend its current registration period to the
- 17 registration period under which all such motor vehicles or trailers will
- 18 be registered. Credit shall be given for registration paid on each motor
- 19 vehicle or trailer when the motor vehicle or trailer has a later
- 20 expiration date than that chosen by the owner except as otherwise
- 21 provided in sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128,
- 22 60-3,224, 60-3,227, 60-3,233, 60-3,235, 60-3,238, 60-3,240, 60-3,242,
- 23 60-3,244, 60-3,246, 60-3,248, 60-3,250, 60-3,252, and 60-3,254 and
- 24 section 8 of this act. Thereafter all such motor vehicles or trailers
- 25 shall be registered on an annual basis starting in the month chosen by
- 26 the owner.

- (e) Upon a trade-in or surrender of a motor vehicle under a lease;

- 28 (2) If the date of the event falls within the same calendar month in
- 29 which the motor vehicle or trailer is acquired, no refund shall be
- 30 allowed for such month.
- 31 (3) If the transferor or lessee acquires another motor vehicle at

- 1 the time of the transfer, trade-in, or surrender, the transferor or
- 2 lessee shall have the credit provided for in this section applied toward
- 3 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 4 transferor or lessee shall file a claim for refund with the county
- 5 treasurer upon an application form prescribed by the department.
- 6 (4) The registered owner or lessee shall make a claim for refund or
- 7 credit of the fees and taxes for the unexpired months in the registration
- 8 period within sixty days after the date of the event or shall be deemed
- 9 to have forfeited his or her right to such refund or credit.
- 10 (5) For purposes of this section, the date of the event shall be:
- 11 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 12 (b) in the case of a change in the situs, the date of registration in
- another state; (c) in the case of a trade-in or surrender under a lease,
- 14 the date of trade-in or surrender; (d) in the case of a legislative act,
- 15 the effective date of the act; and (e) in the case of a court decision,
- 16 the date the decision is rendered.
- 17 (6) Application for registration or for reassignment of license
- 18 plates and, when appropriate, validation decals to another motor vehicle
- 19 or trailer shall be made within thirty days of the date of purchase.
- 20 (7) If a motor vehicle or trailer was reported stolen under section
- 21 60-178, a refund under this section shall not be reduced for a lost plate
- 22 charge and a credit under this section may be reduced for a lost plate
- 23 charge but the applicant shall not be required to pay the plate fee for
- 24 new plates.
- 25 (8) The county treasurer shall refund the motor vehicle fee and
- 26 registration fee from the fees which have not been transferred to the
- 27 State Treasurer. The county treasurer shall make payment to the claimant
- 28 from the undistributed motor vehicle taxes of the taxing unit where the
- 29 tax money was originally distributed. No refund of less than two dollars
- 30 shall be paid.

When no such replacement motor vehicle, trailer, or semitrailer is so registered, the county treasurer 23 24 shall forward the application and affidavit, if any, to the State 25 Treasurer who shall determine the amount, if any, of the allowable credit for the registration fee and issue a credit certificate to the owner. For 26 27 the motor vehicle tax and fee, the county treasurer shall determine the 28 amount, if any, of the allowable credit and issue a credit certificate to the owner. When such motor vehicle, trailer, or semitrailer is removed 29 from service within the same month in which it was registered, no credits 30 shall be allowed for such month. The credits may be applied against taxes 31

- 19 limiting the manufacturing cost of each plate to an amount less than or
- 20 equal to the amount charged for license plates pursuant to section

2 (3)(a) When the department receives an application for Nebraska 3 History Plates, the department may deliver the plates and registration 4 certificate to the applicant by United States mail or to the county 5 treasurer of the county in which the motor vehicle, trailer, or semitrailer is registered and the delivery of the plates and registration 6 7 certificate shall be made through a secure process and system. Beginning on an implementation date designated by the director on or before January 8 9 1, 2023, if delivery of the plates and registration certificate is made by the department to the applicant, the department may charge a postage 10 and handling fee in an amount not more than necessary to recover the cost 11 12 of postage and handling for the specific items mailed to the registrant. 13 The department shall remit the fee to the State Treasurer for credit to the Department of Motor Vehicles Cash Fund. The county treasurer or the 14 15 department shall issue Nebraska History Plates in lieu of regular license plates when the applicant complies with the other provisions of the Motor 16 17 Vehicle Registration Act for registration of the motor vehicle, trailer, or semitrailer. If Nebraska History Plates are lost, stolen, or 18 19 mutilated, the licensee shall be issued replacement license plates upon 20 request pursuant to section 60-3,157. 21 (b) The county treasurer or the department may issue temporary 22 license stickers to the applicant under this section for the applicant to lawfully operate the vehicle pending receipt of the license plates. No 23 24 charge in addition to the registration fee shall be made for the issuance 25 of a temporary license sticker under this subdivision. The department shall furnish temporary license stickers for issuance by the county 26 27 treasurer at no cost to the counties. The department may adopt and 28 promulgate rules and regulations regarding the design and issuance of temporary license stickers. 29 (4) The owner of a motor vehicle, trailer, or semitrailer bearing 30

Nebraska History Plates may apply to the county treasurer to have such

- 1 plates transferred to a motor vehicle or trailer other than the motor
- 2 <u>vehicle</u> or trailer for which such plates were originally purchased if
- 3 such motor vehicle or trailer is owned by the owner of the plates. The
- 4 owner may have the unused portion of the fee for the plates credited to
- 5 the other motor vehicle or trailer which will bear the plates at the rate
- 6 of eight and one-third percent per month for each full month left in the
- 7 registration period. Application for such transfer shall be accompanied
- 8 by a fee of three dollars. Fees collected pursuant to this subsection
- 9 shall be remitted to the State Treasurer for credit to the Department of
- 10 Motor Vehicles Cash Fund.
- 11 (5) If the cost of manufacturing Nebraska History Plates at any time
- 12 exceeds the amount charged for license plates pursuant to section
- 13 <u>60-3,102, any money to be credited to the Support Nebraska History Cash</u>
- 14 Fund shall instead be credited first to the Highway Trust Fund in an
- 15 amount equal to the difference between the manufacturing costs of
- 16 <u>Nebraska History Plates and the amount charged pursuant to section</u>
- 17 60-3,102 with respect to such plates and the remainder shall be credited
- 18 to the Support Nebraska History Cash Fund.
- 19 Sec. 9. The Support Nebraska History Cash Fund is created. The fund
- 20 shall consist of money credited to the fund under section 8 of this act
- 21 and any other gifts, bequests, grants, or other contributions or
- 22 donations to the fund from public or private entities. The Nebraska State
- 23 Historical Society shall administer and distribute the Support Nebraska
- 24 History Cash Fund. The fund shall be expended to promote the history of
- 25 Nebraska on the Internet, to support history education for children in
- 26 Nebraska, and for costs directly related to the administration of the
- 27 fund. Any money in the fund available for investment shall be invested by
