RE: Report of Property Forfeiture Seizures

Legislative Bill 1106 passed by the One Hundred Fourth Legislature and approved by the Governor on April 19, 2016, requires law enforcement agencies to annually report to the Auditor of Public Accounts (APA) property seized related to drug and child pornography cases. The APA is required to submit a report to the Legislature on the nature and extent of such filed reports.

For the period January 1, 2023, through December 31, 2023, the APA received 84 reports from law enforcement agencies, see attached. Of the reports received, 70 indicated they had no property seized during that time frame, the remaining 14 indicated they had seized property and included details of the seizures.

The reports received were scanned and can be found on the APA website at www.auditors.nebraska.gov under the "Local Governments" tab, "Search Forfeitures".
