Subject: Juvenile Room Confinement Report

Dear Mr. Metzler:

Nebraska Statute 83-4,134.01 requires Nebraska's juvenile facilities to report quarterly to the Legislature and the Office of the Inspector General within two weeks after the end of each quarter, information regarding the use of room confinement in Nebraska's juvenile facilities. All facilities followed the Center for Disease Control and local public health department recommendations on the use of medical quarantine for youth testing positive or exposed to COVID-19.

Attached you will find the room confinement usage data for the Whitehall Psychiatric Residential Treatment Facility (PRTF) in Lincoln, as well as the Youth Rehabilitation and Treatment Centers (YRTC) in Kearney, Hastings, and Lincoln for the third quarter of fiscal year (FY) 2022/2023. The YRTC system continues to use room confinement as a behavioral management tool for high-risk youth in our care. Efforts are continually being made to guarantee youth are confined for the shortest amount of time possible to ensure the safety of all parties.
