- 1 A BILL FOR AN ACT relating to education; to amend section 79-10,141,
- 2 Revised Statutes Cumulative Supplement, 2022; to provide legislative
- 3 intent regarding the Summer Electronic Benefits Transfer Program; to
- 4 require the State Department of Education to administer a program to
- 5 provide electronic benefit transfer funds to eligible youth in the
- 6 summer as prescribed; and to repeal the original section.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 79-10,141, Revised Statutes Cumulative
- 2 Supplement, 2022, is amended to read:
- 3 79-10,141 (1) Because children are susceptible to hunger in the
- 4 summertime, resulting in negative health effects, the Legislature
- 5 intends, as a state nutrition and health policy, that (a) the State of
- 6 Nebraska's participation in the Summer Food Service Program of the United
- 7 States Department of Agriculture be strengthened where it is needed to
- 8 provide adequate nutrition for children and (b) the State of Nebraska opt
- 9 into the provision of the federal Consolidated Appropriations Act of 2023
- 10 to permanently authorize the Summer Electronic Benefits Transfer Program.
- 11 (2) To encourage participation and utilization of the Summer Food
- 12 Service Program, the department shall:
- 13 (a) Provide information to sponsors concerning the benefits and
- 14 availability of the Summer Food Service Program; and
- 15 (b) Award grants of up to fifteen thousand dollars on a competitive
- 16 basis to sponsors approved by the department. Grants awarded under this
- 17 section may be used for nonrecurring expenses incurred in initiating or
- 18 expanding services under the Summer Food Service Program, including, but
- 19 not limited to, the acquisition of equipment, salaries of staff, training
- 20 of staff in new capacities, outreach efforts to publicize new or expanded
- 21 services under the Summer Food Service Program, minor alterations to
- 22 accommodate new equipment, computer point-of-service systems for food
- 23 service, and the purchase of vehicles for transporting food to sites.
- 24 Funds may be expended up to the full cost of a qualifying expense
- 25 incurred by a sponsor in initiating or expanding the services under the
- 26 Summer Food Service Program, and if the funds are expended solely for the
- 27 benefit of child nutrition programs administered by the department, no
- 28 proration of the expense shall be required. Funds shall not be used for
- 29 food, computers, except point-of-service systems, or capital outlay. The
- 30 total amount of grants awarded under this section shall be limited to one
- 31 hundred thousand dollars per fiscal year.

- 1 (3) In awarding grants under this section, the department shall give
- 2 preference in the following order of priority to:
- 3 (a) Sponsors located within the boundaries of school districts in
- 4 which fifty percent or more of the students apply and qualify for free
- 5 and reduced-price lunches or located within the boundaries of a census
- 6 tract in which fifty percent or more of the children fall under the
- 7 poverty threshold as defined by the United States Department of
- 8 Agriculture;
- 9 (b) Sponsors in which health or education activities are emphasized;
- 10 and
- 11 (c) Sponsors that participate in the Summer Food Service Program at
- 12 the time of grant application.
- 13 (4) Sponsors may apply for grants under this section by:
- 14 (a) Submitting to the department a plan to start or expand services
- 15 under the Summer Food Service Program;
- 16 (b) Agreeing to operate the Summer Food Service Program for a period
- 17 of not less than two years; and
- 18 (c) Assuring that the expenditure of funds from state and local
- 19 resources for the maintenance of other child nutrition programs
- 20 administered by the department shall not be diminished as a result of
- 21 grants received under this section.
- 22 <u>(5) The department shall administer a program to provide electronic</u>
- 23 benefit transfer funds to eliqible youth in the summer consistent with
- 24 the provisions of the federal Consolidated Appropriations Act of 2023
- 25 authorizing the Summer Electronic Benefits Transfer Program.
