- A BILL FOR AN ACT relating to the office of Public Counsel; to amend sections 43-4317 and 47-904, Reissue Revised Statutes of Nebraska, and section 81-8,244, Revised Statutes Cumulative Supplement, 2022; to change and eliminate provisions relating to the appointment, reappointment, and terms of the Inspector General of Nebraska Child Welfare and the Inspector General of the Nebraska Correctional System; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

Section 1. Section 43-4317, Reissue Revised Statutes of Nebraska, is

- 3 43-4317 (1) The office of Inspector General of Nebraska Child
- 4 Welfare is created within the office of Public Counsel for the purpose of
- 5 conducting investigations, audits, inspections, and other reviews of the
- 6 Nebraska child welfare system. The Inspector General shall be appointed
- 7 by the Public Counsel with approval from the chairperson of the Executive
- 8 Board of the Legislative Council—and the chairperson of the Health and
- 9 Human Services Committee of the Legislature.
- 10 (2) The Inspector General shall be appointed for a term of five
- 11 years and may be reappointed. The Inspector General shall be selected
- 12 without regard to political affiliation and on the basis of integrity,
- 13 capability for strong leadership, and demonstrated ability in accounting,
- 14 auditing, financial analysis, law, management analysis, public
- 15 administration, investigation, or criminal justice administration or
- 16 other closely related fields. No former or current executive or manager
- 17 of the department may be appointed Inspector General within five years
- 18 after such former or current executive's or manager's period of service
- 19 with the department. Not later than two years after the date of
- 20 appointment, the Inspector General shall obtain certification as a
- 21 Certified Inspector General by the Association of Inspectors General, its
- 22 successor, or another nationally recognized organization that provides
- 23 and sponsors educational programs and establishes professional
- 24 qualifications, certifications, and licensing for inspectors general.
- 25 During his or her employment, the Inspector General shall not be actively
- 26 involved in partisan affairs.
- 27 (3) The Inspector General shall employ such investigators and
- 28 support staff as he or she deems necessary to carry out the duties of the
- 29 office within the amount available by appropriation through the office of
- 30 Public Counsel for the office of Inspector General of Nebraska Child
- 31 Welfare. The Inspector General shall be subject to the control and

- 1 supervision of the Public Counsel, except that removal of the Inspector
- 2 General shall require approval of the chairperson of the Executive Board
- 3 of the Legislative Council and the chairperson of the Health and Human
- 4 Services Committee of the Legislature.

- 7 47-904 (1) The office of Inspector General of the Nebraska
- 8 Correctional System is created within the office of Public Counsel for

- 10 reviews of the Nebraska correctional system. The Inspector General shall
- 11 be appointed by the Public Counsel with approval from the chairperson of
- 12 the Executive Board of the Legislative Council and the chairperson of the
- 13 Judiciary Committee of the Legislature.
- 14 (2) The Inspector General shall be appointed for a term of five
- 15 years and may be reappointed. The Inspector General shall be selected
- 16 without regard to political affiliation and on the basis of integrity,
- 17 capability for strong leadership, and demonstrated ability in accounting,
- 18 auditing, financial analysis, law, management, public administration,
- 19 investigation, or criminal justice administration or other closely
- 20 related fields. No former or current executive or manager of the
- 21 department shall be appointed Inspector General within five years after

- 29 employment, the Inspector General shall not be actively involved in

- 31 (3) The Inspector General shall employ such investigators and

- 2 office within the amount available by appropriation through the office of
- 3 Public Counsel for the office of Inspector General of the Nebraska
- 4 Correctional System. The Inspector General shall be subject to the

- 11 81-8,244 (1) (1) (a) The Public Counsel may select, appoint, and
- 12 compensate as he or she sees fit, within the amount available by
- appropriation, such assistants and employees as he or she deems necessary
- 14 to discharge the responsibilities under sections 81-8,240 to 81-8,254. He
- or she shall appoint and designate one assistant to be a deputy public
- 16 counsel, one assistant to be a deputy public counsel for corrections, one
- 17 assistant to be a deputy public counsel for institutions, and one
- 18 assistant to be a deputy public counsel for welfare services.
- 19 (2) (b) Such deputy public counsels shall be subject to the control
- 20 and supervision of the Public Counsel.
- 21 (3) (c) The authority of the deputy public counsel for corrections
- 22 shall extend to all facilities and parts of facilities, offices, houses
- 23 of confinement, and institutions which are operated by the Department of
- 24 Correctional Services and all county or municipal correctional or jail
- 25 facilities.
- 26 (4) (d) The authority of the deputy public counsel for institutions
- 27 shall extend to all mental health institutions and facilities operated by
- 28 the Department of Health and Human Services, to all veterans institutions
- 29 operated by the Department of Veterans' Affairs, and to all regional
- 30 behavioral health authorities that provide services and all community-
- 31 based behavioral health services providers that contract with a regional

- 1 behavioral health authority to provide services, for any individual who
- 2 was a patient within the prior twenty-four months of a state-owned and
- 3 state-operated regional center, and to all complaints pertaining to
- 4 administrative acts of the department, authority, or provider when those
- 5 acts are concerned with the rights and interests of individuals placed
- 6 within those institutions and facilities or receiving community-based
- 7 behavioral health services.
- 8 (5) (e) The authority of the deputy public counsel for welfare
- 9 services shall extend to all complaints pertaining to administrative acts
- 10 of administrative agencies when those acts are concerned with the rights
- 11 and interests of individuals involved in the welfare services system of
- 12 the State of Nebraska.
- 13 (6) (f) The Public Counsel may delegate to members of the staff any
- 14 authority or duty under sections 81-8,240 to 81-8,254 except the power of
- 15 delegation and the duty of formally making recommendations to
- 16 administrative agencies or reports to the Governor or the Legislature.
- 17 (2) The Public Counsel shall appoint the Inspector General of
- 18 Nebraska Child Welfare as provided in section 43-4317. The Inspector
- 19 General of Nebraska Child Welfare shall have the powers and duties
- 20 provided in the Office of Inspector General of Nebraska Child Welfare
- 21 Act.
- 22 (3) The Public Counsel shall appoint the Inspector General of the
- 23 Nebraska Correctional System as provided in section 47-904. The Inspector
- 24 General of the Nebraska Correctional System shall have the powers and
- 25 duties provided in the Office of Inspector General of the Nebraska
- 26 Correctional System Act.
