## **LEGISLATIVE BILL 1364**

- 1 A BILL FOR AN ACT relating to economic development; to amend sections
- 2 81-12,148 and 84-612, Revised Statutes Supplement, 2023; to change
- 3 provisions of the Site and Building Development Act and provide for
- 4 a transfer from the Cash Reserve Fund; to repeal the original
- 5 sections; and to declare an emergency.
- 6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 81-12,148, Revised Statutes Supplement, 2023, is

- 2 amended to read:
- 3 81-12,148 (1) Governmental subdivisions and Nebraska nonprofit
- 4 organizations are eligible to receive assistance under the Site and
- 5 Building Development Act. Any entity receiving assistance under
- 6 subsection (1) of section 81-12,147 shall provide, or cause to be
- 7 provided, matching funds for the eligible activity in an amount
- 8 determined by the Department of Economic Development, which amount shall
- 9 be at least equal to one hundred percent of the amount of assistance
- 10 provided by the Site and Building Development Fund. Nothing in the act
- 11 shall be construed to allow individuals or businesses to receive direct
- 12 loans from the fund.
- 13 (2) An applicant for a grant for development of a public-private-
- 14 partnership facility under subdivision (1)(h) of section 81-12,147 shall
- 15 provide the Director of Economic Development with a letter of support
- 16 from the United States Strategic Command prior to approval of the
- 17 application and with proof of the availability of [XXXX] twenty million
- 18 dollars in private or other funds for the facility. No funds shall be
- 19 expended or grants awarded until receipt of proof of the availability of
- 20 [XXXX] twenty million dollars in private or other funds for the facility
- 21 and certification is provided by the Director of Economic Development to
- 22 the budget administrator of the budget division of the Department of
- 23 Administrative Services.
- 24 (3) An applicant for a grant for development under subdivision (1)
- 25 (k) of section 81-12,147 is not required to meet the matching fund
- 26 requirements pursuant to this section but shall provide the Director of
- 27 Economic Development a letter from the United States Department of
- 28 Defense or contractor providing upgrades to ground-based nuclear
- 29 deterrence that infrastructure improvements, including the construction
- 30 of electrical, drinking water, and clean water infrastructure, will not
- 31 be included in the scope of the project. No grants shall be awarded or

- 1 funds expended until such letter is received.
- 2 (4) This section does not apply to any inland port authority
- 3 receiving assistance under subsection (2) of section 81-12,147.
- 4 Sec. 2. Section 84-612, Revised Statutes Supplement, 2023, is
- 5 amended to read:
- 6 84-612 (1) There is hereby created within the state treasury a fund
- 7 known as the Cash Reserve Fund which shall be under the direction of the
- 8 State Treasurer. The fund shall only be used pursuant to this section.
- 9 (2) The State Treasurer shall transfer funds from the Cash Reserve
- 10 Fund to the General Fund upon certification by the Director of
- 11 Administrative Services that the current cash balance in the General Fund
- 12 is inadequate to meet current obligations. Such certification shall
- include the dollar amount to be transferred. Any transfers made pursuant
- 14 to this subsection shall be reversed upon notification by the Director of
- 15 Administrative Services that sufficient funds are available.
- 16 (3) In addition to receiving transfers from other funds, the Cash
- 17 Reserve Fund shall receive federal funds received by the State of
- 18 Nebraska for undesignated general government purposes, federal revenue
- 19 sharing, or general fiscal relief of the state.
- 20 (4) The State Treasurer shall transfer two million dollars from the
- 21 Governor's Emergency Cash Fund to the Cash Reserve Fund on or before June
- 22 30, 2024, on such dates and in such amounts as directed by the budget
- 23 administrator of the budget division of the Department of Administrative
- 24 Services.
- 25 (5) The State Treasurer shall transfer two hundred sixteen million
- 26 one hundred twenty thousand dollars from the Cash Reserve Fund to the
- 27 Nebraska Capital Construction Fund on or after July 1, 2022, but before
- 28 June 15, 2023, on such dates and in such amounts as directed by the
- 29 budget administrator of the budget division of the Department of
- 30 Administrative Services.
- 31 (6) The State Treasurer shall transfer one hundred eighty-two

- 1 million six hundred twenty-three thousand eight hundred twenty-five
- 2 dollars from the Cash Reserve Fund to the Nebraska Capital Construction
- 3 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 4 and in such amounts as directed by the budget administrator of the budget
- 5 division of the Department of Administrative Services.
- 6 (7) The State Treasurer shall transfer fifty-three million five
- 7 hundred thousand dollars from the Cash Reserve Fund to the Perkins County
- 8 Canal Project Fund on or before June 30, 2023, on such dates and in such
- 9 amounts as directed by the budget administrator of the budget division of
- 10 the Department of Administrative Services.
- 11 (8) No funds shall be transferred from the Cash Reserve Fund to
- 12 fulfill the obligations created under the Nebraska Property Tax Incentive
- 13 Act unless the balance in the Cash Reserve Fund after such transfer will
- 14 be at least equal to five hundred million dollars.
- 15 (9) The State Treasurer shall transfer thirty million dollars from
- 16 the Cash Reserve Fund to the Military Base Development and Support Fund
- on or before June 30, 2023, but not before July 1, 2022, on such dates
- 18 and in such amounts as directed by the budget administrator of the budget
- 19 division of the Department of Administrative Services.
- 20 (10) The State Treasurer shall transfer eight million three hundred
- 21 thousand dollars from the Cash Reserve Fund to the Trail Development and
- 22 Maintenance Fund on or after July 1, 2022, but before July 30, 2022, on
- 23 such dates and in such amounts as directed by the budget administrator of
- 24 the budget division of the Department of Administrative Services.
- 25 (11) The State Treasurer shall transfer fifty million dollars from
- 26 the Cash Reserve Fund to the Nebraska Rural Projects Fund on or after
- 27 July 1, 2022, but before July 15, 2023, on such dates and in such amounts
- 28 as directed by the budget administrator of the budget division of the
- 29 Department of Administrative Services.
- 30 (12) The State Treasurer shall transfer thirty million dollars from
- 31 the Cash Reserve Fund to the Rural Workforce Housing Investment Fund on

- 1 or after July 1, 2022, but before July 15, 2023, on such dates and in
- 2 such amounts as directed by the budget administrator of the budget
- 3 division of the Department of Administrative Services.
- 4 (13) The State Treasurer shall transfer twenty million dollars from
- 5 the Cash Reserve Fund to the Intern Nebraska Cash Fund on or after July
- 6 1, 2022, but before June 15, 2023, on such dates and in such amounts as
- 7 directed by the budget administrator of the budget division of the
- 8 Department of Administrative Services.
- 9 (14) The State Treasurer shall transfer twenty million dollars from
- 10 the Cash Reserve Fund to the Middle Income Workforce Housing Investment
- 11 Fund on July 15, 2022, or as soon thereafter as administratively
- 12 possible, and in such amounts as directed by the budget administrator of
- 13 the budget division of the Department of Administrative Services.
- 14 (15) The State Treasurer shall transfer eighty million dollars from
- 15 the Cash Reserve Fund to the Jobs and Economic Development Initiative
- 16 Fund on or after July 1, 2022, but before July 15, 2023, on such dates
- 17 and in such amounts as directed by the budget administrator of the budget
- 18 division of the Department of Administrative Services.
- 19 (16) The State Treasurer shall transfer twenty million dollars from
- 20 the Cash Reserve Fund to the Site and Building Development Fund on July
- 21 15, 2022, or as soon thereafter as administratively possible, and in such
- 22 amounts as directed by the budget administrator of the budget division of
- 23 the Department of Administrative Services.
- 24 (17) The State Treasurer shall transfer fifty million dollars from
- 25 the Cash Reserve Fund to the Surface Water Irrigation Infrastructure Fund
- 26 on or after July 15, 2022, but before January 1, 2023, on such dates and
- 27 in such amounts as directed by the budget administrator of the budget
- 28 division of the Department of Administrative Services.
- 29 (18) The State Treasurer shall transfer fifteen million dollars from
- 30 the Cash Reserve Fund to the Site and Building Development Fund on or
- 31 before June 30, 2022, on such dates and in such amounts as directed by

- 1 the budget administrator of the budget division of the Department of
- 2 Administrative Services.
- 3 (19) The State Treasurer shall transfer fifty-five million dollars
- 4 from the Cash Reserve Fund to the Economic Recovery Contingency Fund on
- 5 or before June 30, 2022, on such dates and in such amounts as directed by
- 6 the budget administrator of the budget division of the Department of
- 7 Administrative Services.
- 8 (20) The State Treasurer shall transfer ten million dollars from the
- 9 Cash Reserve Fund to the School Safety and Security Fund as soon as
- 10 administratively possible after September 2, 2023, on such dates and in
- 11 such amounts as directed by the budget administrator of the budget
- 12 division of the Department of Administrative Services.
- 13 (21) The State Treasurer shall transfer ten million dollars from the
- 14 Cash Reserve Fund to the General Fund as soon as administratively
- 15 possible after June 7, 2023, on such dates and in such amounts as
- 16 directed by the budget administrator of the budget division of the
- 17 Department of Administrative Services.
- 18 (22) The State Treasurer shall transfer one million dollars from the
- 19 Cash Reserve Fund to the Revitalize Rural Nebraska Fund as soon as
- 20 administratively possible after June 7, 2023, on such dates and in such
- 21 amounts as directed by the budget administrator of the budget division of
- 22 the Department of Administrative Services.
- 23 (23) The State Treasurer shall transfer three million dollars from
- 24 the Cash Reserve Fund to the Risk Loss Trust on or before June 30, 2024,
- 25 on such dates and in such amounts as directed by the budget administrator
- 26 of the budget division of the Department of Administrative Services.
- 27 (24) The State Treasurer shall transfer eleven million three hundred
- 28 twenty thousand dollars from the Cash Reserve Fund to the Health and
- 29 Human Services Cash Fund on or after July 1, 2023, but on or before June
- 30 30, 2024, on such dates and in such amounts as directed by the budget
- 31 administrator of the budget division of the Department of Administrative

- 1 Services.
- 2 (25) The State Treasurer shall transfer five hundred seventy-four
- 3 million five hundred thousand dollars from the Cash Reserve Fund to the
- 4 Perkins County Canal Project Fund on or before June 30, 2024, on such
- 5 dates and in such amounts as directed by the budget administrator of the
- 6 budget division of the Department of Administrative Services.
- 7 (26) The State Treasurer shall transfer one million four hundred
- 8 thousand dollars from the Cash Reserve Fund to the State Building
- 9 Revolving Fund on or before July 10, 2023, on such dates and in such
- 10 amounts as directed by the budget administrator of the budget division of
- 11 the Department of Administrative Services.
- 12 (27) The State Treasurer shall transfer one million one hundred
- 13 thousand dollars from the Cash Reserve Fund to the Accounting Division
- 14 Revolving Fund on or before July 10, 2023, on such dates and in such
- 15 amounts as directed by the budget administrator of the budget division of
- 16 the Department of Administrative Services.
- 17 (28) The State Treasurer shall transfer one million one hundred
- 18 fifteen thousand dollars from the Cash Reserve Fund to the Public Safety
- 19 Cash Fund on or after July 1, 2023, but before June 30, 2024, on such
- 20 dates and in such amounts as directed by the budget administrator of the
- 21 budget division of the Department of Administrative Services.
- 22 (29) The State Treasurer shall transfer one hundred million dollars
- 23 from the Cash Reserve Fund to the Roads Operations Cash Fund before June
- 24 30, 2023, on such dates and in such amounts as directed by the budget
- 25 administrator of the budget division of the Department of Administrative
- 26 Services.
- 27 (30) The State Treasurer shall transfer eighteen million seven
- 28 hundred fifty thousand dollars from the Cash Reserve Fund to the State
- 29 Self-Insured Indemnification Fund before June 30, 2023, on such dates and
- 30 in such amounts as directed by the budget administrator of the budget
- 31 division of the Department of Administrative Services.

- 1 (31) The State Treasurer shall transfer five million dollars from
- 2 the Cash Reserve Fund to the Nebraska Public Safety Communication System
- 3 Revolving Fund on or after July 1, 2023, but before June 30, 2024, on
- 4 such dates and in such amounts as directed by the budget administrator of
- 5 the budget division of the Department of Administrative Services.
- 6 (32) The State Treasurer shall transfer seventy million dollars from
- 7 the Cash Reserve Fund to the Shovel-Ready Capital Recovery and Investment
- 8 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 9 and in such amounts as directed by the budget administrator of the budget
- 10 division of the Department of Administrative Services.
- 11 (33) The State Treasurer shall transfer two million dollars from the
- 12 Cash Reserve Fund to the Site and Building Development Fund on or after
- 13 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 14 as directed by the budget administrator of the budget division of the
- 15 Department of Administrative Services.
- 16 (34) The State Treasurer shall transfer twenty million dollars from
- 17 the Cash Reserve Fund to the Economic Development Cash Fund on or after
- 18 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 19 as directed by the budget administrator of the budget division of the
- 20 Department of Administrative Services.
- 21 (35) The State Treasurer shall transfer zero dollars from the Cash
- 22 Reserve Fund to the Rural Workforce Housing Investment Fund on or after
- 23 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 24 as directed by the budget administrator of the budget division of the
- 25 Department of Administrative Services.
- 26 (36) The State Treasurer shall transfer zero dollars from the Cash
- 27 Reserve Fund to the Middle Income Workforce Housing Investment Fund on or
- 28 after July 1, 2023, but before June 30, 2024, on such dates and in such
- 29 amounts as directed by the budget administrator of the budget division of
- 30 the Department of Administrative Services.
- 31 (37) The State Treasurer shall transfer two hundred forty million

- 1 dollars from the Cash Reserve Fund to the Economic Recovery Contingency
- 2 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 3 and in such amounts as directed by the budget administrator of the budget
- 4 division of the Department of Administrative Services.
- 5 (38) The State Treasurer shall transfer ten million dollars from the
- 6 Cash Reserve Fund to the Critical Infrastructure Facilities Cash Fund on
- 7 or after July 1, 2023, but before June 30, 2024, on such dates and in
- 8 such amounts as directed by the budget administrator of the budget
- 9 division of the Department of Administrative Services.
- 10 (39) The State Treasurer shall transfer four hundred forty million
- 11 dollars from the General Fund to the Cash Reserve Fund on or after July
- 12 1, 2023, but before June 30, 2024, on such dates and in such amounts as
- 13 directed by the budget administrator of the budget division of the
- 14 Department of Administrative Services.
- 15 (40) The State Treasurer shall transfer zero dollars from the Cash
- 16 Reserve Fund to the Site and Building Development Fund on or after July
- 17 1, 2024, but before June 30, 2025, on such dates and in such amounts as
- 18 directed by the budget administrator of the budget division of the
- 19 Department of Administrative Services.
- 20 (41) The State Treasurer shall transfer one million dollars from the
- 21 Cash Reserve Fund to the General Fund on or after July 1, 2024, but
- 22 before June 30, 2025, on such dates and in such amounts as directed by
- 23 the budget administrator of the budget division of the Department of
- 24 Administrative Services.
- 25 (42) The State Treasurer shall transfer twenty-five million four
- 26 hundred fifty-eight thousand eight hundred dollars from the Cash Reserve
- 27 Fund to the Nebraska Capital Construction Fund on or after July 1, 2024,
- 28 but before June 30, 2025, on such dates and in such amounts as directed
- 29 by the budget administrator of the budget division of the Department of
- 30 Administrative Services.
- 31 (43) The State Treasurer shall transfer two million five hundred

- 1 thousand dollars from the Cash Reserve Fund to the Materiel Division
- 2 Revolving Fund on or after July 1, 2023, but before June 30, 2024, on
- 3 such dates and in such amounts as directed by the budget administrator of
- 4 the budget division of the Department of Administrative Services.
- 5 (44) The State Treasurer shall transfer ten million dollars from the
- 6 Cash Reserve Fund to the Youth Outdoor Education Innovation Fund on or
- 7 after July 1, 2023, but before June 30, 2024, on such dates and in such
- 8 amounts as directed by the budget administrator of the budget division of
- 9 the Department of Administrative Services.
- 10 (45) The State Treasurer shall transfer [XXXX] dollars from the Cash
- 11 Reserve Fund to the Site and Building Development Fund as soon as
- 12 <u>administratively possible, on such dates and in such amounts as directed</u>
- 13 by the budget administrator of the budget division of the Department of
- 14 Administrative Services.
- 15 Sec. 3. Original sections 81-12,148 and 84-612, Revised Statutes
- 16 Supplement, 2023, are repealed.
- 17 Sec. 4. Since an emergency exists, this act takes effect when
- 18 passed and approved according to law.
