**KELLY:** Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the twenty-first day of the One Hundred Ninth Legislature, First Session. Our chaplain for the day is Pastor John Schnell, Encounter Life Church, Mead, Nebraska, in Senator Storm's district. Please rise.

**JOHN SCHNELL:** Let us pray. Almighty God and Father and our Lord and Savior Jesus Christ, I pray first of all, that your Holy name will be honored and held in high regard in this Chamber. Heavenly Father, together we come before you in humility as people who are willfully out of step with you and in need of your forgiveness. **CLERK:** Mr. President, there's a quorum present.

**KELLY:** Are there any corrections for the Journal?

**CLERK:** I have no corrections this morning, sir.

**KELLY:** Are there any messages, reports, or announcements?

**CLERK:** There are, Mr. President. Your Committee on Urban Affairs, chaired by Senator McKinney, reports LB240, LB286, LB289, LB290 to General File. Additionally, your Committee on Banking, Commerce and Insurance reports LB241, LB293, LB527, LB609 to General File, some having committee amendments. Notice of hearing from the Judiciary Committee, as well as communication from the governor concerning an appointment to the Nebraska Game and Parks Commission, Kurt Arganbright. An additional communication from the governor appointing Chuck Hutchison to the Nebraska Power Review Board, and a reappointment of a member to the Board of Educational Lands and Funds, as well as a communication from the governor concerning an appointment to the Nebraska Oil and Gas Conservation Commission. Additionally, amendments to be printed to LB182 from Senator Bostar, and notice of committee hearing from the Natural Resources Committee. Announcement: the Business and Labor Committee will meet in executive session today at 11:00 in Room 2022; Business and Labor, 11:00, Room 2022. The Government Committee will have an executive session immediately following their hearing today in Room 1507; Government Committee today, Room 1507 after the hearing. Notice that the Business and Labor Committee will meet in Room 1524 on February 10, 2025, instead of Room 2102; Business and Labor, 1524, instead of Room 2102 on February 10.
