ARCH: Senator Hansen, you are recognized for announcement.

HANSEN: Thank you, Mr. Speaker. Colleagues, a final reminder that today at noon is the deadline to submit a bill request to the bill drafting staff in order to guarantee you receive something to drop before adjournment on the tenth legislative day. Requests received after noon will be drafted if time permits. However, priority will be given to the requests giv-- received before the noon deadline. The, the Revisor of Statutes expressed that they have received over 1,100 drafting requests, increasing rapidly in the past few days. So we ask your patience and understanding as the bill drafters work diligently to complete all drafts in time to be introduced next Wednesday. And Mr. Speaker, if I might also mention one other thing.

ARCH: Please. Senator Hansen for an announcement.

HANSEN: Colleagues-- if I can have your attention for just a second here. You know, there's a saying that's etched on the, the building of Palmer College of Chiropractic in Davenport, Iowa, spoken by B.J. Palmer, who's one of the founders of chiropractic. He once said, we never know how far-reaching something we think, say, or do today will affect the lives of millions tomorrow. I wanted to give some recognition to a young man who has, I thi-- in, in my opinion, has changed the hearts and minds of many people and has helped more people than a lot of us could ever hope for on the floor in this small little

room, and that was Jack Hoffman. Many of you might remember little Jack Hoffman running a 69-- 69-yard touchdown and inspiring many people throughout the country about the fight for pediatric brain cancer. Yesterday, tragically, he passed away at the age of 19. His father also passed away, I believe about four years ago, from brain cancer as well. So I think sometimes when we sit here on the floor and argue and fight and bicker about little things, sometimes we hope we can do something as important what Jack Hoffman did with just a small touchdown run. I want to read something that I thought was interesting that I read on ESPN. Jack Hoffman, the young Nebraska football fan who ran for a touchdown during the 2013 Cornhuskers' spring game and became a catalyst for pediatric brain cancer fundraising, died Wednesday after a 14-year battle with cancer. Hoffman was diagnosed with a cancerous glioma when he was five. Doctors told the family that most of his golf ball-sized tumor could not be removed. But his father, Andy Hoffman, did exhaustive research and found a do-- doctor in Boston who extracted more than 90% of the tumor. Jack's favorite player was Nebraska running back Rex Burkhead. And before the surgery, Andy reached out to Nebraska, hoping his son could meet him. Burkhead had lunch with Hoffman and ra-- and raced him on the field, and the family forged an enduring friendship with the former NFL running back. In late 2011, when the Cornhuskers trailed Ohio State by three touchdowns-- I remember this significantly because I was at that game. One of the greatest games I think I ever saw-- Burkhead fired up some of his teammates by mentioning the inspirational boy he just met. "Hey, Jack wouldn't give up," he told him, "so why should we?" Nebraska rallied, and Burkhead scored the game-winning touchdown. So I just want to give some recognition to somebody who did a lo-- who, who inspired a lot of people, who gave a lot of hope for people, and raised money to help recognize pediatric brain cancer with the-- I want to make sure I mention this right-- the Team Jack Foundation. So thank you, Mr. Speaker, for allowing me to speak on this. And let's all keep him and his family in our thoughts and our prayers. And sometimes remember that even though we think we're doing important stuff here, sometimes people out there are doing much more important things with what little they have. Thank you, Mr. Speaker.
