

Clerk reading.

SPEAKER: All provisions of law relative to procedure having been complied with, the question is shall the bill pass with the emergency clause attached? All those in favor vote aye. All those opposed vote no. Once again, have you all voted? The Clerk will record.

CLERK: Roll call vote read. 43 ayes, no nays, 6 not voting.

SPEAKER: The bill is passed with the emergency clause attached. Attention, please, the final bill on final reading this morning, L.B. 198. Clerk will read the bill.

CLERK: L.B. 198 read.
