SENATOR KEYES: I, Mr. President, there is an amendment to the bill, on line 2, after issue, for one motor vehicle carrying ten passengers or less and not for higher, I move for the acceptance of the amendment.

SPEAKER: Now is there further discussion for the Keyes amendment to LB 176, Senator Goodrich do you care to discuss the amendment? All those in favor of that amendment please say aye, those opposed say no, so ordered the amendment is adopted. Senator Keyes, back to you, what is your pleasure?

SENATOR KEYES: Now Mr. President, we have discussed this bill, to no end, one of the cheapest most economical bills that has went through the floor of this legislature and it has one, had one of the best discussions of any bill, and so I just move for the advancement of the bill.

SPEAKER: Is there any further discussion of the bill as amended? The question is shall LB 176 as amended be advanced from general file to E&R initial, all those in favor vote aye, all those opposed vote no. Well, once again the Chair would ask if you have all voted? Senator Keyes.

SENATOR KEYES: (didn't turn on his mike soon enough) 5 votes don't it?

SPEAKER: That is correct, have you all voted? Have you all voted?

SENATOR KEYES: Let's wait a minute I ask for a call of the house.

SPEAKER: Alright, you'd better ask, because you can't ask to hold open the vote.

SENATOR KEYES: I'm not asking for that, -

SPEAKER: Senator Keyes asking for a call of the house, the Clerk will clear the board. Now then, Senator Keyes asking for a call of the house, all those in favor of a call of the house, will vote aye, all those opposed vote no. Okay the Clerk will record. Simple majority is required there.

CLERK: 21 ayes, 1 nay.

SPEAKER: Very good, we are now under call of the house, at the next bell please indicate your presence. The Clerk will clear the board. Thank you, at the next bell please indicate your presence, we are under call of the house. The iss-, we are under call of the house, please indicate your presence, motion under vote is the advancement of Senator Keyes' LB 176, from general file to E&R initial. Senator Carstens voting aye, Senator Proud voting aye, have you all indicated your presence? Okay, the Clerk will clear the board. Senator Stull moved that the call be raised. All those in favor vote aye, all those opposed, the motion now is to raise the call, all those in favor of it vote aye, all those opposed vote no. Thank you, the Clerk will record.

CLERK: 30 ayes, no nays, to raise the call.

SPEAKER: The call is raised, read the tally on the original vote.

CLERK: 26 ayes, 3 nays, 20 not voting.

SPEAKER: Okay after that skirmish LB 176 is advanced from general file to E&R initial. That brings up the general file consideration of LB 14A, Senator Schmit's bill. The Clerk will clear the board. Thank you.
